NOTE A - DESCRIPTION OF THE PLAN

The following description of the Winpak Portion Packaging, Inc. 401(k) Thrift Savings Plan (the "Plan") is provided for general informational purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan became effective on May 1, 1983, and was revised on January 1, 1985, to permit employees of Winpak Control Group, non-union employees of Winpak Heat Seal Corporation, and employees of Winpak Lane, Inc. to make pretax contributions as provided by Section 401(k) of the Internal Revenue Code. Participants become eligible to participate in the Plan immediately upon hire for employee deferral contributions. Employees become eligible for employer matching funds after completing one year of service. The Plan was structured to comply with the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA").

New employees hired after January 1, 2005, that participate in the Plan, subject to the availability of net profits, would receive an employer matching contribution equal to 100% of the first 6% of salary deferral. Existing participants will continue to receive an employer matching contribution, subject to the availability of net profits, equal to 50% of the first 6% of salary deferral. New employees are immediately eligible upon employment and are automatically enrolled in the Plan at 3% of salary deferral. In addition, if no designated investment options have been selected, the participant's account is invested in Fidelity Investments Freedom Funds based on retirement age. New employees will have the ability to affirmatively elect not to participate in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, if any, and an allocation of the Company's matching contribution and Plan earnings and can be charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Contributions

The Plan provides for participants to contribute up to 1%-60% of pretax earnings, or a maximum of \$23,000 as defined by the Internal Revenue Service ("IRS") regulations. Participants who are or will attain age 50 by the end of the plan year may elect to contribute an additional \$7,500 of their eligible compensation as before tax catch-up contributions. Subject to the availability of net profits, the Company is required to match:

- 100% of the first 6% of the amount a participant contributes for participants who are employees of Winpak Lane, Inc.
- 100% of the first 6% of the amount a participant contributes for participants who are not employees of Winpak Lane, Inc. or Winpak Control Group, Inc. and whose employment commencement date was before January 1, 2005, and are not eligible to participate in the Winpak Portion Packaging Inc. Pension Plan.
- 100% of the first 6% of the amount a participant contributes for participants who are not employees of Winpak Lane, Inc. or Winpak Control Group, Inc. and whose employment commencement dates are after December 31, 2004.
- 50% of the first 6% of the amount a participant contributes for all other participants, including, effective January 1, 2020, participants who are employees of the Winpak Control Group, Inc.

Contributions are subject to certain limitations. Participants direct the investment of their contribution into various mutual fund investment options offered by the Plan.

Vesting

The Plan provides that the participants' contributions and actual earnings thereon are fully vested when made. Vesting in the Company contribution portion of their account is based upon years of continuous service. Participants become 20% vested after one year of service, with ratable increases until fully vested after five years of service based on hours of service as defined in the Plan document.

Forfeited Accounts

If a participant leaves the Company and is not fully vested in the Company's matching contribution, the nonvested portion is forfeited. The forfeited amounts are used to reduce administrative expenses or offset employer contributions. As of December 31, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$103,717 and \$25,307, respectively. Forfeited nonvested accounts were used to offset administrative expenses by \$23,686 for the year ended December 31, 2024.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of the amounts in their vested accounts. The loans are secured by the balance in the participant's account and bear interest rates that change from 4.25% to 9.50%, which commensurate with local prevailing rate as determined by the Plan Administrator. Principal and interest is paid ratably through biweekly payroll deductions. Notes receivable terms do not exceed 10 years.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or a direct rollover into another qualified plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that

affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for fair value disclosures.

Purchases and sales of securities are recorded on a trade-date basis, Interest income is recorded on the accrual basis, dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various mutual fund investment options, Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Administrative Expenses

Administrative expenses are paid by the Plan sponsor unless the Plan Administrator directs payment from the Plan. For the year ended December 31, 2024, administrative expenses were reduced by \$23,686 from forfeited nonvested accounts.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Topic Accounting Standards Codification ("ASC") 820, *Investments - Debt and Equity Securities*, defines fair value, establishes a framework for using fair value to measure assets and liabilities, and expands disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic ASC 820 are as follows:

- Level 1 - unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted market prices in active markets for similar assets or liabilities, quoted prices for identical or

similar assets or liabilities in non-active markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - inputs that are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: An investment formed from the pooling of investments by institutional investors. The Plan's interest in the Fidelity Managed Income Portfolio ("MIP") collective trust is valued by the trustee based on the Net Asset Value ("NAV") of shares held by the Plan at year-end as practical expedient fair value. The fund allows for daily liquidity with no additional days' notice required for redemption for participant-directed transactions at the constant NAV of \$1 per unit. Were the Plan to initiate a full redemption of the Fidelity MIP, the investment advisor reserves the right to temporarily delay withdrawal from the trust for up to 12 months in order to ensure that securities liquidations will be carried out in an orderly manner. There were no unfunded commitments of the collective trust as of December 31, 2024 and 2023.

Certain Plan investments are shares of mutual funds and a collective trust fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee, as defined by the Plan and; therefore, these transactions qualify as party-in-interest which are exempt from the prohibited transaction rules. Notes receivable from participants are also considered party-in-interest transactions.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a partial or complete termination of the Plan, participants become fully vested and acquire a nonforfeitable interest in all contributions to their accounts. Such amounts would then be distributed to participants as a lump sum distribution as provided by the Plan.

NOTE H - INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan document that received an opinion letter from the IRS, dated June 30, 2020 stating that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended and restated since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - SUBSEQUENT EVENTS

For the year ended December 31, 2024, the Plan evaluated subsequent events for potential recognition and disclosure through September 12, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
