Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Promontory Healthcare Companies, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 - Description of Plan

The following brief description of Promontory Healthcare Companies, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering qualified employees of Promontory Healthcare Companies, LLC (the Company and Plan Sponsor). The Plan Sponsor is a member of an affiliated service group which includes Promontory Healthcare Management, LLC; SNF Lincoln Operating Company; SNF Omaha Operating Company; SNF Ammon Operating Company; Curis Partners, LLC; Elite Professional Home Care, LLC; Elite Services, LLC; Promontory Home Health, LLC; Nebraska Home Health OPCO, LLC dba Home Nursing with Heart P.C.; BH-SD DD Opco, LLC; BH-IC Opco LLC, BH-SD Social Rehab LM LLC, BH-RC Opco, LLC; BH-VC OPCO SP, LLC; and BH-Social Rehab Holding LLC. The Plan Sponsor is a member of a controlled group which includes Promontory Healthcare Management, LLC; Advanced Home Health, LLC; Promontory Home Health-SD, LLC; Curis Partners, LLC, and Promontory Therapy Services, LLC, Community Therapy Services LLC, Community Psych Nursing Partners Inc, Community Healthcare Partner-NE LLC, IF HOSPICE OPCO LLC, BH SD-TC, LLC, BH-SD Visalia, LLC, West Coast Men's, BH-WC, LLC, Cameron Care, LLC, BH-OR, LLC, BH-MLK OC, LLC, BH-OR 109th, LLC, and BH Holdings. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan management is responsible for oversight of the Plan.

Eligibility

Employees are eligible to participate in the Plan if they have completed one year of service and are 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has completed 1,000 or more hours of service. To participate in profit sharing, employees must meet the above requirements as well as work at least 500 hours during the Plan year or be employed by the Company at December 31.

Entry Date

Employees may enter the Plan immediately coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Each year, participants may contribute up to 92.50% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company may make discretionary employer matching contributions.

For the year ended December 31, 2024, the Company elected to match various amounts for the various members in the Plan as follows. For all other members of the Plan not listed below, the Company did not elect to make discretionary matching contributions.

Advanced Home Health, LLC: discretionary match up to 2% for 2024.

Curis Partners, LLC: discretionary match up to 3% for 2024.

Promontory Healthcare Management, LLC: discretionary match up to 3% for 2024.

Home Nursing with Heart P.C.: discretionary match up to 3% for 2024.

Community Therapy Services LLC: discretionary match up to 1% for 1st and 3rd quarter of 2024.

Additional profit-sharing amounts may be contributed at the discretion of the Company's board of directors. No such additional discretionary profit-sharing contributions were made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company matching contributions, as well as allocations of the Company discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are also vested immediately in the Company's contribution portion of their accounts.

Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested accounts, as all accounts are automatically 100% vested.

Payment of Benefits

Participants may elect to receive a lump-sum amount equal to the value of their vested interest upon retirement, termination of service, death or disability. A terminated participant with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or upon hardship as described in the Plan document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions are recorded in the year in which employee contributions are withheld from compensation.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Reclassifications

Certain amounts from the prior year financial statements have been reclassified for comparative purposes to conform to the presentation in the current year financial statements.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts – Valued at fair value based on the net asset value (NAV) of units as determined by the insurance company. The NAV is based on the observable market prices of the underlying assets within the account less liabilities. The NAV for the underlying assets of the account is a readily determinable measure of their fair value and is the basis for current transactions.

Note 4 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

Note 5 - Tax Status

The Plan uses a pre-approved plan document sponsored by IEC Group Inc, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments consist of pooled separate accounts managed by John Hancock Life Insurance Company, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Delinquent Participant Contributions

It was noted in 2024 and 2023, that there were delays by the Company in submitting employee contributions to the trustee in the aggregate amount of \$19,408 and \$12,891, respectively. In 2024, the Company partly reimbursed the Plan for lost earnings from the 2024 and 2023 late contributions and the Company is in the process of filing Form 5330 and correcting lost earnings for the remaining uncorrected late contributions.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Plan Amendments

On March 19, 2024, the Plan was retroactively amended effective January 1, 2019 to allow immediate participation in the Plan upon satisfying the Plan's eligibility requirements. The amendment is applicable to plan year ended December 31, 2024.

Note 10 - Subsequent Event

Effective January 1, 2025, the Plan was amended to allow eligible part time employees to make elective deferral contributions to the Company's 401(k) Plan.

Effective February 25, 2025, the Plan was amended to change the determination period for employer matching contributions from annually to each pay period.

The Plan Sponsor has evaluated subsequent events through September 10, 2025, the date which the financial statements were available to be issued.
