Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the WGI, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

WGI, Inc. established the WGI, Inc. 401(k) Plan (the “Plan”) on January 1, 2002. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the sponsoring organization WGI, Inc. and related employers, Streamline Technologies, Inc, and The Atlantic Group, LLC (collectively the “Employer”), except for union employees, non-resident aliens, a co-op students and interns, and employees acquired in certain business transactions, as defined in plan document. All employees who have attained the age of 21 and have completed at least three months of service are eligible to make employee deferral contributions and receive employer matching contributions. In order to receive an employer non-elective profit-sharing contribution, employees must have completed at least one year of service defined as 1,000 hours in the eligibility computation period. John Hancock Life Insurance Company (U.S.A.) (“John Hancock” or the “Insurance Company”) holds the Plan’s investments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant-directed.

Plan Administration

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged directly for administrative expenses, if not paid by the Employer. Certain expenses incurred in the administration of the Plan are paid by the Employer and are excluded from these financial statements. Individual participant accounts are charged directly for loan recordkeeping, if applicable.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 19, 2025.

Participant Deferral Contributions

Each year, Participants may defer 100% of their eligible compensation, not to exceed a dollar limit established under the Internal Revenue Code (the “Code”). Participants may make pre-tax or Roth contributions to their accounts. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”).

Employer Contributions

The Employer may make discretionary matching contributions to the Plan. During the year ended December 31, 2024, the Employer made discretionary matching contributions equal to 50% of participants’ deferrals up to 6% of eligible compensation.

Notes to Financial Statements

1. Description of Plan *(continued)*

Employer Contributions (continued)

The Employer may also make a discretionary non-elective profit-sharing contribution each Plan year. The Employer non-elective profit-sharing contribution is on a class allocation based on each Participant in an individual group. During the year ended December 31, 2024, the Employer elected to not make a non-elective profit-sharing contribution to the Plan.

Participant Accounts

Each Participant's account is credited with the Participant's contributions, their respective employer contributions and an allocation of the Plan's investment earnings or losses and is charged with an allocation of certain administrative expenses. Allocations are based on Participant compensation or account balance, as defined in the Plan document. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting for Employer matching contributions and Employer discretionary contributions are on a six year tiered schedule. Upon termination due to death, disability, or attainment of retirement age, a Participant is fully vested in all of their accounts.

Forfeitures

A Participant who leaves the employment of the Employer forfeits any non-vested balance. Forfeited balances of terminated Participants' accounts are used to pay administrative expenses and to reduce Employer contributions. During the year ended December 31, 2024, the Plan used \$22,833 and \$108,958 of forfeitures to reduce administrative expenses and reduce Employer contributions, respectively. December 31, 2024 and 2023, there are unallocated forfeiture amounts of \$122,616 and \$132,849, respectively.

Notes Receivable from Participants

Subject to approval by the plan administrator, Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount a Participant may borrow is \$1,000. A Participant may have up to two loans outstanding at a time. Loan terms range from one to five years (or longer for the purchase of a primary residence). Loans are secured by the vested balance in the Participant's account and bear a reasonable interest rate, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions or by check if the employee has terminated employment. If a Participant ceases to make loan repayments, the plan administrator can deem the loan to be in default. When a distributable event occurs, the Participant's loan balance is reduced and a benefit payment is made in accordance with the Plan document. The interest rates on all outstanding loans at December 31, 2024 and 2023 ranged from 3.25% to 8.50%, and mature at various dates through March 2031.

1. Description of Plan (continued)

Payment of Benefits

Upon termination of service due to death, disability, termination, or retirement, a Participant or beneficiary may elect to receive either a lump-sum or partial distribution of amounts less than or equal to the value of the Participant's vested interest in his or her account. The payment can either be a cash distribution to the Participant, subject to income tax withholdings, or a tax-free rollover to an individual retirement account or another qualified plan. If a terminated participant's vested account balance is less than \$1,000, the plan administrator may cash out the funds to the Participant. If a terminated Participant's vested account balance is greater than \$1,000 but less than \$7,000, the plan administrator may distribute the account balance to the Participant as an individual retirement account.

In-service withdrawals from all Participant's vested accounts are permitted only upon reaching age 59½. Hardship withdrawals are not allowed under the provisions of the Plan document.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investments, Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (*continued*)

Fair Value Measurement

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate investment accounts: As of December 31, 2024 and 2023, pooled separate investment accounts amounted to \$56,848,966 and \$49,880,578, respectively, there were no unfunded commitments, no redemption notice period, and the redemption frequency is daily. The pooled separate investment accounts invest in various investment options and are valued based on the observable net asset value ("NAV") per share of the underlying investments held. The NAV, as provided by John Hancock, is used as a practical expedient to determine fair value for these accounts. While the majority of the underlying assets' values are quoted market prices, the NAV of the pooled separate investment accounts are not publicly quoted. Each plan's share is determined on a participation-unit or variable-unit basis and represents a portion of the holdings of the fund. Pursuant to U.S. GAAP guidance, investments where fair value is measured using the NAV per share as a practical expedient is not categorized within the fair value hierarchy.

Interest bearing cash: As of December 31, 2024 and 2023, the interest bearing cash amounted to \$122,616 and \$132,849, respectively. Interest bearing cash held by the Plan are deemed to be actively traded and are classified as Level 1 instruments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial assets and liabilities could result in a different fair value measurement at the reporting date.

Unit Values

Individual Participant accounts for the pooled separate investment accounts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participant's accounts are charged or credited with the number of units properly attributable to each Participant.

2. Summary of Significant Accounting Policies *(continued)*

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative fees and expensed when incurred.

Payment of Benefits

Benefit payments to Participants are recorded during the period in which they are paid.

Reclassifications

Certain amounts in the 2023 financial statements have been reclassified for comparative purposes in order to conform to the 2024 financial statements. These reclassifications had no impact on previously reported net assets available for benefits.

3. Information Certified (Unaudited)

Certain information related to investments, notes receivable from participants and interest bearing cash disclosed in the accompanying financial statements and ERISA-required supplemental schedule including investments, notes receivable from participants and interest bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, the Insurance Company and a qualified institution.

4. Risk and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.

5. Party-In-Interest Transactions

Plan investments include shares of pooled separate accounts managed by John Hancock, these transactions qualify as exempt party-in-interest transactions. Administrative fees of \$102,787 were paid to John Hancock during 2024. Additional fees of \$175,521 were paid to the investment advisor and third-party administrator. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

7. Tax Status

The underlying volume submitter profit sharing plan has received its latest opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the plan is qualified under section 401(a) of the IRC, and that the plan, as then designed, was in compliance with the applicable requirements of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified as of the date of this report.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
