Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Van Diest Supply Co. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

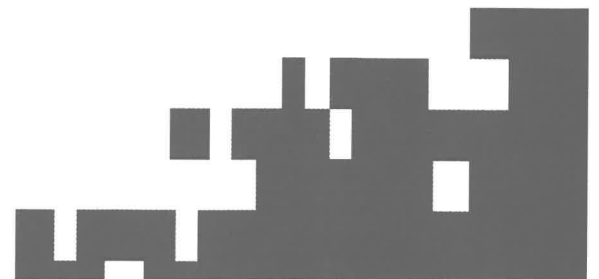

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of Van Diest Supply Co. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering all employees of Van Diest Supply Co. (the Company). The Plan covers employees who have completed 12 months of service with employees eligible to enter the Plan on January 1, April 1, July 1 or October 1 after eligibility requirements have been met. Effective June 1, 2021, the Plan was amended to cover employees who have completed three months of service. Participants may change their deferral rate on a monthly basis. Van Diest Supply Co. determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees. The Plan is subject to the current provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions.

Eligible employees are requested to complete an enrollment form which determines their savings rate and investment elections. Failure to complete this enrollment form results in the eligible employee being automatically enrolled with a 6% employee contribution effective the first plan entry date after meeting eligibility requirements. Employees who are not enrolled or who have elected to defer 0% will be reenrolled each April 1 unless a specific election is made.

Contributions and investment options: Employees who are eligible to participate in the Plan can make elective deferral contributions from 1% to 100% of compensation up to the maximum allowed under the IRC. Effective January 1, 2024, the Plan was amended to allow for Roth after-tax deferral contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company will match up to 50% of the first 6% of employee contributions on the last day of each plan year quarter for any active participant employed on that date and for any participant who was an active member at any time during the plan year quarter who retired, became totally disabled or died. Participants direct the investment of both their contributions and Company contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contribution and an allocation of: (a) the Company's matching contribution and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions plus earnings thereon is based on continuous years of service. These contributions become 20% vested after two years of credited service, as defined, and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service.

Forfeited accounts: At December 31, 2024 and 2023, forfeitures for nonvested account balances totaled \$1,276 and \$1,007, respectively. These forfeitures may be used first to pay administrative expenses and then may be used to reduce future Company contributions. During the year ended December 31, 2024, there was approximately \$60,525 in aggregate forfeitures of nonvested account balances that were used to pay administrative expenses and reduce employer contributions.

Note 1. Plan Description (Continued)

Payment of benefits: Participants or their beneficiaries are eligible for benefits upon retirement, termination, death or hardship. A participant may, if the value of the participant's vested balance is \$5,000 or less, roll over the amount into another qualified plan or receive a lump-sum payment. If the vested balance is \$5,000 or more, the participant may elect to roll over the amount into another qualified plan, receive a lump-sum payment, or an annuity.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.

Note 3. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are therefore excluded from these financial statements. Administrative expenses include fees related to administration of certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

Note 5. Fair Value Measurements

The Fair Value Measurements and Disclosures Topic of the FASB Accounting Standards Codification (ASC), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the topic are described below:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Guaranteed interest accounts: These accounts represent investment contracts with Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. Fair value is the amount Plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity (some investments allow withdrawals without penalty for death, disability, termination or retirement). The fair value is determined by comparing current market interest rates to the interest rate on the account and adjusting for the number of years until the maturity date. The fair value of guaranteed five-year interest accounts is classified within Level 3 of the valuation hierarchy.

Pooled separate accounts: Pooled separate accounts (other than the Principal U.S. Property Separate Account) invest primarily in domestic and international stocks, commercial paper and single mutual funds. The U.S. Property Separate Account invests primarily in commercial real estate and includes mortgage loans which are backed by the associated properties. The net asset value is used as a practical expedient to determine fair value for these accounts. Each pooled separate account provides for redemptions by the Plan at the reported net asset values per share, with little to no advance notice requirement.

Common collective trusts: Common collective trusts invest in a collective trust fund as well as a variety of separate accounts and mutual funds. The net asset value is used as a practical expedient to determine fair value for these accounts. Each collective investment trust account provides for redemptions by the Plan at reported net asset values per share, with little to no advance notice requirement. Investment measured at net asset value per share used as a practical expedient are not required to be classified in the fair value hierarchy.

Mutual funds: Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their accounts.

Note 7. Tax Status

The Plan has adopted a nonstandardized form of a preapproved plan sponsored by Principal Financial Group. The plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document. However, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Related-Party Transactions

Certain investments are shares of pooled separate accounts and guaranteed interest accounts managed by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodians as defined by the Plan. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the Trustee totaled \$119,762 for the year ended December 31, 2024. The Plan Sponsor also paid certain administrative expenses of the Plan.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
