## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Convatec, Inc. Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter**

As discussed in Note 1 to the financial statements, Convatec, Inc. approved a resolution to merge A Better Choice Medical Supply 401(k) Profit Sharing Plan into the Plan effective July 1, 2024. All assets of A Better Choice Medical Supply 401(k) Profit Sharing Plan were transferred to the Plan on July 1, 2024. Our opinion has not been modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. #### Note 1. Plan Description

The following description of Convatec, Inc. Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** Effective August 8, 2008, Convatec, Inc. (the Company) established the Plan, a defined contribution plan, that is designed to comply with and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees of the Company are eligible to participate in the Plan on the date he or she has completed 30 days of service. Certain classes of employees are excluded as described in the Plan document. The Board of Directors of the Company controls and manages the operation and administration of the Plan. The Company's Savings and Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Fidelity Management Trust Company (FMTTC) serves as the trustee of the Plan. The Company serves as the Plan sponsor.

**Plan merger:** Effective July 1, 2024, the Company approved the adoption of the Plan by A Better Choice Medical Supply as a participating employer with respect to its eligible employees. The Company approved a resolution to transfer in the accounts related to participating employer A Better Choice Medical Supply from A Better Choice Medical Supply 401(k) Profit Sharing Plan into the Plan effective July 1, 2024, the date which the Plan assumed legal control of the assets. The transfer in assets of \$1,428,938 is reflected in the Plan's financial statements.

**Contributions:** Participants may contribute up to 75% of their compensation, as defined in the Plan document, for the contribution period as either pretax contributions or Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 in 2024. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may automatically increase its contributions annually until the contributions reach a maximum of 10%. Participants may also make rollover contributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a common collective trust, a money market fund, various mutual funds and self-directed brokerage accounts as investment options for participants.

The Company's nondiscretionary safe harbor matching contribution is a tiered match equal to 100% of the first 4% of compensation plus 50% of the next 2% of compensation that a participant contributes to the Plan. The Company may also make discretionary nonelective contributions. No such additional discretionary contributions were made for the year ended December 31, 2024. Company contributions are invested directly in the investment options, as directed by the participant.

**Participant accounts:** Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Expenses attributable to the acquisition of investments shall be charged to the participant's account for which such investment is made. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their rollover, voluntary pretax, Roth and Company matching contributions plus actual earnings thereon.

Vesting in the Company's contribution portion of participant accounts of participants who were hired after January 1, 2012, and terminated prior to January 1, 2013, is a cliff vesting schedule where the participant is 100% vested after two years of credited service. Vesting in the Company's contribution portion for contributions made between January 1, 2012 and December 31, 2012, and discretionary nonelective contributions of accounts of participants, except for those who were active as of January 1, 2013 or 2014, as described in the paragraph above, is based on the following schedule:

Participants whose account balances were transferred from the Bristol-Myers Squibb Program were immediately vested on the amounts transferred in plus actual earnings thereon. Each participant will be fully vested in his or her matching contributions when he or she attains normal retirement age or in the event of death or disability.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,071 and \$12,348, respectively. These accounts will be used to reduce future employer contributions or offset administrative expenses. During 2024, amounts from forfeited nonvested accounts used to offset employer contributions and administrative expenses were \$29,956.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** Participants can elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account on termination of employment, retirement, the attainment of age 59½, death, or permanent and total disability. Distributions are subject to the applicable provisions of the Plan document. If the vested balance of a participant's account does not exceed \$1,000, the participant will automatically receive a lump-sum distribution. The Plan permits direct rollovers to any eligible individual retirement account or annuity or to a qualified defined contribution plan. A participant may also request an in-service distribution as provided for in the Plan document.

**Notes receivable from participants:** Participants may borrow from their individual account balance up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account. The loan terms are between two and 15 years with a fixed interest rate for new loans equal to one percentage point above the prime rate when the loans are granted. All notes require that repayment be amortized in level payments, not less than quarterly, over a period not extending beyond five years from the date of the loan unless such loan is for the purchase of a participant's primary residence in which case the loan repayment period may not extend beyond 15 years from the date of the loan. Principal and interest are paid ratably through biweekly payroll deductions.

**Revenue credit account:** The Plan has a revenue credit account with the trustee to cover plan expenses. The revenue credit account is treated as a Plan asset and must be used only for legitimate Plan expenses. Unused amounts may be allocated to participant accounts. During the year ended December 31, 2024, the trustee contributed \$0 into the revenue credit account. The balance in the account totaled \$30,758 and \$82,767 on December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Company used \$55,903 from the account to pay Plan expenses and received \$3,894 in dividends.

**Subsequent events:** The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

#### Note 2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of estimates:** The preparation of financial statements in accordance with U.S. GAAP requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair values of the investments are determined by the quoted market share values reported by FMTC, which represent the net asset value (NAV) of shares held by the Plan at year-end. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Company's matching contributions are recorded in the year in which the related employee contributions are made.

**Payment of benefits:** Benefits are recorded when paid. There are no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not been paid as of December 31, 2024.

**Expenses:** Administrative expenses are paid by the Plan, as provided in the Plan document. Certain administrative expenses are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### Note 3. Information Certified or Provided by Fidelity Management Trust Company

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by, or derived from, information provided by FMTC, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets at December 31, 2024 and 2023:

#### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on December 31, 2024 and 2023.

**Self-directed brokerage accounts:** Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. Accounts also include certificates of deposit that are valued at cost that approximate fair value.

**Mutual funds and money market funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective trust fund:** Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

#### **Note 5. Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments were invested in funds managed by affiliates of FMTC. FMTC is the Plan's trustee and, as such, transactions with the trustee qualify as exempt party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits as they are paid through revenue sharing, rather than a direct payment. During the year ended December 31, 2024, the Plan made direct payments to third-party service providers of \$405,850 for administrative expenses which were not covered by revenue-sharing arrangements.

Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. Notes receivable from participants also qualify as exempt party-in-interest transactions.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts become 100% vested in the employer portion of their accounts.

#### **Note 7. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits.
