Except as discussed in the following paragraph, in the planning and performing of our audit of the financial statements of FIAMM Technologies LLC 401 (k) Plan (“Plan”) as of and for the year ended December, 2024 in accordance with auditing standards generally accepted in the United States of America, we considered the Plan’s internal control over financial reporting (“internal control”) as a basis for designing our auditing procedures for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan’s internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Our audit did not extend to the certified investment information summarized in Note 3 to those financial statements and did not include a consideration of internal control relating to that information. The purpose of an ERISA Section 103(a)(3)(C) audit is to express an opinion on whether the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America and that the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses and therefore, there can be no assurance that all deficiencies, significant deficiencies, or material weaknesses have been identified. However, as discussed below, we identified certain matters that we wish to communicate to you. Matters communicated in this letter are classified as follows:

- Deficiency – A control deficiency exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect and correct misstatements on a timely basis.
- Reportable Finding – An identified instance of noncompliance or suspected noncompliance with laws or regulations in accordance with AU-C section 250, *Consideration of Laws and Regulations in an Audit of Financial Statements*; a finding arising from the audit that is, in the auditor’s professional judgment, significant and relevant to those charged with governance regarding their responsibility to oversee the financial reporting process in accordance with AU-C section 260, *The Auditor’s Communication With Those Charged With Governance*; or an indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditor’s professional judgment, are of sufficient importance to merit management’s attention in accordance with AU-C section 265, *Communicating Internal Control Related Matters Identified in an Audit*.

Potentially Delinquent Contributions	Reportable Finding
Observation:	When reviewing the contribution reconciliation, Crowe noted five payroll periods with a lag time between the payroll date and the trust deposit date that exceeded the Company's average lag time of 1-3 days, which could be considered delinquent by the DOL
Potential Effect:	The engagement team noted that the DOL could consider multiple contributions to the plan delinquent, based on the lag time between the payroll period and deposit date.
Recommendation:	We recommend that the Company review the contributions with Fidelity to determine if any corrective contributions ought to be made.

Delay in Enrollment of Eligible Participant	Reportable Finding
Observation:	During participant data testing, we noted that one of the participant's 401(k) enrollment was delayed by 22 days beyond the required auto-enrollment date. Testing compared plan eligibility rules, payroll records, and enrollment dates to verify compliance with plan provisions.
Potential Effect:	The deficiency could result in delayed contributions for certain participants, leading to missed earnings on contributions. While the dollar impact in the current plan year is immaterial, a lack of timely monitoring controls increases the risk of future untimely enrollments and potential regulatory non-compliance.
Recommendation:	<p>We recommend management strengthen monitoring controls around participant eligibility and auto-enrollment processing. Specifically:</p> <ol style="list-style-type: none"> <li>1) Establish a periodic reconciliation between Fidelity eligibility files and payroll setup to identify late enrollments in real time.</li> <li>2) Ensure HR/payroll maintains supporting documentation for eligibility determinations for longer than 30 days to allow for independent review.</li> <li>3) Consider implementing an exception report to flag any participants not enrolled within the required timeframe.</li> </ol>

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the FIAMM Technologies, L.L.C 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of FIAMM Technologies, L.L.C. (the “Company”), who have reached the age of 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan implemented the required provisions of the SECURE Act 2.0 related to removing the requirement for RMDs from Roth accounts and allows surviving spouse to use the deceased participants age to determine RMD requirements. These provisions remain in effect.

Participant Contributions: Participants may contribute up to 50 percent of their annual wages including bonuses and overtime (subject to the annual dollar limits set by the Internal Revenue Service). Each participant can select the type of investments held in their own voluntary contribution account (directed investment account). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

Employer Contributions: The Company may contribute a discretionary amount which shall be divided among participants according to compensation level. For the years ended December 31, 2024 and 2023, there were no discretionary employer contributions. The Company makes nondiscretionary contributions of 100% of the first 3% of participant contributions and 50% of the next 2% of participant contributions.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocation of the Company's contribution, plan earnings and forfeitures of terminated participant's non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Retirement, Death, Disability: A participant (beneficiary) is entitled to 100% of his or her vested account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Participants before January 1, 2000 are 100% vested and participants after January 1, 2000 are 100% vested after three years of credited service.

Forfeitures: At December 31, 2023, the balance in the forfeited non-vested accounts totaled \$15,803. There were no forfeitures at December 31, 2024. These accounts may be applied first to payment of plan administration expenses and then to reduce future employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Notes Receivable from Participants: Upon request of the participant, the trustee may make loans to the participants subject to limitations as defined by the Plan. All loans are secured by the balance in the participant's account and bear interest at a rate of 4.25% to 9.50% which commensurate with local prevailing rates. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits: Upon termination of service, a participant may elect to receive either a rollover to another account, a lump-sum amount equal to the value of his or her account, or annual installments over a period of years. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Recordkeeping fees and fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements and schedules of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: The Plan provides for various investment options including mutual funds and collective trust funds. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balance.

Subsequent Events: Management has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

**NOTE 3 – CERTIFIED INFORMATION – INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends and interest income or notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the custodian of the Plan.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 4 – FAIR VALUE MEASUREMENTS** (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trusts:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. The fund invests in investment contracts issued by life insurance companies, banks and other financial institutions with the objective of preserving principal investment while earning a level of interest income that is consistent with the principal preservation.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype non-standardized profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by employees or officers of the Company. Certain professional fees for the administration and audit of the Plan were paid by the Company. Investment management and custodial fees paid by the Plan to Fidelity Management Trust Company and affiliates of Fidelity qualify as party-in-interest transactions.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the FIAMM Technologies, L.L.C 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of FIAMM Technologies, L.L.C. (the “Company”), who have reached the age of 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan implemented the required provisions of the SECURE Act 2.0 related to removing the requirement for RMDs from Roth accounts and allows surviving spouse to use the deceased participants age to determine RMD requirements. These provisions remain in effect.

Participant Contributions: Participants may contribute up to 50 percent of their annual wages including bonuses and overtime (subject to the annual dollar limits set by the Internal Revenue Service). Each participant can select the type of investments held in their own voluntary contribution account (directed investment account). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

Employer Contributions: The Company may contribute a discretionary amount which shall be divided among participants according to compensation level. For the years ended December 31, 2024 and 2023, there were no discretionary employer contributions. The Company makes nondiscretionary contributions of 100% of the first 3% of participant contributions and 50% of the next 2% of participant contributions.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocation of the Company's contribution, plan earnings and forfeitures of terminated participant's non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Retirement, Death, Disability: A participant (beneficiary) is entitled to 100% of his or her vested account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Participants before January 1, 2000 are 100% vested and participants after January 1, 2000 are 100% vested after three years of credited service.

Forfeitures: At December 31, 2023, the balance in the forfeited non-vested accounts totaled \$15,803. There were no forfeitures at December 31, 2024. These accounts may be applied first to payment of plan administration expenses and then to reduce future employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Notes Receivable from Participants: Upon request of the participant, the trustee may make loans to the participants subject to limitations as defined by the Plan. All loans are secured by the balance in the participant's account and bear interest at a rate of 4.25% to 9.50% which commensurate with local prevailing rates. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits: Upon termination of service, a participant may elect to receive either a rollover to another account, a lump-sum amount equal to the value of his or her account, or annual installments over a period of years. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Recordkeeping fees and fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements and schedules of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: The Plan provides for various investment options including mutual funds and collective trust funds. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balance.

Subsequent Events: Management has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

**NOTE 3 – CERTIFIED INFORMATION – INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends and interest income or notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the custodian of the Plan.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 4 – FAIR VALUE MEASUREMENTS** (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trusts:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. The fund invests in investment contracts issued by life insurance companies, banks and other financial institutions with the objective of preserving principal investment while earning a level of interest income that is consistent with the principal preservation.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype non-standardized profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by employees or officers of the Company. Certain professional fees for the administration and audit of the Plan were paid by the Company. Investment management and custodial fees paid by the Plan to Fidelity Management Trust Company and affiliates of Fidelity qualify as party-in-interest transactions.
