Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the December 31, 2024 Financial Statements

We have performed an audit of the financial statements of Gorham Savings Bank 401(k) Incentive Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the period of April 1, 2024 through December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the December 31, 2024 Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of Gorham Savings Bank 401(k) Incentive Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Gorham Savings Bank (the Company) who meet certain age and service requirements. Under the provisions of the Plan, investment activity is directed by individual participants, except for Safe-Harbor Qualified Contributions contributed to the Plan prior to January 1, 2021, which are directed by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 4, 2023, the Board of Directors of the Company entered into a definitive agreement with Maine Community Bancorp, MHC to merge under the Maine Community Bancorp name in a merger of equals. The transaction closed and the merger is effective as of January 1, 2025. As a result of the merger, the Plan had several amendments made on November 20, 2024:

- Participation in the Plan is frozen effective December 31, 2024. No additional Company employees are allowed to enter the Plan and such employees will become participants of Maine Community Bancorp, MHC's 401(k) plan.
- Effective October 1, 2024, the minimum service requirement to enter the Plan is 30 days of employment and employees may enter the Plan on the first of the month following completion of the minimum age and service requirements.
- Effective October 1, 2024, the Plan's year-end was changed to December 31.

Eligibility

Employees become eligible for participation in the Plan after the attainment of age 18 and, prior to the amendment on October 1, 2024, completion of three consecutive full calendar months of employment without interruption for that entire calendar month and in which the employee is also credited with at least 83.33 hours of service per month or completion of one year of service, if earlier. Eligible employees are automatically enrolled in the Plan at 3% if they do not voluntarily enroll or opt out.

The Plan has a Roth 401(k) feature which allows participants to contribute a portion of their annual after-tax compensation to the Plan. Annual limitations on employee contributions apply to pre-tax and after-tax contributions in the aggregate.

Contributions

The Plan allows participants to make voluntary pre-tax contributions up to the annual Internal Revenue Service (IRS) limit. The Company also makes an annual Safe-Harbor Qualified Contribution of 3% of the participant's Plan year compensation to eligible employees' accounts. Contributions are limited to the maximum amount allowable under the Internal Revenue Code (IRC).

The Plan also allows for discretionary matching and employer contributions. The Company matched 25% of each 1% deferred, up to a maximum of 6% of deferred eligible compensation for the period of April 1, 2024 through December 31, 2024. The maximum amount of discretionary matching contributions for the period was 1.5% of eligible compensation. The discretionary matching contributions vest 100% after two years of service. The discretionary employer contributions were 2% of eligible compensation. The discretionary employer contributions vest 100% after one year of service.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurement.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of realized gains or losses and net unrealized appreciation or depreciation on investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is accrued daily on the outstanding balances. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits paid to participants are recorded upon distribution from the Plan.

Subsequent Events

Management has considered transactions or events occurring through September 22, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Nonparticipant-Directed Investments

Prior to January 1, 2021, Safe-Harbor Qualified Contributions contributed to the Plan were directed by the Company. Effective January 1, 2021, due to the "hard freeze" of The Retirement Plan of Gorham Savings Bank, a related plan sponsored by the Company, Safe-Harbor Qualified Contributions are directed by participants. Safe-Harbor Qualified Contributions contributed to the Plan prior to January 1, 2021 remain directed by the Company, with the exception of Safe-Harbor Qualified Contributions contributed to participants hired on or after October 1, 2015. Information about the net assets available for benefits and the significant components of the changes in net assets available for benefits relating to nonparticipant-directed investments is as follows:

4. Tax Status

The IRS issued a favorable opinion letter on June 30, 2020, and stated that the non-standardized pre-approved profit sharing plan adopted by the Company was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with applicable requirements of the IRC.

5. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts.

6. Information Certified by the Trustee

The investments, investment transactions, net appreciation in fair value of investments, and dividend income were obtained by management and agreed to or derived from the information certified by Charles Schwab Trust Bank, the trustee, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits;
- Notes 3 and 9 to the Financial Statements; and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year)

7. Party-in-Interest Transactions

Some Plan investments are shares of mutual funds which are administered by parties related to Charles Schwab Trust Bank. Therefore, these transactions qualify as party-in-interest transactions.

Fees paid to EPIC Retirement Plan Services for recordkeeper services amounted to \$4,145 for the period of April 1, 2024 through December 31, 2024.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and March 31, 2024.

Mutual funds: Valued at quoted market prices of the underlying investments. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued daily based on the established net asset value (NAV) per unit of \$10.00. The fund attempts to maintain a stable price per unit of \$10.00; however, there can be no assurance that the value of the units in the fund will not fluctuate. The principal value per unit of the fund is determined at the end of each day by dividing net assets by the number of units outstanding.
