NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Didlake, Inc. HRA Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General

The Plan and related trust were established to provide health and other benefits to eligible participants. The Plan provides benefits consisting of a Health Reimbursement Arrangement (HRA). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The plan provides health reimbursement arrangement benefits for eligible participants and their dependents. The third-party administrator pays insurance premiums to various insurance companies who are responsible for paying benefits under these agreements. There is a 30-day waiting period after employment for coverage of benefits.

Health Reimbursement Arrangement Reserve (HRA)

The HRA component of the plan will reimburse covered persons for qualified health expenses incurred after the effective date of this HRA component, provided the covered employee was enrolled at the time the expense was incurred. Qualified health expenses are amounts paid for the diagnosis, cure, mitigation, treatment or prevention of disease, or for the purpose of affecting any structure or function of the body.

Eligibility

All employees who work 30 hours or more and provide services on a project or contract that is subject to prevailing wage laws, and if the project and the job performed are covered under the Plan, then for purposes of receiving any prevailing wage contribution made to the Plan employees are eligible. The date of eligibility begins on the date they first perform services on the project or their date of hire on the covered prevailing wage project. They will become a participant in the Plan on that date. Former employees are eligible to use up their remaining Plan funds until their account has been depleted.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Contributions

The Plan is funded primarily by contributions from the Plan Sponsor. Benefit or insurance premium payments are made from these contributions. Contributions are allocated to Plan benefits and expenses in accordance with an administrative services agreement between the Plan Sponsor and the third-party administrator. The Plan Sponsor is ultimately responsible for the allocation and administration of funds. However, the third-party administrator pays insurance premiums to various insurance companies.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared using the modified cash basis of accounting, which differs from generally accepted accounting principles. Under the basis, certain revenues are recognized when received rather than when earned and certain expenses are recognized when paid rather than when incurred.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all financial instruments purchased with an original maturity of three months or less to be cash equivalents.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claim processors that have yet to be reimbursed by the Plan (if any) are recorded as payable to claims administrator in the accompanying statements of net assets available for benefits.

Health Reimbursement Arrangement

Included in the accompanying statements of net assets are amounts available to reimburse participants for qualifying medical expenses as of November 30, 2024, totaling \$0. Claims incurred before plan year end that were submitted after year-end (but before the date defined by the plan agreement) totaled \$0.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan maintains funds in the First Citizen Bank which seeks preservation of capital and liquidity. This fund invests primarily in short-term, high-credit-quality money market instruments. These instruments are US-dollar-denominated obligations and primarily include commercial paper, certificates of deposits, master and promissory notes, municipal securities, and repurchase agreements. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded in the accrual basis.

Subsequent Events

Management has reviewed subsequent events through July 30, 2025, the date the financial statements were available to be issued.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 as described as follows:

Level 1 *Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.*

Level 2 *Inputs to the valuation methodology include*

- *quoted prices for similar assets or liabilities in active markets;*
- *quoted prices for similar assets or liabilities in inactive markets;*
- *inputs other than quoted prices that are observable for the asset or liability;*
- *inputs that are derived principally from or corroborated by observable market data by correlation or other means.*

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 *Inputs to the valuation methodology are unobservable and significant to the fair value measurement.*

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for asset measured at fair value. There have been no changes in methodologies used for November 30, 2024 and 2023.

Money Market Fund: Valued at the net asset value of shares held by the Plan at year end. Because the fair value of the fund is based on quoted prices in an active market, as defined by FASB ASC 820, Fair Value Measurement and Disclosures, it is considered a level 1 measurement. There were no money market fund at year end.

NOTE 5. TRUST FEES/ADMINISTRATIVE FEES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and trustees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

NOTE 6. TAX STATUS

Plan management believes that the Plan qualifies for exemption from income tax under the Internal Revenue Code, and therefore, no provision for income taxes is reflected in the accompanying financial statements.

Accounting Principles generally accepted in the United States of America require plan management to evaluate the tax position taken by the Plan and record a tax liability (or asset) if it has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any tax periods in progress.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the plan to modify the benefit provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

Benefit obligations include those claims for which services have been performed but which have not been paid as of November 30, 2024. Based on the inherent uncertainties involved, it is reasonably possible that the estimate will change in the near term.
