We have performed audits of the financial statements of Welocalize, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### 1. Description of the Plan

#### *General*

The following description of the Welocalize, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering substantially all employees of Welocalize, Inc. (the Employer), except for nonresident aliens, residents of Puerto Rico, and periodic hourly field service employees under the age of 21 with less than 1,000 hours of service during the year. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective February 1, 2024, the Plan was amended to include automatic enrollment of all newly hired employees. Employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants who are automatically enrolled in the Plan have their pre-tax deferral rate set at 3% of eligible compensation.

Effective January 1, 2025, Welo Data, LLC merged into the Plan.

#### *Administration*

Fidelity Workplace Services, LLC serves as the third-party administrator and recordkeeper that processes and maintains the records of participant data. Fidelity Management Trust Company (Fidelity) has been engaged to serve as the trustee of the Plan. The Employer serves as the Plan Administrator and is responsible for the day-to-day operations and oversight of the Plan.

#### *Participant Contributions*

Participants may contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. In addition, participants may elect to contribute Roth deferrals. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Internal Revenue Code (IRC). Participants who elect to contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in compensation.

#### *Rollover Contributions*

Participants are permitted to make rollover contributions of amounts received from other tax-qualified retirement plans. Such rollover contributions are deposited in the appropriate investment funds in accordance with the participant's election and the Plan's provisions.

#### *Employer Contributions*

As defined in the Plan document, the Employer may match a portion of participant contributions on a discretionary basis. During the year ended December 31, 2024, the Employer matched 50% of employee deferrals up to 3% of a participant's compensation, determined on a per pay period basis. The Employer may also make discretionary profit-sharing contributions to the Plan. The Employer did not make discretionary profit-sharing contributions for the year ended December 31, 2024.

### *Participant Accounts and Investment Options*

Each participant's account is credited with the participant's contributions and Employer discretionary matching contributions, if any, as well as, allocations of the Employer discretionary profit-sharing contributions, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are immediately vested in their salary deferral contributions, rollover contributions and related earnings thereon. Vesting on certain types of contributions from employers merged into the Employer is different than on the Employer's current discretionary profit-sharing contributions and matching contributions. Vesting is based on the following schedules:

### *Forfeited Accounts*

Terminating participants of the Plan are paid the current value of the vested balance in their accounts as soon as administratively feasible. Unvested amounts are forfeited and used to reduce administrative expenses or the Employer's discretionary contributions. As of December 31, 2024 and 2023, unallocated forfeitures totaled \$12,548 and \$12,034, respectively. During 2024, \$139,158 of forfeitures were used to reduce Employer contributions.

### *Payment of Benefits*

Benefit payments are available to participants upon retirement (age 65), termination of employment, death, in-service withdrawals upon attainment of age 59 ½, or disability. Upon proof, to the satisfaction of the Plan Administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for hardship purposes. Participants are entitled to a benefit equal to the vested portion of their account, which will be distributed in the form of a lump sum payment. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$5,000 or less.

### *Notes Receivable from Participants*

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding note balance in the participant's account during the prior 12 months. The notes are secured by the participant's vested account balance and no more than one outstanding note is permitted at any time. Such notes bear interest at the available market financing rates and must be repaid to the Plan within a five-year period, unless the note is used to purchase a principal residence. The specific terms and conditions of such notes are established by the trustees of the Plan. Principal and interest are paid ratably through payroll deductions.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan have been presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### *Use of Estimates*

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan Administrator deems the note to be in default, the note balance is reduced, and a benefit payment is recorded based on the terms of the Plan document.

### *Payments of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Plan administrative and recordkeeping fees are paid by the Plan and included in administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant's account and included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange

Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Corporate Stock* - Valued at the closing price reported on the active market on which the individual securities are traded.

*Interest-Bearing Cash Accounts and Money Market Accounts* - Valued at amortized cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity, the trustee; therefore, these transactions qualify as party-in-interest transactions. Investment advisory services are provided by UBS Financial Services, Inc. (UBS). Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments. The Employer directly pays any other fees related to the Plan's operations. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participant accounts will become fully vested and non-forfeitable.

### 7. Tax Status

The Plan is using a prototype plan that received an opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the form of the Plan document was acceptable under the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires management to evaluate the Plan's tax positions. The Plan's management has concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities that, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Subsequent Events

Management has evaluated events and transactions for potential recognition or disclosure through the independent auditor's report date, September 18, 2025 the date the financial statements were available to be issued. Other than events disclosed in Note 1, the Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
