Note 1—Description of the Plan

The following brief description of Divurgent, LLC 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Reference should be made to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering certain employees of Divurgent, LLC (the “Company” or “Employer”) who completed six months of continuous employment. All employees, except for union employees, nonresident aliens, temporary project-based employees, and leased employees, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Company is the Plan sponsor and Plan administrator. The Company outsourced the recordkeeping function of the Plan to John Hancock Life Insurance Company (U.S.A.) (the “Trustee or qualified institution”) and the Trustee holds the assets of the Plan. Certain administrative functions are performed by employees of the Company. These employees do not receive compensation from the Plan.

Participant Contributions – Participants may contribute up to the maximum amount permitted by law subject to certain Internal Revenue Code (“IRC”) limitations. The maximum contribution limit for 2024 was \$23,000. Participants who are 50 years or older during the Plan year may make additional pretax contributions referred to as catch-up contributions. The limit on catch-up contributions for 2024 was \$7,500. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated account until changed by the participant. Unless otherwise affirmed, the employee’s deferral rate will increase by 1% each year up to the maximum deferral rate of 9%. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, a participant may direct after-tax contributions into Roth 401(k) accounts, subject to certain limits. Roth 401(k) accounts allow participants to elect to be taxed currently on part or all of their contributions made to the Plan. Future distributions of Roth 401(k) contributions and the related earnings are not taxed if certain requirements are met.

Employer Contributions – The Company may make matching contributions based on a percentage of participants’ deferrals, which the Company will determine each year, but not to exceed the first 6% of compensation. Amounts deferred over 6% of compensation are not matched. Participants must complete a year of service and be employed on the last day of the Plan year to be allocated matching and profit sharing contributions. For the year ended December 31, 2024, the Company elected to not make a matching contribution. The Company’s total matching contributions for the year ended December 31, 2024 was \$-0-. The Company may also make a discretionary non-elective profit sharing contribution each year on behalf of the Plan’s participants. The Company did not make a discretionary non-elective profit sharing contribution in 2024. The matching and non-elective profit sharing contributions are invested as directed by the participant.

Vesting – Participants have a fully vested and nonforfeitable interest in their voluntary contributions plus earnings thereon. Vesting in the Company’s matching and discretionary non-elective profit sharing contributions plus earnings thereon is based on years of continuous service. Forfeited balances of terminated participant’s nonvested accounts can be used to reduce future Company contributions or Plan expenses, as defined by the Plan. Regardless of the vesting schedule, participants are fully vested upon death or disability.

Each participant’s vesting schedule in the Company’s matching and discretionary non-elective profit sharing contributions plus earnings thereon is as follows:

Participant Accounts – Each participant's account is credited with the participant's and Company's matching contributions and an allocation of (a) the Company's discretionary non-elective profit sharing contributions and (b) investment earnings (losses) (including net appreciation in fair value of investments) and charged with participant distributions and an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions as defined by the Plan. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account at the time of retirement, termination, total disability, or death.

Investments – Participants direct the investment of their contributions and any Company contributions into various investment options offered by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants – Participants are eligible to borrow up to 50% of their vested balance or \$50,000, whichever is less, but not less than \$1,000 from the Plan, for any purpose. Note repayments are made through bi-weekly payroll deductions. The notes are secured by the balance in the participant's account and bear interest at prime plus 1% (6.50% to 9.50% on notes outstanding as of December 31, 2024). Notes must be repaid within five years. If the note is made for the purchase of a participant's residence, the note may be repaid over a reasonable period of time longer than five years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, participants who have reached the age of 59½ may elect to withdraw all or part of the amounts then credited to their account prior to termination of employment.

Forfeited Accounts – Forfeitures occur when a participant terminates employment and is not vested in a portion of the Employer contribution amounts. Forfeitures are used to reduce future Employer contributions. Forfeited nonvested accounts totaled \$29,271 and \$34,105 at December 31, 2024 and 2023, respectively.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and qualified institution. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2—Summary of significant accounting policies (continued)

Contributions Receivable – The amount of participant related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Company contributions receivable in the Plan's financial statements.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Benefits Paid to Participants – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses paid directly by the Plan are made at the direction of the Plan Trustees, as provided in the Plan document. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedules:

- Investments, at fair value and notes receivables from participants as of December 31, 2024 and 2023 as shown in the statements of net assets available for benefits.
- Net appreciation in fair value of investments, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

Note 4—Fair value measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no significant changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts – These investments are public investment vehicles valued at net asset value ("NAV") of units of a trust. NAV, as provided by the administrator of the fund, is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. Investments measured at fair value based on NAV practical expedient are excluded from the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with FASB ASC 820 Subtopic 10, the pooled separate accounts held by the Plan are measured at fair value using NAV per share (or its equivalent) as a practical expedient and are exempt from the fair value hierarchy. Note 5—Party-in-interest transactions

Plan investments include shares of pooled separate accounts managed by the Trustee or one of its affiliates, which qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to the Plan to third party administration amounted to \$79,024 for the year ended December 31, 2024.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan without the consent of any participant, subject to the provisions set forth by ERISA. If the Plan is terminated, the amounts in participants' individual accounts that derive from Company contributions become fully vested, regardless of length of service.

Note 7—Federal income tax status

The Plan adopted a Prototype Non-Standardized 401(k) Plan ("Prototype Plan") with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020 in which the IRS stated that the Prototype Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Prototype Plan has been amended since receiving the determination letter. However, the Plan's management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 9—Delinquent participant contributions

During the year ended December 31, 2024, the Plan failed to remit in a timely manner certain participant contributions from its assets within the required time period as specified by DOL Reg. 2501.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan corrected these during the year.

Note 10—Subsequent events

The Plan has evaluated subsequent events through September 15, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued. No events have occurred subsequent to the date of the financial statements that would require adjustment to, or disclosure in, the financial statements.


