NOTE 1 - DESCRIPTION OF PLAN

The following description of the Karndean International LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Karndean International LLC ("the Company"). The Plan has no age or service requirement for participation in employee deferrals and employer safe harbor contributions. Participation in profit sharing contributions requires 500 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to certain limitations established by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Plan allows participants who have attained the age of 50 by the end of the Plan year to make catch-up contributions in accordance with the provisions of Code Section 414(v). Participants direct these contributions into various investment options offered by the Plan. The Company makes a safe harbor matching contribution equal to 100% of the participant's salary deferral contributions, up to a maximum of 5% of the participant's compensation. The Company may also make a discretionary profit-sharing contribution. The Company did not make a discretionary profit-sharing contribution for 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: Under the Plan, a participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their account balances plus actual earnings thereon, except for Company discretionary profit sharing contributions, which vest at 20% per year beginning after two years of service and become fully vested after six years of service.

Forfeitures: Forfeitures of Company contributions are used to offset plan expenses and then future Company contributions. At December 31, 2024 and 2023, there were no forfeitures available to utilize. During 2024, there were no forfeitures used to offset Company contributions.

Investment Options: Upon enrollment in the Plan, a participant may direct contributions to a variety of investment options. Participants are allowed to change their investment options at any time.

Payment of Benefits: Upon termination of service, disability, retirement, or death, a participant will receive a distribution equal to the value of his or her vested interest in his or her account. Balances are generally paid as a single lump-sum distribution or rollovers to another qualified plan.

Withdrawals: A financial hardship provision is available, enabling a participant to withdraw an amount to cover an immediate and heavy financial need not to exceed limits imposed by the plan document.

In-Service Distribution: Upon the attainment of age 59 1/2, participants are entitled to in-service distributions of their vested account balances.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Administrative and Investment Management Expenses: The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and custodian fees. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 4 - CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB, the custodian of the Plan.

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

Self-Directed Funds: Accounts primarily consist of mutual funds and common stocks. The fair values of these investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Mutual Funds: The Plan holds investments in mutual funds through a custodial account arrangement with Nationwide Trust Company, FSB (Nationwide), the Nationwide Retirement Innovative Advantage Program, which is designed to comply with the Internal Revenue Code Section 403(b)(7). Plan participants direct their investments to various registered investment companies that are offered as investment options under the Plan's custodial account arrangement with Nationwide. Nationwide charges participant accounts with administrative, recordkeeping and asset fees on a monthly basis, as established per the Plan's Program Agreement with Nationwide. The fair values of the Plan's investments in the Nationwide Retirement Innovative Advantage Program reflect the quoted market prices of the underlying mutual funds held directly by the Plan through the Program agreement, less the fees allocated by Nationwide under the Program Agreement (Level 2 measurement inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative and fiduciary functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan holds units of mutual funds managed by the custodian of the Plan. These transactions qualify as party-in-interest transactions. Nationwide Trust Company, FSB, is the Plan's custodian and recordkeeper, and investment management fees and contract administrative fees to this service provider qualifies as party-in-interest transactions. Total fees paid to the service provider were not material for the year ended December 31, 2024.

NOTE 7 - TAX STATUS

The Plan sponsor adopted the restated version of a pre-approved plan document. The Internal Revenue Service has determined and informed the prototype plan sponsor, by a letter dated June 30, 2020, that the prototype plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended from the original pre-approved plan document, Plan management believes the Plan is designed and is currently being operated in accordance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - SUBSEQUENT EVENTS

The Plan has evaluated events and transactions occurring subsequent to the balance sheet date of December 31, 2024, for items that should be recognized or disclosed in these financial statements. This evaluation was conducted through September 23, 2025, the date these financial statements were available to be issued.
