INDEPENDENT AUDITOR'S REPORT

To the Plan Trustee and Management of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chapman & Prime 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTE 1: DESCRIPTION OF PLAN

The following description of Chapman & Prime 401(k) Profit Sharing Plan (the Plan) provides only general information. Refer to the Plan documents for a more complete description of the Plan provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Chapman Healthcare Center, Inc. (the "Company", "Sponsor", and "Employer") and its affiliates. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance. Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Principal Life Insurance Company and Principal Trust Company, as the qualified institutions and custodians, which invests contributions and Plan earnings, makes investment transactions as directed by the participants and provides certain recordkeeping services. Orenda Retirement, LLC currently acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

The Plan covers substantially all full-time employees. The employees must also meet other requirements such as reaching twenty and one-half years old with six months of service. They then become eligible for participation in the Plan the first entry date following the required eligibility. Entry dates are the 1st day of the Plan year or the 1st day of the seventh month of the Plan year following the completion of the eligibility requirements.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor, under the terms of the Plan adoption agreement, has elected to make discretionary employer matching contributions of 1% of compensation for the year ended December 31, 2024. Additional profit-sharing amounts may be contributed at the option of the Company's management.

During the year ended December 31, 2024, the Company contributed \$80,238 in accrual based employer matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1: DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and Company's profit sharing and matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is vested in these contributions as follows:

Years of Service	Vesting Percent
Less than 3	0%
3 or more	100%

A participant's account becomes fully vested upon the participant's death, total disability, or attaining normal retirement age.

Participant and Employer Contributions Receivable

Contributions receivable include those pursuant to formal commitments based on the Plan's adoption agreement. Evidence that a formal commitment existed was based on criteria that (a) the contribution is based on participant compensation that existed for the current plan year and (b) the plan terms require a contribution to be made for the current plan year.

Notes Receivable from Participants

Participants may have one loan outstanding at any time and the maximum amount available is \$50,000 or one-half of their vested balance, whichever is less. No loan in an amount less than \$1,000 will be made. The loans are secured by the balance in the participant's account and bear interest at a rate that is commercially reasonable and determined by the Administrator by reviewing rates of similar types of loans by other lenders. Principal and interest is paid ratably through payroll deductions. Maximum repayment period shall not exceed five years, with the exception of loans that are used to acquire a principal residence.

Note 1: DESCRIPTION OF PLAN (Continued)

Benefit Payments

On termination of service due to death a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments to pay the entire account balance by the end of a five-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or use they account balance to purchase an annuity contract.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3 and \$3,433 respectively. These accounts will be used to reduce future employer contributions or to pay Plan expenses. In 2024, Plan expenses were reduced by \$9,338 from forfeited nonvested accounts.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the Plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Plan Amendments

There were no significant plan amendments during the year.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value, and NAV. The Plan's Trustee and management determines the Plan's valuation policies utilizing information provided by the investment advisers, third-party administrator and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and are included in benefits paid to participants and excess contributions payable. The Plan reported excess contributions related to failed year end ADP/ACP compliance test for the year ended December 31, 2024 totaling \$2,011. The excess contributions were not refunded to the applicable participant within 2 ½ months following the December 31, 2024 year-end, as required by the Internal Revenue Service. The Plan reported excess contributions related to failed year end ADP/ACP compliance test for the year ended December 31, 2023 totaling \$2,829. The excess contributions were refunded to the applicable participant within 2 ½ months following the December 31, 2023 year-end, as required by the Internal Revenue Service.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued, and determined there were no events that occurred that required disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The Plan Trustee has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, the qualified institutions:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- c) Investment income information, net appreciation in the value of investments, and interest income from notes receivable, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All amounts included in Note 5, *Investments Reported at Contract Value*.
- f) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024, excluding notes receivable from participants.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value or net asset value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts ("PSA"): Assets of a pooled separate account are pooled with funds of other investors and invested in stocks or mutual funds. The underlying securities have observable level 1 quoted pricing inputs or the fair value of the underlying investment may be publicly traded with a quoted price. The pooled separate account is not publicly quoted but the net asset value of the account is available to current investors via the Plan website or when Plan participants access the account values. The value is the basis for current transactions and the PSA can be redeemed at net asset value as of the measurement date. Therefore the Plan investments in PSAs have been determined to have a "readily determinable fair value" as is valued as a Level 1 asset.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and valued as a Level 1 asset.

Note 4: FAIR VALUE MEASUREMENTS (Continued)

Common investment trusts ("CITs"): The Plan's CITs invest in a collective trust fund. The fair value of the collective investment trust does not have a publicly quoted pricing input, but is available to current investors via the Plan website or when Plan participants access their account values. The net asset value is the basis for current transactions and the CIT can be redeemed at net asset value as of the measurement date. Therefore, the Plan investments have been determined to have a "readily determinable fair value" as is valued as a Level 1 asset.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: INVESTMENTS REPORTED AT CONTRACT VALUE

In 2020, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Trust Company totaling \$27,367 at December 31, 2024 and \$26,000 at December 31, 2023. Principal Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.75%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 6: TAX STATUS

The Plan has adopted a prototype non-standardized profit-sharing plan for which the IRS has determined and informed the prototype plan submitter, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, Principal Life Insurance Company, Principal Trust Company and Principal Global Investors Trust Company were the custodians of the Plan. The custodians of the Plan provides investment services to the Plan and also manages and invests contributions and other cash received as directed, records interest and dividend income, and makes distributions to participants. Orenda Retirement, LLC currently serves as third-party administrator for the Plan. Countryman & Smitherman, Inc. also provides consulting services for the Plan.

In general, the administrative expenses for the Plan are paid from the Plan's assets. From time to time certain expenses of the Plan, including legal and accounting fees, are paid by the Plan Sponsor. In addition, certain services to the Plan by the Plan Sponsor were performed at no charge.

Note 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 9: NON-EXEMPT TRANSACTION

In three instances during 2024, the Company experienced unintentional delays in the remittance of withheld participant contributions to the Plan which was not considered timely in accordance with the plan asset provisions of the Department of Labor (DOL) Regulation 2510.3-102, resulting in a prohibited (or a non-exempt) transaction. The aggregate amount of participant contributions in these three late remittances was \$12,480, with an additional \$3,032 in late participant loan remittances. The accompanying Schedule of Delinquent Participant Contributions discloses this non-exempt transaction in accordance with DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is correcting this non-exempt transaction during the year ending December 31, 2025 pursuant to the DOL's Voluntary Fiduciary Correction Program by funding the impacted Plan participants' accounts for earnings that would have been credited to the participants' accounts if the late remittance had been made on a timely basis and also crediting participants' accounts for the amount of excise taxes the Company would have otherwise paid to the IRS for the a late remittance.
