NOTE 1 – PLAN DESCRIPTION

The following description of the O & K American Corp. 401(k) Savings & Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

A. GENERAL

The Plan is a defined contribution plan covering eligible employees of O & K American Corp. (the “plan sponsor”). The plan sponsor administers the Plan and funds contributed under the Plan are held, invested and distributed by the trustee acting under trust agreements between the trustee and the plan sponsor in which all transactions are participant directed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

B. ELIGIBILITY

Employees are eligible to participate in the Plan upon attaining age 21 on the entry date subsequent to the six-month anniversary of the employee’s commencement date. Leased employees, contractors, security staff, janitorial staff, commissioned sales representatives and international transfer employees eligible to receive benefits from a retirement plan in their country of origin are not eligible to participate in the Plan.

Effective November 22, 2024, the Plan Sponsor amended the Plan to voluntarily adopt the automatic enrollment and escalation provisions of Section 101 of the SECURE 2.0 Act of 2022, ahead of the mandatory effective date of January 1, 2025. Newly eligible employees and, in a one-time re-solicitation, current participants with a 0% deferral rate as of that date, are automatically enrolled at a 3% elective deferral rate, increasing 1% annually to a maximum of 10%, unless they opt out or elect a different rate.

This change was implemented with the first payroll cycle following adoption and was communicated through updated plan documents, enrollment materials, and required notices. The Plan Sponsor made this change to increase participation and promote retirement savings. No compliance issues were identified related to the early adoption as of December 31, 2024.

Eligible employees may also receive an annual discretionary contribution from the plan sponsor upon attaining their one-year anniversary as well as being actively employed by the plan sponsor as of the last day of the calendar year.

C. CONTRIBUTIONS

Participants may contribute up to 100% of their compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Those participants who are age 50 or over by the end of the calendar year are eligible to make catch-up contributions up to the IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan also allows for Roth (after tax) contributions.

The employer may make an annual discretionary contribution. This contribution is to be made at the sole discretion of the plan sponsor and shall not exceed the maximum deductible amounts used to determine taxable income under the Internal Revenue Code. The plan sponsor elected to contribute 3% of participants’ eligible compensation for the plan years ended December 31, 2024 and 2023, which is the maximum percent allowed based on the plan sponsor’s employee handbook.

D. PARTICIPANT ACCOUNTS

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, employer contributions, allocations of Plan earnings, and charged administrative expenses. Allocations are based on the participant earnings or account balances.

E. VESTING

Participants are immediately vested in their contributions and the plan sponsor's discretionary contribution portion of their accounts, plus actual earnings thereon.

F. NOTES RECEIVABLE FROM PARTICIPANTS

A participant may borrow a minimum of \$1,000 and maximum amount of the lesser of (1) \$50,000 reduced by the excess of the highest outstanding plan loan balances during the year proceeding the date of the loan, or (2) 50% of the participant's vested interest in the Plan. Participant loans are secured by the balance in the participant's account. Participants may only have a maximum of two loans outstanding at any given time. The interest rate is determined by the plan administrator based on interest rates charged by persons in the business of lending money for loans under similar circumstances. The principal for a loan must be paid within a five year period unless the purpose of the loan is to acquire a principal place of residence, in which case, the loan may be repaid over a longer term. Plan loans must be repaid by salary deduction in equal payments of principal and interest each pay period and are recorded when received.

G. PAYMENT OF BENEFITS

Upon retirement, disability, or death, payment will be made in one lump sum or in installments. Upon termination of service prior to retirement, disability, or death, the participants whose vested balances exceed \$5,000 may receive, based on their account balances, the vested portion of their accounts in a single lump-sum payment, in installments, or as a qualified rollover. Participants with less than \$1,000 of vested benefits will receive a lump-sum distribution or can elect a rollover. In limited circumstances, distributions are permitted prior to termination of service: part or all of rollover contributions may be withdrawn in a single sum payment; all or part of a participant's vested balance may be paid in a single sum payment after reaching age 59.5, and upon financial hardship, as defined by the Plan Agreement.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America (GAAP), as promulgated by the Financial Accounting Standards Board (FASB) in the Accounting Standards Codification (ASC).

B. BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

C. ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain recorded amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

D. PLAN EXPENSES

The plan sponsor pays most of the expenses of administering the Plan. Expenses associated with loans and disbursements are paid by the individual participants. Investment related expenses are charged to participant accounts and included in net appreciation (depreciation) of fair value of investments.

E. INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

F. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

G. PAYMENT OF BENEFITS

Benefits are recorded when paid.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

I. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 12, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan's investments are held in a trust fund administered by Fidelity Management Trust Company, the trustee of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustee:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net (depreciation) appreciation of the fair value of investments, interest and dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements, as the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – RELATED PARTY TRANSACTIONS

Certain plan investments consist of fund shares managed by Fidelity Investments, the custodian and Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Also, the Plan has notes receivable from participants that qualify as party-in-interest transactions. Investments in shares managed by Fidelity Investments and the notes receivable from participants total \$1,624,570 and \$1,266,558, as of December 31, 2024 and 2023, respectively.

NOTE 6 – TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the plan administrator will facilitate distribution of the full account balances in a single lump sum payment to each participant.

NOTE 7 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies and input used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual Funds*: Valued based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Money Market Mutual Fund*: Valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity. These securities are reflected at Level 2 as inputs used to determine fair value are not quoted prices in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
