INDEPENDENT AUDITOR'S REPORT

To the Administrator of
TCW Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of TCW Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of TCW Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TCW Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TCW Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the TCW Retirement Plan (the "Plan"), formerly known as Tennessee Commercial Warehouse, Inc. 401(k) Profit Sharing Plan, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a profit-sharing plan with a 401(k) arrangement covering all full-time employees of TCW Admin., Inc. (the "Company") who have six months of service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions – Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the statutory limitations defined in the Internal Revenue Code. Participants may change their contribution percentages at any time. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan Sponsor may make matching contributions equal to a discretionary percentage of each participant's contribution, to be determined by the Company's board of directors. Additional amounts may be contributed at the option of the Company's board of directors and are allocated to the participant's accounts in proportion to his or her compensation for the Plan year. All contributions are subject to certain statutory limitations.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocation of (a) the Plan Sponsors' contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as of the allocation date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may not borrow from their fund accounts.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsors' discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Beginning with the second year of participation, a participant earns 20% for each year of credited service. A participant is 100% vested after six years of credited service, as defined. A participant's account also becomes fully vested upon death or disability of the participant, attainment of Normal Retirement Age of 62, or upon termination of the Plan.

Investment Options – Upon enrollment in the Plan, participants may direct contributions into any of a variety of investment options provided under a contract with Ascensus Trust Company. Participants may change their investment options daily.

Payment of Benefits – On termination of service due to any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For vested balances exceeding \$5,000, the Plan also allows for installment payments. The Plan can automatically distribute, or rollover terminated employee balances not exceeding limits specified in the Plan document and amendments. Hardship withdrawals are not permitted, but a participant may receive their rollover contributions as a distribution. Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Plan Termination – The Plan Sponsor expects the Plan to continue indefinitely. However, the Plan Sponsor retains the right under the Plan to discontinue Plan Sponsor contributions at any time and to terminate the Plan. In the event of Plan termination, participants would become fully vested in their account balances. These balances would continue to be held in custody by the applicable trustee until all vested Plan benefits were distributed to the participants.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited nonvested accounts totaled less than 1% of net assets. As specified in the Plan document, these amounts are used to pay the administrative expenses of the plan or reduce future employer contributions to the Plan.

Accounting Periods – Any references to 2024 or 2023 in these financial statements refer to the years ended December 31, 2024 and 2023, respectively, unless otherwise noted.

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Estimates – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further details.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan’s realized gains or losses on investments sold during the year as well as unrealized gains and losses on investments held during the year.

Administration of Plan Assets – The Plan’s assets are held by the custodian of the Plan. Contributions are received by the custodian and invested into participant directed funds. The custodian receives and re-invests any interest and dividend income and makes distributions to participants. Certain administrative functions are performed by officers and employees of the Plan Sponsor. No such officers or employees receive compensation from the Plan.

Administrative Expenses – Certain administrative expenses of the Plan are paid directly by the Plan Sponsor.

Date of Management’s Review – Subsequent events were evaluated through August 29, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – INVESTMENTS AND FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements and Disclosures (“ASC 820”) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets which the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - TAX STATUS

The Plan is an Access Retirement Services, LLC defined contribution prototype plan. The prototype plan received a favorable determination letter, dated June 30, 2020, from the Internal Revenue Service concerning its tax-exempt status. The Plan has been restated since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Vanguard, an affiliate of Ascensus Trust Company, the trustee of the Plan. The Plan also engaged auditors to audit the plan, investment advisors, and third-party plan administrators. Fees for these services are included in plan expenses. These transactions qualify as party-in-interest transactions. The fees paid by the Plan for investment and other administrative services to these parties-in-interest amounted to \$152,872 and \$107,103 during 2024 and 2023, respectively. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIANS

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared by and certified to as complete and accurate by the investment custodians of the Plan. Ascensus Trust Company served as the investment custodian and trustee of the assets of the Plan.

NOTE 8 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements reflect a payable of the excess contributions due to the participants, while the 5500 reports them as contributions for the year. The Plan records corrective distributions as a reduction of contributions in the financial statements. This approach aligns with the recommendation by the Financial Reporting Executive Committee (FinREC), who consider these contributions ineligible for the plan year.
