### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Evergreen Enterprises, LLC 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1—Description of the Plan**

The following description of Evergreen Enterprises, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan was established on January 1, 1999, by Evergreen Enterprises of Virginia, LLC (the “Plan Administrator”) as a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was amended and restated effective January 1, 2022 to include employees of Plow & Hearth LLC and Children’s Group LLC, who were previously a part of the Plow & Heath, LLC 401(k) Plan. Effective January 1, 2022, the Plan was considered a multiple employer Plan with the addition of Children’s Group LLC as a participating employer. Effective February 14, 2024, net assets of \$1,402,198 were transferred out of the Plan, as Children’s Group was removed from the Plan as a participating employer.

The Plan was most recently amended effective January 1, 2023, to comply with Internal Revenue Service (“IRS”) regulations for periodic Plan restatements. No significant changes were made to previous Plan provisions.

*Eligibility* – The Plan covers the employees of Evergreen Enterprises, LLC, and Plow & Hearth LLC, (collectively referred to as the “Company”) who have completed at least three months of service. To receive the employer match, employees must have completed one year of service. Each employee who becomes eligible to participate shall enter the Plan effective as of the first day of the month immediately following or coinciding with the date the employee completes eligibility conditions.

The Plan includes an automatic enrollment provision for employees who became eligible to participate in the Plan subsequent to January 1, 2022. Newly eligible employees will be entered into the Plan at a pre-tax deferral contribution rate of 3%, unless they notify Plan management that they do not wish to participate in the Plan or elect a different percentage.

*Plan Administration* – The Company is the Plan sponsor and Plan Administrator. Assets of the Plan are held by Ascensus, LLC (the “qualified institution”), the trustee of the Plan. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan. The Company may reimburse the Plan for any administrative expenses incurred.

*Contributions* – The Plan provides for participant contributions of pre-tax and Roth contributions of a specific percentage or dollar amount of annual compensation, as defined in the Plan. Participants of qualifying age may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations allowed under Section 402(g) of the Internal Revenue Code (“IRC”).

The Company may make matching contributions, nonelective contributions, and profit-sharing contributions equal to a discretionary percentage defined by the Company’s Board of Directors. For the year ended December 31, 2024, the Company elected to contribute 100% of the first 2% of the participant’s compensation contributed to the Plan. There were no nonelective or profit-sharing contributions in 2024.

*Investment Options* – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers multiple investment options for participants as of December 31, 2024. Participants may change their investment elections at any time.

**Note 1—Description of the Plan (continued)**

*Participants' Accounts* – Each participant's account is credited with the participant's contributions and an allocation of Company contributions. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Each participant's account is also allocated a portion of the Plan earnings and losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are segregated for purposes of determining the earnings or losses on each participant's choice of investments.

*Payment of Benefits* – Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, attainment of age 59½, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment, installment payments in an amount equal to the vested value of his or her account, or ad-hoc distributions. At December 31, 2024 and 2023, there were no benefit payments that had been requested but not yet paid.

*Vesting* – A participant normally becomes eligible for benefits after reaching age 65 or meeting the vesting requirements. A participant who becomes permanently disabled, dies, or reaches the early retirement requirements while in the employment of the Company will have a 100% vested interest in his or her account. As defined in the Plan document, the early retirement requirements are attainment of age 55 and completion of 5 years of vesting service. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Vesting of Company contributions is determined in accordance with the participant's years of continuous service with the Company as follows:

*Forfeitures* – Forfeitures of nonvested contributions may be used to pay Plan expenses or used to offset the Company's contribution obligation. The Plan's balance in the forfeitures account were \$139 and \$1,396 as of December 31, 2024 and 2023, respectively. Forfeiture balances of \$17,388 were used to pay Plan expenses for the year ended December 31, 2024. No forfeitures were used to offset the Company's contribution for the year ended December 31, 2024.

*Notes Receivable from Participants* – A participant may borrow from the Plan an amount which, when added to the outstanding balance of any other loans from the Plan to the participant, does not exceed the lesser of: (i) 50% of his or her vested portion or (ii) \$50,000 reduced by the excess, if any, of the highest outstanding loan balance in the previous 12 months over the outstanding balance on the date of the loan. The period for repayment shall be for a period not to exceed five years unless the loan is to be used in conjunction with the purchase of the principal residence of the participant, for which the repayment period is up to 10 years. New loans are charged an interest rate commensurate with the prime rate (as published by the Wall Street Journal) plus 1%. All outstanding loans bore an interest rate of 4.25% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

**Note 2—Summary of significant accounting policies**

*Basis of Presentation* – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The Plans Investment Committee determines the Plan’s valuation policies utilizing information provided by Ascensus, LLC.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* – Benefit payments are recorded when paid.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. Delinquent notes are reclassified as distributions based upon terms of the Plan document. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded.

*Excess Contributions Payable* – Amounts payable to participants for contributions in excess amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

*Contributions Receivable* – The amount of employer contributions due and payable, but not yet deposited with the Plan as of year-end is reflected as employer contributions receivable in the Plan’s financial statements.

*Administrative Expenses* – As provided by the Plan Agreement, administrative expenses related to Plan investments and administration are paid by the Plan, and other administrative expenses are paid by the Company. Investment related expenses are included in net appreciation of fair value of investments.

*Risks and Uncertainties* – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 3—Information provided and certified by the qualified institution (unaudited)**

Assets of the Plan are in the custody of Ascensus, LLC (the “qualified institution”). The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution of the Plan has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, including realized and unrealized gains and losses, dividends and interest, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year).

**Note 4—Fair value measurements**

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between levels during the year ended December 31, 2024.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 or 2023:

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Interest Bearing Cash* – Valued at historical cost, which approximates fair value.

*Common Collective Trusts* – These investments are valued based on NAV of units of the common collective trust. NAV, as provided by the qualified institution, is used as a practical expedient to estimating fair value. NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The funds' principal objective is to protect principal while providing a higher rate of return than shorter maturity investments, such as money market funds or certifications of deposits.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Plan termination**

Although, it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions and the net assets would be allocated to participants of the Plan in amounts equal to the individual account balances.

**Note 6—Tax status**

The Company adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7—Party-in-interest transactions**

Certain investments of the Plan are managed by the qualified institution of the Plan's assets. The qualified institution provides investment management services to the Plan. The Plan also pays fees to an investment advisor. Transactions involving these investments are considered to be party-in-interest transactions for which statutory exemption exists under DOL's Rules and Regulations. Fees incurred by the Plan for investment management and advisory services are paid directly by the Plan and, therefore, do qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid by the Plan to these parties-in-interest totaled \$122,236 for the year ended December 31, 2024.

Notes receivable from participants also qualified as parties-in-interest.
