NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Carollo Engineers, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the comprehensive plan document for a more complete description of the Plan’s provisions.

General

The Plan was established effective July 1, 1984, by Carollo Engineers, Inc. (“Carollo”, the “Company” or “Plan Sponsor”) and was amended and restated effective October 25, 2021. The Plan is a contributory defined contribution plan covering all eligible employees of the Company, and certain participating related employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Trustee and Administration of the Plan

The Trustee of the Plan is Fidelity Management Trust Company (“FMTC” or “Trustee”). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan’s 401(k) Committee is responsible for oversight of the Plan, including determining the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility

Employees must be 18 years of age or older to participate in the Plan. Eligible employees can participate in the Plan immediately upon being hired. All employees are eligible to participate unless they are covered by a collective bargaining agreement, leased employees, and certain nonresident aliens, as defined.

Contributions

Each year, participants may contribute up to 95% of pre-tax annual compensation, as defined. Salary deferral agreements may be made, terminated or changed according to procedures and limitations set up by the Plan Administrator and the Plan document. The Plan also allows for after-tax and Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, with increases of 1% each year thereafter to a maximum of 15%. Participants may elect to not participate in the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company has elected to make safe harbor matching contributions of 100% of the first 1% of eligible compensation that a participant contributes to the Plan and 50% of the next 5% of eligible compensation that a participant contributes to the Plan (the “Safe Harbor Matching Contribution”), subject to Internal Revenue Code (“IRC”) limitations. The Safe Harbor Matching Contribution for each participant is made to the same investment funds to which the participant’s deferred contributions are made. All investments are participant directed.

Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000. Loans bear a reasonable rate of interest (prime rate plus 1% at the date of approval) and are secured by the participant's vested account balance. The maximum number of loans outstanding at any one time is two. Loans are repaid through payroll deductions and have a maximum repayment term of five years, unless the loan is for a purchase of a principal residence, in which case the repayment period shall be no more than 15 years. Participant loans with no payments received for 6 months are classified as in default and are treated as a taxable distribution from the Plan. As of December 31, 2024, the loans outstanding had interest rates of 4.25% to 9.50%, maturing on various dates through October 2037. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

Participants who terminate their employment prior to the completion of the minimum number of applicable years of service forfeit their unvested employer contributions. Forfeited balances are used to reduce matching contributions or Plan expenses. During the year ended December 31, 2024, \$83,869 of forfeitures were used to reduce employer matching contributions and \$2,095 of forfeitures were used to pay Plan expenses. As of December 31, 2024 and 2023, forfeitures included in Plan assets totaled \$20,527 and \$9,765, respectively.

Payment of Benefits

Participants are eligible to receive a lump sum distribution of their vested account balance upon termination of employment, retirement, disability or death. A participant or beneficiary may elect to (a) receive the lump sum amount directly, or (b) roll over the value into another qualified plan or Individual Retirement Account ("IRA"). If, upon termination of employment, the value of the vested portion of a participant's account is \$1,000 or less, it will automatically be distributed as soon as administratively feasible. For participants with account balances in excess of \$1,000, no distribution will occur until a withdrawal request is completed. Participants with account balances in excess of \$1,000, in addition to either a lump sum or direct rollover, may choose to receive installments, request a partial withdrawal, or defer receiving payments until age 73.

In-service withdrawals from a participant's vested account balance are permitted on attainment of age 59½ or in circumstances of financial hardship, in accordance with provisions specified in the Plan agreement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by its investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan payments beyond the applicable cure period and the loan is deemed a distribution, based on the terms of the loan document, the participant's loan balance is reduced, and a benefit payment is recorded in the financial statements in the year the determination was made.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to certain participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments and are allocated to participants' accounts based on a specified basis point per investment through the investments' earnings. Administrative expenses paid by the Plan totaled \$161,307 for the year ended December 31, 2024.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - INVESTMENTS AND FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement* ("ASC 820"), provides the framework for measuring fair value, which includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023. Certain reclassifications have been made to the 2023 financial statements for them to conform to the 2024 presentation.

Mutual Funds (Registered Investment Companies)

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Account

Self-directed brokerage account investments are valued at the closing price reported on the active market on which the individual securities are traded. Accounts primarily consist of mutual funds, common stocks, units, certificates of deposits, funds, cash, corporate bonds, government bonds, preferred stock and rights/warrants.

Collective Trusts

Valued at NAV per unit as determined by the collective trusts as of the valuation date. The unit values are determined based upon the fair value of the underlying assets. The NAV, as provided by the Trustee, is used as practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The collective trusts have no unfunded commitments, redemption notice periods or redemption requirements.

Stable Value Fund

The stable value fund ("SVF") is collective trust managed by FMTC which seeks to preserve principal investments while earning interest income and seeks to maintain a NAV of \$1 per unit. The SVF invests in fully benefit-responsive investment contracts issued by insurance companies and other financial institutions, and in fixed income securities. The SVF is stated at fair value using the NAV as a practical expedient for fair value. The investment contracts provide for the payment of a specified rate of interest and for the repayment of principal when the contracts mature. Fair value approximates contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As of December 31, 2024, the Plan had no unfunded commitments related to the stable value fund. The stable value fund has a daily redemption frequency and redemption notice period. There are no other restrictions on the timing of redemption; however, participant redemptions may be subject to certain redemption fees.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are investment funds managed by Fidelity Investments or FMTC. FMTC is the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants qualify as party-in-interest transactions. Administrative expenses paid by the Plan to the trustee, and its affiliates, also qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan should be terminated, the amount in each participant's account, as of the date of such termination, becomes fully vested.

NOTE 7 - TAX STATUS

The plan document is a pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the pre-approved plan was designed in accordance with applicable IRC requirements as of that date. The Plan has since been amended. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the Plan's tax positions and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
