Opinion

We have audited the accompanying financial statements of McElroy Truck Lines, Inc., Medical Benefits Plan, which comprise the statements of net assets available for benefits — cash basis and statements of plan's benefit obligations — cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits — cash basis and statements of changes in plan's benefit obligations — cash basis for the years then ended and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits — cash basis of McElroy Truck Lines, Inc., Medical Benefits Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits — cash basis for the years ended December 31, 2024 and 2023, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the McElroy Truck Lines, Inc., Medical Benefits Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the plan's provisions.

General

McElroy Truck Lines, Inc., Medical Benefits Plan provides health and other benefits to substantially all full-time employees and their eligible dependents. The Plan and related trust were established on April 12, 1989. The Plan is a Voluntary Employees' Beneficiary Association (VEBA) described in Section 501(c)(9) of the Internal Revenue Code of 1954. The plan document was amended effective January 1, 2016 to include all plan features in a wrap document.

Benefits

The Plan provides health benefits (medical, dental, vision, and prescription drugs), short-term disability benefits, life insurance, critical illness and accident, and accidental death and dismemberment insurance. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the life insurance benefits, (basic, supplemental, and dependent), accidental death and dismemberment, critical illness and accident and vision insurance. The Company purchases annual insurance contracts for these insured benefits. Premiums for life insurance and accidental death and dismemberment insurance programs are paid to the insurance company from the general assets of the Company. Premiums for the vision benefits are paid from the assets of the trust.

Stop Loss Coverage

The Plan purchases stop-loss insurance coverage to limit its exposure to individual health claims in excess of \$150,000. The premiums are included in premium payments in the accompanying statements of changes in net assets available for benefits.

Self-Insured Benefits

All other plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services

Note 1. Plan Description (continued)

only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then either reimbursed by the trust account or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions (Employer)

It is the employer's policy to fund the Plan to the extent necessary to pay current benefits. Employees contribute specified amounts based on plan coverage and amounts to extend coverage to eligible dependents.

Contributions (Employee)

Participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. Participants pay the full cost of the critical illness and accident policies. The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance and stop loss insurance. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

There were no significant changes in the method of funding the Plan in the years ended December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Accounting Method

As is the case of many entities of this type, the accounts are maintained, and these statements are presented, on a cash basis, reflecting only cash received and disbursed. Therefore, receivables and payables, accrued income and expenses which may be material in amount, are not reflected, and these statements are not intended to present the overall financial position or results of operations.

Estimates

The preparation of financial statements in accordance with the cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2. Summary of Significant Accounting Policies (continued)

Payment of Benefits

Premiums paid by either the Company or the trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processors.

Date of Management's Review

Subsequent events were evaluated through September 3, 2025, which is the date the financial statements were available to be issued.

Note 3. Reportable Transactions

For the years ended December 31, 2024 and 2023, no transactions, with the exception of benefit payments, were in excess of 5% of the current value of plan assets. There were no loans or fixed-income obligations in default, or classified as uncollectible.

Note 4. Stop Loss Recoveries

Claims in excess of the individual stop loss for health insurance amounted to \$209,099 and \$366,262 for December 31, 2024 and 2023, respectively. The amounts are used to offset claims.

Note 5. Claims Incurred but not Reported

Plan obligations at December 31 for claims incurred but not reported are estimated by the plan's management based on claims data provided by the plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payments. The estimated amounts are reported in the accompanying statements of plan's benefit obligations.

Note 6. Tax Status

The VEBA trust established under the Plan to hold plan assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service and the plan sponsor believes that the trust and the Plan, as amended, continue to qualify and operate in accordance with applicable provisions of the Internal Revenue Code.

The preparation of financial statements in conformity with the cash basis of accounting require plan management to evaluate tax positions taken by the Plan and recognize a

Note 6. Tax Status (continued)

tax liability (or asset) if it has taken an uncertain position that more likely than not, would not be sustained upon examination by appropriate taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Termination of the Plan

Although it has not expressed to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be used for the benefit of the participants.

Note 8. Related Party Transactions

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

Note 9. Liabilities

The Plan sponsor makes employer contributions to the Plan as needed to cover cash deficiencies. Liabilities of \$21,609 represent cash overdrafts as of December 31, 2023. The overdraft is the result of outstanding checks. The bank statement reflected a positive balance as of December 31, 2023.
