Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Green Mountain Electric Supply, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. (1) Description of Plan

The following description of the Green Mountain Electric Supply, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all employees, except leased employees, of the Green Mountain Electric Supply, Inc. (the “Company”), Recovery Logistics LLC, and Apex Energy Tek, LLC. Effective April 1, 2024, April 26, 2024, and May 1, 2024, the Plan was amended to include employees of newly acquired companies Wash Electric Supply, WESCO Distribution Inc/Needham Electric Supply, LLC, and Ion Lighting Distributions, Inc., respectively. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

An employee becomes eligible to participate in the Plan upon attainment of age 21 and completion of six consecutive months of employment, during which 500 hours of service must be completed. The entry date will be the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or the next following the date the employee satisfies eligibility requirements. Effective July 1, 2023, the Plan was amended to change the service requirement to three consecutive months of employment and 250 hours and the entry date to first day of the Plan quarter coinciding with the next following the date the employee satisfies the eligibility requirements.

(b) Employee Contribution

Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to the maximum amount as set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.

(c) Employer Contribution

The Company makes a safe harbor matching contribution for each employee who enters into a salary reduction agreement and meets the employer contribution eligibility requirement. The matching contribution during 2024 and 2023 equaled 100% of the first 3% and 50% of the next 2% deferred by participants.

The Company may also contribute a profit-sharing contribution for each employee, without regard to current or accumulated net profits of the Company determined by the administration of the Plan for each year. Eligible participants must be employed on the last day of the Plan year. The Company did not provide a profit-sharing contribution in 2024 and 2023.

(d) Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested account balances.

Allocations are based on a participant's eligible compensation relative to total eligible compensation, deferred contribution amounts or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant determines the investment strategy of their account as provided by the Plan.

(e) Vesting

Participants are immediately vested with respect to their contributions and the Company's safe harbor matching contribution plus earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 20% vested after two years of employment, with an additional 20% per year thereafter until fully vested. Upon normal retirement age, 65 years old or the fifth anniversary of the first day of the Plan year in which participation in the Plan commenced, if later, death or disability, a participant becomes fully vested.

(f) Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive distributions equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, leave the funds in the Plan until retirement age, or transfer to a custodian of another qualified plan or individual retirement account. If the terminating employee's non-forfeitable account balance is less than \$5,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.

(g) Forfeited Accounts

Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to pay the Plan's expenses or to reduce amounts otherwise required to be contributed to the Plan. No forfeitures were used during the years ended December 31, 2024 and 2023. Available forfeitures were \$967 and \$0 at December 31, 2024 and 2023, respectively.

(h) Participant Loans

The Plan does not permit loans.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held at year end.

(d) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

(e) Payment of Benefits

Benefit payments are recorded when paid.

(f) Administrative Expenses

All administrative expenses are paid directly by the Company, except for investment fees, which are deducted from the net asset value of Plan investments and paid by participants.

(g) Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, which is the date that the financial statements were available to be issued.

(3) Plan Amendment and Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) Income Tax Status

The Plan is based on a prototype plan and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated March 31, 2014. This letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator and prototype sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(5) Withdrawing Participants

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

(6) Related Party Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

(7) Information Certified by the Plan's Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Ascensus LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investments purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(8) Fair Value Measurements

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at quoted market prices at year-end.

Money Market Funds: The Plan uses the market approach to measure the fair value of money market funds. The Plan is able to obtain actively traded quoted prices for these funds.

Cash Equivalents: Valued at cost

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
