Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Premier Medical Group, Inc. 401(k) / Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Premier Medical Group, Inc. 401(k) / Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Premier Medical Group, Inc., who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective April 1, 1997. Premier Medical Group, Inc. (the Company) is the plan sponsor.

Contributions

Eligible employees may contribute up to 100% of their pretax compensation or make nondeductible (after-tax) contributions, as defined by the Plan, not to exceed the maximum amounts allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan.

For each plan year, the Company shall contribute to the Plan on behalf of each participant who is eligible to share in matching contributions for the year a safe-harbor matching contribution equal to 3% of each participant's compensation. The Company may also contribute discretionary employer contributions as determined by the Company's Board of Directors. For the years ended 2024 and 2023, the Company made profit sharing contributions of \$1,526,378 and \$1,367,705, respectively, to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary and matching contribution and an allocation of Plan earnings (losses) and administrative expenses based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and the Company's safe-harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Payment of Benefits

Upon retirement, termination, disability or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take an in-service distribution upon reaching age 59 ½. Upon termination, automatic distributions are required for balances of less than \$5,000.

Automatic distributions made without the participant's consent are rolled into an individual retirement account designated by the Trustee. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 70 ½.

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$16,273 and \$10,488, respectively. Forfeitures attributable to non-vested employer matching contributions are used to reduce the contribution of the employer for the next plan year. Forfeitures attributable to discretionary employer contributions are used to reduce the employer contribution during the plan year in which such forfeitable event occurs. In 2024 and 2023, employer contributions were reduced by \$26,210 and \$10,195, respectively, from forfeited non-vested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Accounting Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through July 25, 2025, the date at which the financial statements were available to be issued, and has determined that there are no events that require adjustment to, or disclosure in, these financial statements.

NOTE 3 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4 – INCOME TAX STATUS

The Plan has adopted Newport Group, Inc. Volume Submitter 401(k) Profit Sharing Plan (VSPS Plan). The Internal Revenue Service has determined and informed Newport Group, Inc. by a letter dated November 30, 2020, that the plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The VSPS Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the determination letter, Plan management believes the Plan is designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company (the trustee of the Plan). This information has not been audited by the Plan’s independent auditors.

NOTE 7 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 7 - FAIR VALUE MEASUREMENTS (continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (held in pooled and self-directed accounts): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund held in the 401(k) account is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily net asset value and to transact at that price. The money market fund held by the 401(k) account is deemed to be actively traded.

Corporate & US stocks, foreign equities (held in self-directed accounts): Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Newport Trust Company is the Trustee of the Plan and as such, holds the Plan's assets. Newport Group, Inc. is the third party administrator of the Plan.

Mitchell, McLeod, Pugh & Williams, Inc. is the investment advisor to the Plan. The advisor is authorized to supervise and manage the Plan in accordance with the investment objectives set forth by the Plan sponsor. The advisor has full discretion with transactions involving the Plan's assets. The advisor's responsibilities also include advising individual participants regarding investment choices and objectives for their individual accounts. The advisor has fiduciary responsibility for investment advice for the Plan.

Raymond James and Waverly Advisors, LLC serve as investment advisors to certain self-directed participant brokerage accounts.

**NOTE 9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS
(continued)**

Direct payments to parties-in-interest in 2024 and 2023 were \$143,951 and \$134,330, respectively.

Certain administrative functions are performed by officers or employees of the plan sponsor. No such officer or employee receives compensation from the Plan.

NOTE 10 – ALLOCATED INSURANCE CONTRACT

An allocated insurance contract with a contract value of \$226,122 is held in a self-directed participant account. The allocated contract is a contract with an insurance company under which related payments to the insurance company are currently used to purchase a future benefit for an individual participant.

Under the allocated contract, the insurance company that issued the contract has unconditionally guaranteed, upon receipt of the required premiums, to provide a retirement benefit of a specified amount to the covered participant without adjustment for fluctuations in the market value of the underlying assets of the insurance company, and the participant has the legal right to such benefits, which is legally enforceable against the insurance company. Under such an allocated contract, the Plan has effectively transferred the risk for payment of benefits accrued to that date to the insurer and, accordingly, the value of the allocated contract is excluded from Plan assets.
