**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the RAND Engineering & Architecture, DPC 401(k) Plan (the "Plan") provides only general information. A more complete description is provided in the Plan agreement.

***General***

The Plan is a defined contribution profit sharing plan under Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers eligible employees of RAND Engineering & Architecture, DPC, the Plan sponsor (the "Company").

***Eligibility***

All employees age 21 and over, who are not interns or a member of a collective bargaining unit, are eligible to participate by making elective deferrals to the Plan.

Those eligible to make deferral contributions are also eligible to receive employer matching and profit sharing contributions after completing one year of service, which is defined as at least 1,000 hours of service commencing with their hire date. To receive a matching or profit sharing contribution, the individual must remain an employee on the last day of the plan year, unless they died, were disabled or reached normal retirement age, as defined.

***Contributions***

Eligible participants may make contributions to the Plan subject to certain federally imposed limits (\$23,000 in 2024 and \$22,500 in 2023) on either a pre-tax or post-tax (Roth) basis. Participants that are eligible to enter the Plan and do not opt out will be automatically enrolled in the Plan at a 3% deferral rate, with this automatic amount increasing 1% at the beginning of each plan year, up to a maximum rate of 20%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions subject to certain federally imposed limits (\$7,500 in 2024 and 2023). Rollover contributions from other qualified plans meeting certain conditions may be made.

The Company may make matching contributions to eligible participants at a rate determined each year by Company. The Company may also make a discretionary profit sharing contribution each year in an amount determined by the Company, which would be allocated to all participants based upon a specified formula. For the year ended December 31, 2024, the Company's total matching contribution to the Plan was \$127,001.

All contributions are participant-directed and held and invested by the custodian in accordance with the participant's investment allocation election amongst a list of investment options offered. The investment options offered by the Plan are Vanguard target retirement, index, money market, and other funds.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and Company contributions, as well as an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Allocations are based on participant earnings (or loss), account balances, or specific transactions, as defined by the Plan. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions, including rollovers, plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions is based on years of service. A participant is fully vested after 6 years of service in accordance with the following schedule:

***Payment of Benefits***

Upon normal retirement age, death, or disability, a participant will become 100% vested in their account. Upon termination, reaching normal retirement age, or reaching age 59 ½, as specified in the Plan, a participant is entitled to benefits equal to the vested value of his or her account.

***Plan Administration***

The Plan is administered by the Company. Ascensus Trust Company was the trustee of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2023.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to lesser of 50% of their vested account balances or \$50,000. The notes receivable from participants are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The interest rate on all outstanding notes receivable was between 4.25% and 9.50% at December 31, 2024 and 2023.

***Notes Receivable from Participants*** *(Continued)*

Repayments are made through payroll deductions over the term of the note or by the participant directly through their plan account. All notes are payable within a period of five years unless used for the purchase of a principal residence. A participant can only have two loans outstanding from the Plan.

***Forfeited Accounts***

Forfeitures of terminated participants' non-vested accounts may be used to reduce future employer contributions or to pay Plan administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts were \$5,580 and \$6,872, respectively. Forfeitures of non-vested participant accounts totaled \$5,516 and \$1,824 for the years ended December 31, 2024 and 2023, respectively.

***Hardship Distribution***

Participants may withdraw from the vested interest in their pre-tax or post-tax elective deferrals, matching contributions and profit sharing contributions to pay for a financial hardship caused by (1) eligible medical expenses incurred by the participant or his or her family; (2) the purchase of a principal residence; (3) post-secondary tuition and education expenses for the participant or his or her family; (4) payments needed to prevent eviction from a principal residence; (5) payments for funeral expenses for the participant's family; or (6) certain expenses for the repair of damage to the participant's principal residence. A hardship distribution cannot exceed the amount required to relieve the financial need, and the participants are not permitted to make any elective deferrals for six months after the date of receiving the distribution.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account, are included in administrative expenses, and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. No significant excess contributions were due to participants at December 31, 2024 and 2023.

***Payment of Benefits***

The Plan records benefit payments to withdrawing participants when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to the year end, and who had requested a distribution which was approved but not yet paid at period end, if any. There were no such unpaid distributions at December 31, 2024 and 2023.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Subsequent Events***

Subsequent events were evaluated through September 11, 2025, and there were no significant subsequent events to report.

**NOTE 3 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investments in securities are generally exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

***Basis of Fair Value Measurement***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

***Basis of Fair Value Measurement (Continued)***

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual and Money Market Funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables present by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. The investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

**NOTE 5 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, the parent of Ascensus Trust Company, the trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- 1) Investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits, as of December 31, 2024 and 2023;
- 2) Dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits, for the year ended December 31, 2024;
- 3) The Schedule of Assets (Held at End of Year) as of December 31, 2024 as shown in the supplemental schedule.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 6 - RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan has transactions with certain parties who have or may perform services or have fiduciary responsibilities to the Plan. Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan. The Plan issues loans to participants, which are secured by the balances in the participants' accounts. Also, investments were maintained with service providers of the Plan. The Company pays certain administrative and accounting fees of the Plan. These transactions qualify as party-in-interest transactions.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 8 - TAX STATUS**

In 2022, the Plan entered into a new adoption agreement, effective April 1, 2022, which did not change the significant Plan provisions. The Company adopted prototype plans of Ascensus. The Internal Revenue Service (IRS) issued an opinion dated June 30, 2020 stating that the form of the updated prototype plan is appropriate for use by employers for the benefit of their employees, and the IRS issued a similar opinion letter for the prior prototype plan in effect.

Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
