***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the financial statements of The Ridgeview Industries Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of assets available for benefits as of December 31, 2024, and the related statement of changes in assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Ridgeview Industries Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### ***Responsibilities of Management for the 2024 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Ridgeview Industries Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

#### **Note A – Description of Plan**

The following description of the Ridgeview Industries Retirement Savings Plan(Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of The Ridgeview Industries Retirement Savings Plan (the Plan's sponsor), who have completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 50 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan provides an automatic employee salary deferral contribution of 3 percent of an employee's eligible compensation. The automatic contribution begins immediately after a new participant meets eligibility requirements. The automatic contribution will increase 1 percent each year until it reaches a maximum of 6 percent.

For the year ended December 31, 2023 the Company is required to make matching contributions of 100 percent of the first 3 percent of the employees' compensation deferred, plus 50 percent of the next 3 percent of the employee's compensation deferred. Additional profit-sharing contributions may be made at the discretion of the Company's board of directors. There were no profit-sharing contributions during 2024 or 2023. Effective January 1, 2024, the Company amended the plan document to change the matching contribution percentage to 100 percent of the first 3 percent of the employee's compensation deferred, plus 50 percent in excess of the first 3 percent but not in excess of 5 percent in total of the employee's compensation deferred.

#### **Plan Operations**

The Company has appointed Empower Trust Company, LLC (Trustee) to serve as Trustee, and the Company to act as plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator is responsible for interpreting and communicating the provisions of the Plan, ensures that all government and participant reporting requirements are fulfilled. The Plan's fiduciary committee is responsible for oversight of the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Note A – Description of Plan (Continued)**

##### **Vesting**

Participants are immediately 100 percent vested in participant and company matching and profit-sharing contributions to the Plan.

##### **Loans to Participants**

The plan allows participants to borrow money from the Plan, not to exceed the lesser of one-half of the amount of the participants' vested accounts or \$50,000 reduced by the highest outstanding loan balance during the past 12 months or any existing loan balances on the date a new loan is made, whichever is greater. The loans are collateralized by the participants' vested accounts and bear interest at prevailing market rates, as determined by the plan administrator. Notes receivable must have a term of no longer than five years unless the purpose of the note is to acquire a principal residence.

##### **Payment of Benefits**

Withdrawals are generally not permitted before age 59½ except in the event of death, disability, or termination of employment or for reasons of proven financial hardship. Upon termination of service, a participant will receive his or her account balance in a lump-sum amount, installments, or an annuity. In the event of an employee's death, the entire account balance will be paid to the participant's named beneficiary.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

##### **Costs and Expenses**

Certain transaction fees and administrative expenses are paid by the Plan and are based on reasonable and customary rates.

##### **Forfeited Accounts**

Forfeited balances of terminated participants' nonvested accounts are used to pay plan administrative expenses or to offset employer matching contributions. The balance in the forfeiture account at December 31, 2024 and 2023 was insignificant. During the years ended December 31, 2024 and 2023 no forfeited non-vested accounts were used.

##### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Note B – Summary of Accounting Policies**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### **Investments and Income Recognition**

Investments are reported in the Plan's financial statements at fair value . Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### **Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 19, 2025, which is the date the financial statements were available to be issued.

#### **Note C – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying Statements of Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note C – Fair Value Measurements (Continued)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs use quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets,
- quoted prices for identical or similar assets and liabilities in markets that are not active,
- other inputs that are observable or can be corroborated by observable market data,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued based on quoted net asset values of the shares held by the Plan on the last business day of the Plan year.

*Common/collective trust funds (CCTs):* Valued at NAV based on the underlying securities, The NAV of each of the separate accounts is reported by the fund managers as of the financial statement date based on recent transaction prices and represents the price at which the Plan would be able to initiate a transaction.

#### **Note D – Information Certified by Trustee**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments and interest and dividends and interest income on notes receivable from participants for the year then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

#### **Note E – Risks and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Assets Available for Benefits.

#### ***Note F – Parties-In-Interest***

Certain plan assets are in investment funds managed by Empower Trust Company, LLC or its affiliates. Empower Trust Company, LLC is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$84,504 and \$70,660 for the years ended December 31, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

#### ***Note G – Plan Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination, net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

#### ***Note H – Tax Status***

The prototype plan used by the Plan obtained an opinion letter dated November 14, 2022, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not requested or received an individual determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
