INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Ruekert & Mielke, Inc. Profit Sharing/401(k) Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Ruekert & Mielke, Inc. Profit Sharing/401(k) Trust ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Ruekert & Mielke, Inc. Profit Sharing/401(k) Trust ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 1, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Ruekert & Mielke, Inc. is the plan sponsor, employer and the plan administrator. Effective January 1, 2025, Axiom Consultants, LLC became a participating employer of the plan. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust") is the plan trustee. Principal Trust also holds custody of the plan's investment assets, including insurance products made available through Principal Life Insurance Company, under a trust agreement between Principal Trust and Principal Life Insurance Company. The two Principal entities are collectively referred to as "Principal". Principal serves as the recordkeeper that maintains participant records, third party administrator that maintains plan documents, and tax counsel that performs various compliance tests. SageView Advisory Consulting Group is the plan's investment advisor.

Investments - The plan sponsor determines investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information.

At the end of each business day, Principal determines the fair value of the investments held and allocates the fair value of the investments to the participants. Earnings on investments bought, sold and held during the years are reflected in the accompanying statements of changes in net assets available for benefits.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily closing price as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trusts and pooled separate accounts - Valued at the NAV based on units of the common/collective trusts and pooled separate accounts and are direct filing entities. The NAV is generally based on the fair value of the underlying investments held by the common/collective trusts and pooled separate accounts less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the common/collective trusts and pooled separate accounts would sell the investment for an amount different than the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General - The plan was established December 10, 1962 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to participate in the plan once they have completed four months of service and have reached age twenty-one. An employee can enter the plan immediately following the date the plan's eligibility requirements are met.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their annual wages subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Newly eligible employees are automatically enrolled in the plan and have 5% of their compensation withheld as elective deferral contributions. These participants' deferral rates are increased annually on July 1 by 1%, until such deferral rate reaches a maximum of 10%. Participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions are made in conjunction with each payroll. The employer match was equal to 50% of the first 6% of employee compensation contributed to the plan as elective deferral contributions in 2024 and 2023.
- d. Nonelective contributions may be made at the employer's discretion. There were no such nonelective contributions in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral, rollover and employer contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral, rollover contributions and related earnings. Participants begin vesting in their employer contributions and related earnings upon two full years of service, at which time they are 20% vested. The participant then vests at the rate of 20% each year thereafter. Upon death, disability or attainment of normal retirement age (defined as age 65) or early retirement age (defined as age 60 with 5 years of vesting service) while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon death, disability, attainment of normal or early retirement age or termination of employment. Distributions are generally made in the form of a single lump sum or an annuity. Hardship withdrawals are permitted under certain circumstances. In-service withdrawals can commence upon attaining the age of 59½.

Forfeitures - Forfeited nonvested accounts are used to pay plan fees or reduce the amount of the employer contributions. Forfeitures used to reduce employer contributions were \$31,000 in 2024 and \$12,000 in 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and 2023.

Administrative expenses - Certain administrative fees of the plan are paid by the employer. Certain other fees are paid by the plan using plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan fees and nonparticipant directed charges for service and administration fees. Nonparticipant directed fees are allocated to participants on an account value basis.

Notes receivable from participants - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Prior to January 1, 2025, participants could not have had more than five loans outstanding at any given time. Effective January 1, 2025, participants may not have more than three loans outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had various repayment schedules through December 2028 with interest rates from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

4. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Principal. Principal holds custody of plan investment assets and executes investment transactions and, therefore, these transactions qualify as party-in-interest transactions.

The plan has an administrative service agreement with Principal in which Principal provides certain administrative services to the plan. Principal receives revenue from mutual fund providers for services Principal provides to the funds. The revenue is used to offset certain amounts that would have otherwise been owed to Principal for its administrative services to the plan. The plan pays Principal direct for certain other service fees that are not covered by the revenue sharing provisions per the administrative service agreement. Direct fees paid were \$70,000 in 2024 and \$60,000 in 2023.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

5. INCOME TAX STATUS

The plan is operating under a Principal Financial Group Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which received a favorable opinion letter on June 30, 2020. The opinion letter received from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) if the plan has taken any uncertain positions that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for uncertain positions taken and determined that the plan was not required to recognize any tax liabilities (or assets) related to uncertain positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

Management has obtained certifications from Principal, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- b. Dividends from investments, net appreciation (depreciation) in fair value of investments and interest on notes receivable from participants during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.
