We have performed audits of the accompanying financial statements of FMRS Health Systems, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 – Plan Description

The following description of FMRS Health Systems, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established January 1, 2006, covering substantially all employees of FMRS Health Systems, Inc. (the “Company”), who have attained age eighteen and who are not waiver respite providers, waiver family providers, contract physicians, or non-resident aliens who do not receive any earned income which constitutes United States source income. Employees who meet these eligibility requirements may participate in the Plan on the first day of January or July immediately following their hire date. The Plan is sponsored and administered by FMRS Health Systems, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants contribute to the Plan through voluntary payroll deductions. Participants may elect to defer up to 100% of their pretax compensation up to an amount not to exceed the *Internal Revenue Service (IRS)* limitation on net contributions. Eligible participants who have attained age 50 on or before the close of the Plan year may make catch-up contributions, subject to the limitations of the Internal Revenue Code (*IRC*). Participants may also contribute amounts representing rollover distributions from other qualified benefit plans. The Company contributes to a participant’s account an amount equal to 100% of the participant’s elective contributions, subject to a limit of 3% of the participant’s total compensation. The Company also makes a profit-sharing contribution of 4% of compensation for all qualifying participants.

Vesting

Participants are always fully vested in their account balance derived from participant contributions and rollovers, adjusted for investment experience. Vesting in the Company’s contribution portion of participants’ accounts is based on years of credited service. Participants vest 20% per year after two years of service and are 100% vested after six years. In addition, upon death, disability, early, normal, or late retirement, participants become fully vested in employer contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching and any additional contributions, and an allocation of the Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

The Plan permits each participant to direct the investment of his or her account balance under the Plan to a variety of investment funds selected by the Company. The Trustee of the Plan invests each participant’s account balance under the Plan in accordance with the participant’s direction.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant can elect to transfer their vested interest in the Plan to a qualified plan of a new employer, rollover their funds into an Individual Retirement Account, or receive their vested interest in the Plan in a lump-sum amount.

Administrative Costs

Administrative expenses are paid by the Plan or the Company on a discretionary basis. The majority of these expenses were paid by the Plan during 2024.

Note 2 – Significant Accounting Policies

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested balances totaled \$44,628 and \$112,352, respectively. Forfeited balances may be used to pay Plan administrative expenses or reduce employer contributions. Forfeitures used to reduce employer contributions were \$135,245 in 2024.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably

possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through September 22, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 2 Fair Value Measurements

The fair value of the collective investment trust is based on the market value of its underlying investments and contains synthetic investment contracts comprised of both underlying investments and contractual components. Observable inputs for the collective investment trust include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The collective investment trust invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 4 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Fees paid by the Plan to the Trustee for investment management services are considered related party transactions and amounted to \$48,372 for the year ended December 31, 2024.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 – Tax Status

Effective March 1, 2021, and in conjunction with the change in Trustee, the Plan adopted a non-standardized prototype plan sponsored by Ascensus Trust Company. The prototype plan received an Internal Revenue Service opinion letter dated June 30, 2020, stating the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
