Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of the Plan

The following description of The Prudential Retiree Welfare Benefits Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Descriptions for the specific benefit programs (e.g., medical, dental, vision, etc.) and Plan documents for a complete description of the Plan’s provisions.

General

The Plan generally provides health benefits to eligible retired employees and full-time life insurance salespersons of The Prudential Insurance Company of America (the “Company”) and its participating affiliates, other than employees excluded pursuant to collective bargaining agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Benefits

The Plan provides health benefits (medical, dental and vision) to participants and covered dependents. Generally, retired employees are eligible for health benefits if they retire at or after age 55 and have at least 10 years of vesting service or otherwise meet the eligibility requirements for retirement status under The Prudential Merged Retirement Plan (the “Retirement Plan”). Benefits may be provided by insurance contracts, some of which may be underwritten by the Company, depending on the specific coverage. The Plan also provides a Retiree Medical Savings Account (“RMSA”) and a PruCredit Account, which are record keeping accounts. Eligible retired employees may generally use the RMSA and PruCredit Account for reimbursement for the cost of premiums for certain medical, dental, vision and prescription drug coverage.

The RMSA is closed to the participation of new employees and rehired employees with forfeited or exhausted RMSAs. Interest credit allocations previously ceased, a time limit was previously established to use the allocations in the RMSA, and types of expenses eligible for reimbursement under the RMSA were previously expanded.

Contributions

The contributions required to provide benefits may be made wholly by the Company, wholly by the participant or by both the Company and the participant, based on the particular eligible coverage. Participants may contribute specified amounts to extend coverage to eligible dependents. The amounts are determined by the Company.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

The costs of the postretirement benefits are shared by the employer and retirees. In addition to deductibles, co-pays, and coinsurance for benefits, participants (where applicable) pay monthly contributions into the Plan. Contributions, as an estimated percentage of total medical benefits paid, made by retirees during the years ended 2024 and 2023 were as follows:

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles in the United States

of America ("U.S. GAAP"). The modified cash basis of accounting is a cash receipt and disbursement method of accounting unlike U.S. GAAP where information is reported on an accrual basis. However, under the modified basis of accounting investments are stated at their respective fair value or contract value, which is consistent with U.S. GAAP.

Use of Estimates

The preparation of financial statements in accordance with a modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the variable life insurance policies, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The Plan invests in group and individual variable life insurance policies issued by Pruco Life Insurance Company ("Pruco Life"), a wholly-owned life insurance subsidiary of the Company, and Pruco Life Insurance Company of New Jersey, a wholly-owned subsidiary of Pruco Life. These investments are carried at their cash surrender value (contract value), which approximates the fair market value of the underlying assets held by insurance company separate accounts for group policies and registered investment companies for individual policies.

Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments made to or for participants are recorded when paid.

Administrative Expenses

Expenses are the obligation of the Plan and are recorded when paid. The Company, without obligation to do so in the future, may pay selected expenses of the Plan. Expenses paid directly by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Recently Issued Accounting Pronouncements

Changes to U.S. GAAP are established by the Financial Accounting Standards Board ("FASB") in the form of Accounting Standards Updates ("ASU") to the FASB Accounting Standards Codification ("ASC"). The Plan considers the applicability and impact of all ASU. All ASU were assessed and determined to be not applicable or not material to the Plan.

Subsequent Events

The Plan administrator has evaluated events subsequent to December 31, 2024 and through September 22, 2025, the date the financial statements were available to be issued, and determined that there have not been any events that occurred that require adjustments to these financial statements and there were no events or transactions that require disclosure.

3. Postretirement Benefits

The amount reported as the postretirement benefit obligation represent the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after the employees' retirement from service with the Company and participating affiliates. The postretirement benefit obligation represents the amount that is to be funded by contributions from the employer and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The Pri-2012 white collar adjusted base mortality table, adjusted for Company specific experience and projected in the future with a generational improvement scale, was used for both December 31, 2024 and 2023.

The health care cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. Increasing the assumed rates by one percentage point in each year would increase the postretirement benefit obligation as of December 31, 2024 and 2023 by \$21,926,927 and \$20,987,534, respectively. Decreasing the assumed rates by one percentage point in each year would decrease the postretirement benefit obligation as of December 31, 2024 and 2023 by (\$20,177,102) and (\$19,286,586), respectively.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

4. Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the years ended December 31, 2024 and 2023, was

obtained by management and agreed to or derived from information certified as complete and accurate by the Company and the Prudential Trust Company, the trustees of the Plan.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (“Level 1” measurements) and the lowest priority to unobservable inputs (“Level 3” measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The methods described below may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies - are mutual funds registered with the Securities and Exchange Commission. The investments held by the Plan are deemed to be actively traded and the mutual funds are required to publish their daily net asset values ("NAV") and to transact at that price. The Plan values these investments at the closing price reported by the registered investment companies on the reporting date.

Common Trusts - The Plan values these investments at unit value, which is based on the aggregate fair value of the underlying assets (primarily equity securities and bonds) in relation to the total number of units outstanding. The unit value represents the price at which the plan-directed transactions are effected. Unit value is the equivalent of NAV, which is a practical expedient for estimating the fair value of these investments.

As of December 31, 2024 and 2023, there were no unfunded commitments and the redemption frequency was daily on these investment options. The investor-level redemption restrictions for common trusts is withdrawals may be limited to less than the greater of 5% of total account assets or \$2 million.

6. Tax Status

As of December 31, 2024 and 2023, the Plan held 100% of the net assets available for benefits in the following trusts, which were established under the Plan documents:

- a. **The Prudential Welfare Benefits Trust for Union Employees** was established to fund medical and other welfare benefits for eligible union employees, retirees, totally disabled employees, dependents, and surviving dependents and applicable expenses of the Plan and trust. The trust received an exemption letter dated March 15, 2001, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC").
- b. **The Prudential Retiree Health Benefits Trust** was established to fund post-retirement health benefits and other welfare benefits as Prudential may designate through use of such trust for eligible retirees, dependents, and surviving dependents and applicable expenses of the Plan and trust. The trust received an exemption letter dated June 3, 2004, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC.

As a result of the Plan's funding policy, from time to time the trusts may be subject to income taxes. Unrelated business income tax of \$650,000 and \$665,000 was recorded in 2024 and 2023, respectively and is included in administrative expenses in the Statements of Changes in Net Assets Available for Benefits. In addition, the Plan and the trusts are required to operate in conformity with the IRC to maintain the tax-

exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trusts are tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party Transactions

The Prudential Insurance Company of America (or an affiliate) acts as the investment manager for some of the Plan's investments. To the extent a party-in-interest is involved, the transactions in these investments qualify as exempt party-in-interest transactions under ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
