The following description of the Gerbers Poultry, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which began March 1, 1984, is a defined contribution plan covering all employees of Gerbers Poultry, Inc. (“Company”) who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In 2024, the Plan’s name was updated to reflect the most recent adoption agreement.

Eligibility:

Effective September 1, 2024, all employees of the Company age eighteen and older who are employed for one year are eligible to participate in the Plan. Prior to September 1, 2024, all employees of the Company age twenty-one and older who were employed for one year were eligible to participate in the Plan. Part-time, temporary, or seasonal employees who complete a year of service as defined by the Plan (at least 1,000 hours within a twelve-month period) are also eligible to participate.

Contributions:

Employee Contributions - Participants may elect to defer up to 90% of their compensation within statutory limits. The Plan also allows for Roth deferrals. In addition, eligible participants who are at least age 50 may elect to defer additional amounts in the form of catch-up contributions.

Employer Matching Contributions - The Plan utilizes safe-harbor matching contributions. Therefore, all eligible participants will receive a match of 100% of the first 3% of elective deferrals plus 50% of elective deferrals that exceed 2% up to a maximum of 4% of the employee's compensation.

Employer Discretionary Contributions - The Company may make discretionary contributions to the Plan. The contributions are allocated based on the participant’s compensation to total compensation. No discretionary contributions were made in 2024 and 2023.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, and earnings and losses thereon.

Vesting:

All participants are 100% vested in elective deferrals, company safe harbor matching, qualified non-elective contributions, and rollover contributions made to the Plan.

Vesting in Company discretionary contributions is based on years of service. A participant is vested as follows:

Years of Service	Vested %
1	20%
2	40%
3	60%
4	80%
5	100%

Forfeitures:

Forfeitures will be used first to pay administrative fees and then used to reduce future employer contributions. Forfeiture balances were \$1,918 and \$1,824 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans must be for a minimum of \$1,000 and are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Participants are allowed only one loan outstanding at any point in time.

The loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement. The loans are secured by the balance in the participant's account and bear interest at rates established by the Trustee. Principal and interest are paid ratably through payroll deductions.

Other Plan Provisions:

Normal retirement age is 65 years of age, with an allowance for early retirement at age 59 ½.

Payment of Benefits:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant may receive a lump sum amount equal to the value of his or her account. Benefits are recorded when paid.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the modified cash basis of accounting, which differs from accounting principles generally accepted in the United States of America. Benefit payments and administrative expenses are recognized when paid. Contributions and interest/dividend income are recognized when received rather than when earned.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Asset management and withdrawal fees are paid by the Plan. All other administrative fees are paid directly by the Company.

2 Summary of Significant Accounting Policies, Continued

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Risks and Uncertainties:

The Plan's assets include investments in mutual funds and a money market fund with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 19, 2025, which is the date the financial statements were available to be issued.

3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets
- * Quoted prices for identical or similar assets or liabilities in inactive markets
- * Inputs other than quoted prices that are observable for the asset or liability
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

3 Fair Value Measurements, Continued

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund:

The money market fund is structured as an open-ended investment company and its fair value is based on amortized cost which seeks a stable \$1.00 net asset value. The money market fund is classified in Level 2 of the valuation hierarchy.

The fund invests in cash, short-term debt instruments issued by the U.S. government or its agencies and instrumentalities, and repurchase agreements collateralized by such instruments in order to provide current income consistent with stability of principal.

Security transactions are accounted for on the date securities are bought or sold. There were no unfunded commitments as of December 31, 2024 and 2023.

Mutual Funds:

The fair values of the mutual funds are based on quoted market prices in active markets and are classified in Level 1 of the valuation hierarchy.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

4 Tax Status

The Plan adopted a prototype plan from Empower Trust Company. On November 14, 2022, the Internal Revenue Service stated that the Empower Trust Company prototype plan, as then designed, followed the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.
