Management, having determined it is permissible in the circumstances, has elected to have the audits of Randolph-Brooks Federal Credit Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Randolph-Brooks Federal Credit Union 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Randolph-Brooks Federal Credit Union 401(k) Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1. Description of the Plan**

The following description of Randolph-Brooks Federal Credit Union 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined-contribution plan sponsored by Randolph-Brooks Federal Credit Union (Credit Union), and other related employers who are participating companies, for the benefit of its employees who are at least 18 years of age at prescribed entry dates. There are 8 participating employers in addition to the Plan Sponsor. Effective April 1, 2023, RBFCU Assets, LLC became a participating employer in the Plan, resulting in a total of 9 participating employers in addition to the Plan Sponsor. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and also serves as Plan custodian.

***Contributions***

The Plan permits eligible employees, through a salary deferral election to have the Credit Union make annual contributions of up to 80 percent of eligible compensation (not to exceed certain limits as described in the Plan Document). The Plan also offers a Roth in Plan conversion feature. Employee rollover contributions from other qualified plans are also permitted. Participants age 50 or older by December 31 are eligible to contribute additional "catch-up" contributions up to the limits prescribed by the Internal Revenue Service (IRS).

The Credit Union made contributions for all employees of all participating employers, other than Kuper Realty Holding Company (Kuper), up to 200 percent of the first 4 percent of employee Roth or pre-tax contributions and 100 percent of the next 2 percent of employee Roth or pre-tax contributions. Kuper, a participating employer, made contributions up to 50 percent of the first 6 percent of employee Roth or pre-tax contributions. The employer match is calculated at the end of each pay period. Participant and employer contributions are subject to the provisions of the Internal Revenue Code (IRC) and related regulations. At the direction of the Credit Union's board of directors, the employer may make additional discretionary contributions. Discretionary contributions are allocated, based on compensation, to the accounts of eligible participants as defined by the Plan.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 6 percent of eligible compensation unless the participant made an affirmative election otherwise. Employer contributions to the Plan are invested at the discretion of the participant. Contributions are initially placed in a life cycle fund corresponding to the participant's age, if not elected otherwise by participant.

***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Credit Union's contribution and Plan earnings. Allocations are based on a participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollover contributions from other qualified plans can be added to the Plan by eligible participants.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of employer contributions and any earnings thereon is based on years of service as follows:

<b><u>Years of Service</u></b>	<b><u>Percentage</u></b>
Less than one year	0%
One year	20%
Two years	40%
Three years	60%
Four years	80%
Five years	100%

Additionally, an active participant becomes 100 percent vested upon death, disability or upon reaching normal retirement age.

Any nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Credit Union contributions or for Plan administrative fees.

***Payment of Benefits***

Participants (or their beneficiary, if applicable) are entitled to receive benefit payments at the normal retirement age of 59½ or upon their death or disability in the form of a lump-sum in cash. Distributions are made in the event of termination of employment with the employer for any reason and participants are entitled to the vested portion of their account. The Plan allows for automatic distribution if a participant’s vested balance is less than \$5,000. If the participant’s account is less than \$1,000, the balance will be distributed in the form of a cash payment. If the participant’s vested balance is greater than \$1,000 but less than \$5,000, the balance will be distributed in the form of a direct rollover to an individual retirement account designated by the Plan Administrator (if not otherwise directed by the participant). If the participant’s vested balance is greater than \$5,000 then a distribution can be made at the election of the participant. The Plan also allows for hardship withdrawals.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Participants may not have more than one loan outstanding at any time. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant’s loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant’s vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence, in which case the period cannot exceed ten years) through payroll withholdings and additional payments made outside of payroll. In addition, terminated participants are able to continue to make payments until the loan has been paid in full. Interest on the loans is at a fixed rate and is based on local prevailing rates as determined by the Plan Administrator.

Effective June 24, 2024, the Plan was amended to include a waiting period of 15 days after paying off a prior loan to apply for a new loan.

***Forfeited Accounts***

At December 31, 2024 and 2023, unallocated, forfeited nonvested accounts totaled approximately \$222,000 and \$75,000, respectively. The balance of forfeited contributions and any related earnings will be used to reduce administrative expenses of the Plan and future employer contributions. Approximately \$958,000 and \$778,000 of forfeitures were used during the years ended December 31, 2024 and 2023, respectively.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Quoted market prices, if available, are used to value investments. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. The Plan's interest in the collective trusts are valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

### ***Notes Receivable From Participants***

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants that are deemed delinquent by the Plan Administrator are reclassified as distributions based upon the terms of the Plan Document.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the employer or the Plan, at the employer's discretion.

### ***Transfers Between Fair Value Hierarchy Levels***

Transfers in and out of Level 1 (quoted market prices), Level 2 (other significant observable inputs) and Level 3 (significant unobservable inputs) are recognized on the actual transfer date. There were no transfers between fair value hierarchy levels for the years ended December 31, 2024 and 2023.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Assets and Liabilities**

ASC Topic 820, *Fair Value Measurements*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Topic 820 also specifies a fair value hierarchy which requires a plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds representing registered investment funds which are valued at the NAV of shares held by the Plan at year-end. Level 1 securities also include participant-directed BrokerageLink accounts, comprised primarily of common stock and mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows.

In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities.

**Investments Measured Using the Net Asset Value (NAV) per Share Practical Expedient**

The following tables summarize investments for which fair value is measured using NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. Subsequent to December 31, 2024, the Plan initiated and completed a full redemption in an orderly business manner.

**Note 5. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Plan invests in certain funds of the Plan trustee. The Plan paid approximately \$60,000 and \$48,000 in administrative fees to Fidelity Management Trust Company during 2024 and 2023, respectively. The Plan received approximately \$67,000 and \$62,000 of advisory fee rebates during 2024 and 2023, respectively, and offset administrative expenses. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The net reimbursement amount is reflected as Revenue-sharing reimbursements (net of administrative expenses) in the statement of changes in net assets available for benefits. The Credit Union provides certain administrative services at no cost to the Plan.

**Note 6. Plan Termination**

Although it has not expressed an intention to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested an individual determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.
