We have performed an audit of the financial statements of the Action Gypsum Supply, LP 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

### **Note 1 - Description of the Plan**

The following description of the Action Gypsum Supply, LP 401(k) Plan (the Plan) is provided for general information purposes only and is as of December 31, 2024 unless otherwise noted. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Action Gypsum Supply, LP (the Company or Employer), and related employers Action PR Resources, LLC and Action Gypsum Supply West, LP. The Plan commenced effective January 1, 2007, and was amended and restated effective May 1, 2021, to comply with the latest rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### Administration

The Plan Sponsor and named Plan Administrator is Action Gypsum Supply, LP. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and fees, and reports to the Plan's Trustee. The Plan's Trustee and Custodian is Ascensus Trust Company (Ascensus or the Custodian). The Custodian maintains custody of all investments held by the Plan and executes all of the Plan's transactions. An employee of the Company also serves as a Plan Trustee whose responsibility is limited to ensuring the timely collection and deposit of contributions. The Company retained Ascensus, LLC, an agent for Ascensus Trust Company, to provide participant recordkeeping and administration services.

#### Eligibility

Employees of the Company are eligible to participate in the Plan upon completion of three months of service, provided they are age 18 or older, and are not a nonresident alien, leased employee, or covered by a collective bargaining agreement. Eligible employees are permitted to enter the Plan upon the first day of each month coincident with, or next following, satisfaction of the eligibility requirement.

#### Participant Contributions

Participant contributions may be in the form of pre-tax or Roth elective deferrals, up to 96% of their eligible compensation as defined by the Plan. An employee can only contribute on a percentage of compensation basis each pay period. Participant contributions are subject to the Internal Revenue Code (IRC) annual deferral limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan may also accept rollover contributions of retirement benefits that originate from another qualified retirement plan or from pre-tax portions of IRA accounts.

#### Employer Contributions

The Plan provides for safe harbor Employer matching contributions equal to 100% of the first 3% of the participant's eligible compensation, plus 50% of participant's contributions between 3% and 5% of eligible compensation that a participant contributes to the Plan. The total safe harbor Employer matching contribution was \$817,634 for the year ended December 31, 2024.

The Plan also provides for discretionary profit-sharing contributions. The Employer did not make any profit-sharing contributions during the year ended December 31, 2024.

Employer contributions are subject to the limits established annually per the IRC.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and employer's contributions as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions and safe harbor Employer matching contributions plus actual earnings thereon.

Participants vest over a six year graded schedule in their Employer discretionary profit-sharing contributions plus actual earnings thereon, whereby a participant becomes 20% vested after two years of service then an additional 20% vesting is earned each year thereafter.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The maximum number of loans outstanding at any one time is limited to one. The maximum term of a loan is five years. The loan interest rate is set at 1% above Prime rate, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

#### Benefit Payments

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant may elect to receive a lump sum amount equal to the value of the participant's vested balance. Required minimum distributions are made in accordance with IRS requirements. Effective January 1, 2024, distributions to a terminated employee with a vested account balance equal to or less than \$7,000 are made as a lump sum distribution as soon as administratively possible following the participant's termination of employment. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. Prior to January 1, 2024, this automatic distribution threshold was \$5,000. If the vested account balance is less than or equal to \$1,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

### Note 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan agreement.

#### Payment of Benefits

Benefits are recorded when distributed.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable to participants and fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Fees and expenses relating to the day-to-day Plan operations are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

#### Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 16, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Unaudited Information Certified by Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Ascensus Trust Company as to its completeness and accuracy and was not subject to any auditing procedures performed by the Plan's independent auditor:

- Investments and notes receivable from participants reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023 and notes to financial statements;
- Investment interest and dividend income, net appreciation in fair value of investments, and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the fair value hierarchy.

*Common/Collective Trust Funds:* The fair values of the T. Rowe Price Funds and the Morley Capital Stable Value Fund are determined by the NAV provided by the fund administrators. NAV is used as a practical expedient to estimate fair value. Although the NAV unit prices are quoted on a private market that is not active, the unit prices are based on underlying investments that are traded on an active market (market approach). There are also no restrictions on the NAV price or its equivalent. Participant transactions may occur daily, there are no unfunded commitments, and redemption frequency is immediate. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Interest-bearing Cash:* Valued at cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 - Related Party and Party-in-Interest Transactions**

For the year ended December 31, 2024, the Plan paid fees to Ascensus, LLC of \$47,121 for custodial services and plan recordkeeping. During the year ended December 31, 2024, the Plan paid fees to OneDigital Investment Advisors of \$24,485 for investment advisory services. The Plan earns sub-transfer agency fees from select funds, which are used to pay fees of the Plan. Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all their employer contributions.

**Note 7 - Tax Status**

The Plan is utilizing a non-standardized pre-approved plan document sponsored Ascensus LLC (the non-standardized plan). The non-standardized plan has been filed with the IRS and has received a favorable opinion letter dated June 30, 2020. The Plan Sponsor has elected not to apply for an individual IRS Determination Letter upon adoption of the Plan nor on any subsequent amendments. Although the Plan has been amended since receipt of the favorable opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified under Section 401(a) and that the related trust is tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Written amendments to the plan document to reflect SECURE Act 2.0 operational changes will be executed at a later date in accordance with deadlines pursuant to applicable laws and IRS guidance.

**Note 8 - Risks and Uncertainties**

The Plan invests in investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
