### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Preferred Companies 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.



#### (1) Description of Plan

The following description of the Preferred Companies 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more detailed description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all full-time employees who have completed one month of service and are age 21 or older of Preferred Proppants LLC (the Sponsoring Employer) and its participating employers (the Controlled Group and collectively, the Company). Effective January 1, 2024, the Plan was amended to cover all full-time employees who have completed 90 days of continuous employment and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors of the Company is responsible for oversight of the Plan. The Plan's advisor, LPL Financial LLC, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustees.

##### ***Contributions***

Participants may contribute up to 100% of pre-tax annual eligible compensation as defined in the Plan, subject to annual IRS limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may designate all or part of their contribution as Roth contributions and may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Unless an eligible employee requests not to participate in the Plan, all eligible employees are automatically enrolled in the Plan with 2% of their annual cash compensation being contributed to a target date registered investment company. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for a discretionary matching contribution which is determined by the Sponsoring Employer's Board of Directors. For the years ended December 31, 2024 and 2023, the Company elected to match 100% of the first 5% of eligible compensation that a participant contributed to the Plan, with an individual maximum of \$5,000. Contributions are subject to certain limitations.

Effective January 1, 2024, the Company makes safe harbor matching contributions to the Plan equal to 100% up to 5% of eligible compensation that participants contribute to the Plan.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are vested immediately in their contributions as well as safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and any resultant earnings is based on years of continuous service. A participant becomes fully vested after five years of credited service on a graded vesting schedule. However, a participant shall also become fully vested immediately upon death or permanent disability or attaining the normal retirement age of 65. Normal vesting in the Plan is as follows:

##### *Notes Receivable Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. The participant may have no more than two loans outstanding at one time. The loans are secured by the balance in the participants' accounts and bear annual interest. Rates on outstanding loans as of December 31, 2024 ranged between 4.25% and 9.50%, which are commensurate with local prevailing rates determined by the plan administrator. Principal and interest are paid ratably through payroll deductions not to exceed a five-year period, except for loans for the purchase of a principal residence, which may be repaid over a reasonable period of time that may be longer than five years. If any scheduled loan repayment is not made by the end of the calendar quarter after the calendar quarter in which a payment is first delinquent, the loan will be in default.

##### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. The Plan permits in-service withdrawals upon attaining age 59½ (pre-retirement), age 50 (pre-retirement) (employer matching and nonelective contributions only), or as a result of a financial hardship as defined in the Plan. Participant account balances in excess of \$5,000 require participant authorization for distribution. Participant account balances of \$5,000 or less are automatically distributed in one lump-sum.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,797 and \$37,181, respectively. These accounts may be used to pay future administrative expenses of the Plan and to reduce future employer contributions. During 2024, forfeitures of \$82,628 were used to reduce Company contributions.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the Plan.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by their investment advisors and plan trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Contributions*

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

##### *Payment of Benefits*

Benefit payments are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

##### *Expenses, Continued*

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower), the custodians of the Plan, may receive revenue sharing payments from registered investment companies and fixed annuity investments in which the Plan invests. The Plan document provides to the extent revenue sharing payments are received by the custodian or insurance company, a Plan account will be established to receive these amounts which are to be used to pay administrative expenses. If such amounts remain after the payment of administrative expenses, the plan administrator is to allocate such amounts to participants as additional earnings of the Plan. The amount has been recorded as a reduction to Plan expenses in the financial statements.

##### *Subsequent Events*

The Plan has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by Qualified Institutions

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (Empower Insurance) and Empower Trust Company, LLC, qualified institutions.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of cash, registered investment companies, and common stocks that are valued at the basis of readily determinable market prices. Common stocks are valued at the closing price reported on the active market in which the individual securities are traded.

#### (5) Fixed Annuity Contract

In 2015, the Plan entered into a traditional fully benefit-responsive fixed annuity contract with Great-West Life & Annuity Insurance Company (Great-West Insurance). Great-West Insurance was subsequently acquired by Empower Insurance, and Empower Insurance maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the amount stated in the contract. The crediting rate is reviewed on a quarterly basis for resetting. The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with Plan participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### **(6) Related Party Transactions and Party-In-Interest Transactions**

A party-in-interest is defined under Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA as any fiduciary of the Plan, any party rendering services to the Plan, the employer, certain participants, and others. Certain Plan investments are fixed annuity contracts which are managed by Empower Insurance. The Plan's assets, which consist primarily of investments, are held by the custodian of the Plan. Empower is the custodian of the Plan and, therefore, the fixed annuity and participant loan transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

#### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their account balances.

#### **(8) Income Taxes**

The Plan adopted a pre-approved plan, which received an opinion letter from the IRS dated June 30, 2020 which stated that the Company may rely on the opinion letter with respect to the qualification of the Plan under IRC Section 401(a) except as stated below, and also informed the Company that the Company will not receive its own determination letter upon adoption of the pre-approved plan. Although the Plan has been amended since the pre-approved plan received the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
