## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator  
Harmon Law Offices, P.C. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Harmon Law Offices, P.C. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. DESCRIPTION OF PLAN**

The following description of Harmon Law Offices, P.C. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General –**

The Plan is a defined contribution plan covering substantially all employees of Harmon Law Offices, P.C. (the Company), and its affiliates, Northeast Abstract Company, Inc. and Commonwealth Auction Associations, Inc., as defined in the Plan agreement, who have completed six consecutive months of service since their date of employment, defined as 500 hours of service. Upon satisfying those requirements, employees become eligible to participate in the Plan beginning on January 1 or July 1 of each year. Effective April 15, 2024, the Plan was amended to remove the service requirement making all employees immediately eligible to participate in the Plan. As part of the amendment, the entry dates were also removed to allow participants to enter the Plan as soon as they are eligible. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

**Contributions –**

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan agreement, subject to the maximum amount allowed by the Code. Both pre-tax and Roth contributions are permitted under the Plan. The Plan includes an automatic enrollment provision, whereby any participant who does not make an affirmative election to participate in the Plan will be enrolled in the Plan at an annual deferral rate of 4%. Effective April 15, 2024, the Plan was amended to update the automatic enrollment rate to 5%. For those participants, the Plan provides for an automatic escalation clause on the first day of each Plan year of 1% up to a maximum of 10% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions to eligible participants at the discretion of the Board of Directors. To be eligible for a matching contribution, the participant must complete at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year. For the Plan years ended December 31, 2024 and 2023, the Company made no discretionary matching contributions.

**Participant Accounts –**

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting –**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions portion of their accounts is based on years of continuous service, as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

**Notes Receivable from Participants –**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are required to be repaid within five years unless the loan is to be used for the purchase of a primary residence in which case the note may be repaid within a period of no more than ten years. Participants may only have one outstanding loan at any time. The loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits –**

Upon termination of service, retirement, disability or death, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. Partial or installment payments are permitted to satisfy required minimum distribution rules. A participant may withdraw from their rollover account at any time. A participant may also request an in-service withdrawal of all or any portion of their vested account balance upon attainment of age 59 ½. If a participant's account balance is greater than \$1,000 but equal to or less than \$7,000, (increased from \$5,000 effective January 1, 2024 under the SECURE 2.0 Act) the plan administrator can automatically rollover your entire vested account balance into a traditional individual retirement account (IRA). If a participant's account balance is less than \$1,000, the plan administrator can distribute the entire balance in a lump sum amount.

Hardship withdrawals are available from a participant's vested account balance, with a minimum amount of \$500, in order to meet a participant's immediate and heavy financial need, as defined in the Plan document.

**Forfeitures –**

At December 31, 2024 and 2023, the Plan had forfeited nonvested accounts totaling \$520 and \$1,429, respectively. These accounts are used to reduce future Company contributions or pay Plan expenses. For the Plan years ended December 31, 2024 and 2023, \$950 and \$2,121 of forfeitures were used to reduce Company contributions or pay Plan expenses, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting –**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates –**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition –**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants –**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants, if applicable, are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits –**

Benefits are recorded when paid.

**Administrative Expenses –**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Date of Management's Review –**

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:*

Valued daily based upon the units of such pooled separate accounts held by the Plan at year end multiplied by the respective accumulation unit value (AUV). The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund, the fund's dividends and the contract's separate account charges. The NAV is a readily determinable fair value of the underlying assets and is the basis for current transactions.

**4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company. Amounts allocated to the Voya Fixed Account are held in the insurance company's general account, and there are no segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against Voya Retirement Insurance and Annuity Company on the Plan's behalf. The crediting interest rate is set by Voya Retirement Insurance and Annuity Company but may not be less than 1% annually. At December 31, 2024 and 2023, the crediting interest rate was 1.60%. The crediting rate is declared in advance and is reset quarterly. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the full faith and credit of Voya Retirement Insurance and Annuity Company.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measure attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, less participant withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (Continued)**

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Company may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**5. INFORMATION PREPARED AND CERTIFIED BY PLAN'S CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**7. TAX STATUS**

The Plan has adopted a volume submitter profit sharing plan and relies on the volume submitter plan sponsor's favorable opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all Company contributions.

**9. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.



