### Note A – Description of Plan

The following description of the Darwin CX, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of Darwin CX, LLC and its related participating companies (collectively, the “Company” or “Employer”). The Plan was adopted effective May 1, 1984 and restated March 15, 2024, following the transfer of the Palm Coast Data LLC 401(k) Plan, which covered employees from January 1 through March 14, 2024. The Plan was established under a new Employer Identification Number (EIN) and is intended to comply with the applicable provisions of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

All plan assets from the Palm Coast Data LLC 401(k) Plan were transferred into the Darwin CX, LLC 401(k) Plan on March 27, 2024. In addition, the Publisher’s Creative Systems, Inc. Profit Sharing Plan and Trust and the Publisher’s Service Associates, Inc. 401(k) Plan were merged into the Darwin CX, LLC 401(k) Plan effective March 15, 2024.

An employee is eligible to participate in the Plan upon the completion of six months of service and may enter into the Plan the first day of the month coinciding with or following the date the employee eligibility requirements are met. Employees who are not eligible to participate in the Plan include non-resident aliens who do not receive compensation from U.S. sources, employees subject to a collective bargaining agreement, and residents of Puerto Rico.

#### Administration

The Plan is administered by the Company. The Plan’s assets are maintained and administered by Empower Trust Company, LLC (the “Custodian”). The Plan’s recordkeeping services, and maintenance of participant account records are managed by the Empower Trust Company, LLC.

#### Contributions

Participants may contribute up to 100% of their compensation, subject to IRC limitations. The maximum participant deferral for the year ended December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Services (“IRS”) limitations of \$7,500 for the year ended December 31, 2024. The Plan provisions include automatic enrollment for participants who do not complete a salary deferral agreement by their Plan entry date, and provided that no contrary election is made, the participant will automatically defer 3% of eligible compensation for each payroll period to be contributed to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Contributions received from participants are net of excess deferral contributions refunded, as required to satisfy the relevant nondiscrimination provisions of the Plan. The Plan also allows Roth contributions.

The Company provides for a discretionary matching contribution or a discretionary Employer contribution. During the Plan year ended December 31, 2024, the Company did not make a discretionary matching contribution or a discretionary Employer contribution.

#### Participant Accounts

Each participant’s account is credited and/or reduced with the participant’s elective deferral contributions and distributions, the Company’s contributions, and an allocation of the Plan’s investment earnings/losses, investment fees and any administrative expenses paid out of the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan.

Participants may choose from various investments offered. If a participant does not make investment selections, the funds are placed in a target date fund based on the participant’s date of birth.

#### Vesting

Participants are fully vested in their elective contributions, as well as any rollover contributions, plus or minus any earnings or losses thereon. A participant's vested percentage in the portion of his/her account attributable to any Company contribution portion of their accounts plus actual earnings/losses thereon vest according to the schedule below:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1	20%
2	40%
3 or more	100%

Regardless of the vesting schedule above, participants who transferred into the Plan from the Publisher's Creative Systems, Inc. Profit Sharing Plan and Trust are 100% vested at all times in all of their accounts upon attaining age 55 and completing 5 years of vesting service. Participants are fully vested upon retirement, disability, death, or termination of the Plan.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, or other acceptable collateral, and bear interest at a rate of prime plus 1%. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon terms of the Plan document. Loans are considered in default as of the end of the quarter subsequent to the quarter in which the payment was due.

#### Distribution of Benefits

Withdrawals by participants during their employment are permitted with certain restrictions. On termination of service, a participant may receive a lump-sum payment, partial lump sum or installment payment if the balance of the withdrawal exceeds \$7,000 over a period not to exceed the assumed life expectancy of the participant. If the payment is for less than \$7,000 then the participant must receive a lump sum payment. If the payment is a death benefit payment, it will be made in one lump sum within one year of death of the participant. Participants may receive in-service distributions if they attain age 59 ½. The Plan also provides for hardship withdrawals in the event of a qualifying hardship.

#### Forfeitures

Forfeitures occur when a participant terminates employment and has not vested in a portion of the Company's contributions. Forfeitures may be applied to reduce Company contributions and Plan expenses. At December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled approximately \$60,000 and \$70,000, respectively. During the year ended December 31, 2024, approximately \$11,000 of forfeitures were used by the Plan to reduce Company contributions and Plan expenses.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and non-forfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

### Note B – Summary of Significant Accounting Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

#### Valuation of Investments

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. See discussion at Note G on valuation of the guaranteed interest account.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Fair Value Measurements (continued)

<i>Level 1</i>	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
<i>Level 2</i>	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
<i>Level 3</i>	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024 and December 31, 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Empower Trust Company, LLC, a qualified institution. As of December 31, 2024 and December 31, 2023 and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Empower Trust Company, LLC, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

The Plan has received a determination letter from the IRS dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

The Plan Administrator evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

### Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### Note F – Party-In-Interest Transactions

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, were in investment funds managed by Empower Trust Company, LLC; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$66,000 during the year ended December 31, 2024.

### Note G – Fully Benefit-Responsive Investment Contracts

The Plan has entered into traditional fully benefit-responsive guaranteed interest accounts with the Custodian (“the Funds”). The Custodian maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed interest accounts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### Note G – Fully Benefit-Responsive Investment Contracts (continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Specific

coverage provided by each contract may be different from each issuer and can be found in the contract of the Fund. Examples of such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investments options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### Note H – Reconciliation of Financial Statements to Form 5500

The Plan holds investments in pooled separate accounts, which is how they are reported on Form 5500, Schedule D, DFE/Participating Plan Information. Plan number "000" has been used to report these investments on Schedule D because Empower Trust Company, LLC has not filed a Form 5500 directly with the Department of Labor for these investments. As such, the Plan's interest in such investments cannot be included in Schedule H, line 1c(10). Instead, the Plan's interest in the underlying assets of the pooled separate accounts must be allocated and reported in the appropriate categories on a line-by-line basis. Therefore, these investments are reflected as mutual funds on Form 5500, Schedule H, line 1c(13) but as pooled separate accounts for financial statement purposes.
