Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Strongwell Corporation 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 1899, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 1899, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note 1 – Plan Description

The following description of the Strongwell Corporation 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Strongwell Corporation (the “Company”) who have completed six consecutive months of service and are age twenty-one or older. Alternatively, employees who have completed one year of service and are age twenty-one or older are also eligible to participate. Leased employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to the maximum allowed by the *Internal Revenue Code (IRC)*. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also, at the discretion of the Plan Administrator, contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a matching contribution equal to the amount of participant’s salary deferral contributions, up to 4% of compensation. The Company may also make a discretionary profit sharing contribution to the Plan, which was 5.5% of participants’ eligible wages for 2024. Contributions are subject to certain limitations.

Automatic Enrollment

Once an employee has met the eligibility requirements for participation in the Plan, they will be automatically enrolled in the Plan to contribute 4% of their compensation as a salary-deferral contribution to the Plan, unless specifically elected otherwise.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching and discretionary profit sharing contributions, allocation of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Employees become fully vested in the event of total and permanent disability, death of the participant while employed by the Company, or upon termination of the Plan.

Hardship Withdrawals

Hardship withdrawals are permitted pursuant to Internal Revenue Service (IRS) regulations.

Payment of Benefits

If a participant's employment terminates for a reason other than death, disability, or retirement, the benefit will be paid within a reasonable time after such participant incurs a six-month break in service, as described hereafter. Effective January 1, 2024, the automatic distribution threshold increased from \$5,000 to \$7,000 in accordance with Secure Act 2.0. If a participant's vested benefit does not exceed \$7,000, the benefit will be paid in a single lump-sum payment. If a participant's vested benefit is greater than \$7,000 but less than \$25,000, such participant must provide written consent and may elect to receive a single lump-sum payment. In the event of a mandatory distribution that is greater than \$1,000 but less than or equal to \$7,000, if the participant does not affirmatively elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover, or to receive the distribution directly, then the Plan Administrator will pay the distribution in a direct rollover as soon as administratively feasible to an individual retirement plan designated by the Plan Administrator. If a terminated participant's vested benefit is greater than \$7,000, the participant may elect to leave the funds invested in the Plan rather than receive a distribution, subject to the minimum distribution requirements set forth in the Plan. In any event, if the vested benefit exceeds \$25,000, disbursements will be made over a period of five years, with each payment to be calculated based on the number of installment payments remaining to be made. The five-year period is not applicable to participants who terminate employment due to retirement, death, or disability.

Forfeited Accounts

At December 31, 2024 and 1899, forfeited non-vested accounts totaled \$6,108 and \$27,736, respectively. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, forfeitures of \$33,550 were used to reduce employer discretionary contributions.

Note 2 – Significant Accounting Policies

Administrative Costs

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Cash and Interest-Bearing Cash

At December 31, 2024, interest-bearing cash was held at Charles Schwab and was not covered by the Federal Deposit Insurance Program (FDIC).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Certain information was certified as complete and accurate by Charles Schwab Trust Bank, the Plan's Trustee. That information is as follows:

Note 4 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable

inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 1899. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 2 Fair Value Measurements

The fair values of collective investment funds are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The collective investment funds invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The Plan's investment in Galliard Stable Return Fund C is measured at net asset value as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is a twelve-month notice period if the Plan initiates a full redemption of the collective investment trust.

The following table, summarizes investments for which fair value is measured, using the net asset value per share practical expedient as of December 31, 2024 and 1899. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 5 – Investment Contracts

The Plan has investments in the Galliard Stable Return Fund C . Included in this fund are guaranteed investment contracts and certain wrapper contracts. The Plan's investment in this fund is not considered to be fully benefit-responsive and is therefore reported at fair value. However, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus earnings, less participant transactions at contract value. Plan management believes that the occurrence of events that would cause the fund to transact at less than contract value is not probable. The average yield for the fund was approximately 3.35% and 2.93% for 2024 and 1899, respectively. The yield earned by the funds with an adjustment to reflect the actual interest rates credited to participants in the funds was 4.88% and 4.92% for 2024 and 1899, respectively.

Note 6 – Related Party Transactions and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 – Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 401(a) of the *IRC* and, accordingly, the trust's net investment income is exempt from income taxes under Section 501(a). The IRS has determined

and informed the Company by a letter dated July 6, 2017, that the Plan and related trust are designed in accordance with applicable sections of the *IRC*. The Plan has been amended since receiving the determination letter; however, the Plan Administrator and the Plan’s tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the *IRC*. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 9 – Subsequent Events

Subsequent events have been evaluated through September 15, 2025, the date the financial statements were available to be issued.

Note 10 – Reconciliation of Financial Statements to Form 5500
