Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Metro Sales, Inc. Employee Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Metro Sales, Inc. Employee Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Metro Sales, Inc. Employee Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC), covering substantially all employees of Metro Sales, Inc. (the "Company") who are at least 18 years of age. During 2024, the Company acquired Wisconsin Imaging, LLC ("WDI") and the Plan was amended to provide credit for service for the former WDI employees who were employed on July 31, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on June 1, 1974.

The Board of Directors of the Company is responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the trustees. The Plan is administered by the Company and Fidelity Management Trust Company acts as the trustee. The trustee is responsible for holding the assets of the Plan, for participant recordkeeping, and for making disbursements to participants.

Contributions

Participants may, after meeting eligibility requirements, contribute a percentage of their pretax annual compensation, as defined in the Plan. The Plan allows after-tax (Roth) contributions. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, increasing by 1% each year thereafter until reaching 15% of eligible compensation.

The Company may contribute for each participant a discretionary matching contribution on elective contributions made by the participants. During 2024 and 2023, the Company made matching contributions equal to 25% of the elective contributions made by the participants, but not more than the first 6% of eligible compensation the employee contributes to the Plan through salary deferral. The Company may also make discretionary profit sharing contributions. Company discretionary profit sharing contributions were 0.00% and 8.66% of eligible compensation, as defined by the Plan for the years ended December 31, 2024 and 2023, respectively.

Metro Sales, Inc. Employee Profit Sharing Plan Notes to Financial Statements

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's discretionary profit sharing and discretionary matching contributions, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their voluntary contributions and rollover contributions at all times. Vesting in the Company's contribution portion of their accounts is based on a graded schedule and begin vesting after two years of service and continue to vest ratably 20% each year and are fully vested at the end of six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at a rate of two points above the prime rate, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Loans are not to exceed five years unless it is for the purchase of a primary residence, for which the note may be repaid over a period not to exceed ten years. If note payments by participants are delinquent, they are considered a deemed distribution in the Plan year they are delinquent.

Payment of Benefits

Upon termination of service, death, disability, or retirement, participants or designated beneficiaries may receive the value of their vested interest in their account in the form of a lump-sum payment. For account balances that are \$7,000 or less, the Plan Administrator will authorize the benefit payment without the participant's consent. The Plan allows for in-service withdrawals of fully vested balances any time after reaching age 59½ or becoming disabled. The Plan also allows hardship distributions subject to certain restrictions.

Forfeitures

Forfeitures resulting from a terminated participant's failure to be fully vested in the employer contributions to the Plan are used to reduce employer contributions. Forfeited nonvested accounts were approximately \$47,000 at both December 31, 2024 and 2023. Forfeitures used to reduce employer contributions in 2024 and 2023 were approximately \$110,000 and \$77,000, respectively. Forfeitures used to pay plan expenses in 2024 and 2023 were approximately \$8,000 and \$0, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation

Investments are reflected at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment committee, investment advisors, the trustee, and other third parties.

Income Recognition

The net appreciation in fair value of investments represents the realized and unrealized gains or losses on assets bought and sold during the year and held at year end. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Funding Policy

Company discretionary matching contributions are generally remitted to the Plan at the same time as employee deferrals. Company discretionary profit sharing contributions, if authorized, are remitted to the Plan generally in March following the end of the Plan year.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

Self-directed brokerage accounts: Accounts primarily consist of investments in common stocks, mutual funds and cash. Common stocks and mutual funds are valued on the basis of readily determinable market prices. Cash is valued at cost that approximates fair value.

Money market fund: Valued at cost plus accrued income, which approximates fair value measured by similar assets in active markets.

Collective trust fund: Valued at the NAV as a practical expedient to fair value based on the fair value of underlying investment at year-end. The trust intends to maintain a constant net asset value of \$1.00 per share which is the published value and basis for current transactions. As a result, the fair value is considered to be readily determinable.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Company has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The letter states that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since adoption of the prototype plan, however, the plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions but are not prohibited transactions as defined by ERISA. Notes receivable from participants also qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

The Plan has a provision in its service agreement with Fidelity to provide for a participant revenue credit. The credit is calculated quarterly based on average investment balances, excluding the self-directed brokerage accounts. The Company may use the credit to offset, reimburse, or pay certain plan expenses with any remaining amounts being allocated to eligible participants pro rata based on account balances. During 2024 and 2023 and 2023, \$118,166 and \$101,929, respectively were allocated to participants. This amount is included in administrative credits on the statement of changes in net assets available for benefits.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 23, 2025 the date which the financial statements were available to be issued.
