1. Description of the Plan

The Chowbus 401(K) Plan (the “Plan”) was established March 1, 2021. The Plan is a defined contribution plan covering all eligible employees of Chowbus, Inc. (the “Company” or “Employer”). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

The Plan is administered by Company management who is responsible for the administrative and investment decisions of the Plan. Management has appointed Fidelity Management Trust Company (“Fidelity” or the “Trustee”) as trustee and to assist in the administration of the Plan.

Eligibility

There is a minimum one-month period of service required to participate in the Plan, and employees are eligible to begin participation on designated first day of each month provided that they are not part-time, an intern, temporary employee, vendor employee or volunteer.

Contributions

Each year, participants may contribute to the Plan up to 90% of their eligible compensation, on a pre-tax or after-tax (Roth) basis, subject to a maximum annual limit as defined by the Internal Revenue Code (“IRC”) specified by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Unless they affirmatively elect otherwise, eligible employees who have not made an affirmative election to defer under the Plan will have elective deferrals contributed to the Plan in the amount of 6% of their eligible compensation, unless they affirmatively elect not to participate in the plan. For employees enrolled under this automatic enrollment provision there is an automatic escalation of elective deferrals in the amount of 1% each year thereafter not to exceed 10% of eligible compensation.

1. Description of the Plan (*continued*)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings and losses or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in all contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum amount equal to the lesser of (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of plan loans during the one-year period ending on the day before the loan is made over the outstanding balance of plan loans on the date the loan is made, or (b) one-half the present value of the "participant's" account. The loans bear interest at a reasonable rate of interest as determined by the plan administrator based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The loans plus interest are repaid through payroll deduction in equal payments over the term of the loan (up to five years, if for principal residence not to exceed 10 years). Loans are collateralized by the participant's account balance. Upon termination of service, the principal and accrued interest shall be immediately due and payable by the end of the cure period as indicated on the loan documentation.

Payment of Benefits and Withdrawals

The Plan is designed to provide benefits at the time of retirement. However, if employment with the Company is terminated because of death, disability, or for any other reason, a request for distribution of a participant's account balance is also allowed. If a participant dies while classified as an active member of the Plan, the participant's beneficiary or beneficiaries are entitled to receive the participant's account balance. Should a participant become totally and permanently disabled while employed by the Company, the full value of the participant's account balance may be distributed upon request.

Upon termination of employment, the participant's account will be distributed to the participant in a lump-sum cash payment if the participant's vested account balance is less than \$5,000. If the account balance is greater than \$5,000, the consent of the participant and their spouse must be obtained. No distribution shall be made to the Participant before he reaches his Normal Retirement Age (or age 65, if later) without the Participant's consent. Upon reaching age 59½, pursuant to the Internal Revenue Code ("IRC"), participants may elect distributions from their accounts without any tax penalty.

Subject to certain limitations prescribed by the Plan and the IRC, participants may elect hardship withdrawals.

Forfeited Accounts

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. Forfeitures may be used to reduce administrative expenses. At December 31, 2024 and 2023, forfeited amounts totaled \$2,877 and \$1,428. During 2024, no forfeitures were used to reduce administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements*, which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The mutual funds are deemed to be actively traded. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective Plan assets. All other costs not allocable to the account of a particular participant will be charged against the accounts of all participants on a pro rata basis or in such other reasonable manner as may be directed by the Employer and accepted by the trustee. Investment related expenses are included in net appreciation in fair value of investments. Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 19, 2025.

4. Investments (*continued*)

The Goldman Sachs Stable Value Collective Trust seeks to earn current income and preserve capital and stability of principal. The Fund also seeks to maintain a stable NAV of \$1.00 per unit. The NAV per unit is determined each business day. Issues and redemptions of units are recorded based on the next determined NAV per unit normally each day. The ability to redeem from the fund occurs daily. The Plan does not have any unfunded commitment related to the fund.

The International Growth II R1 seeks capital appreciation by investing in the MFS International Growth Collective Investment Trust (CIT). The Large Cap Growth Fund II Class R1 seeks long-term capital growth by investing in the JPMCB Large Cap Growth Fund. The Mid Cap Value Fund II Class R1 seeks long-term capital appreciation by investing in the Allspring Special Mid Cap Value CIT. The Large Cap Value Fund III Class R1 seeks long-term capital growth by investing in the JPMCB U.S. Value Fund. Participants may generally redeem Fund Units daily, subject to few limitations. Advance written notice is required for any redemptions directed by a Plan Sponsor; redemptions of \$1,000,000 or more of a Plan's assets invested in the Fund required 5 business days advance notice for most Funds. Redemptions will be made on a pro rata basis from the Plan's interest in the Fund. These CITs are generally priced and traded daily and subject to annual financial audits. The Plan does not have any unfunded commitment related to the CIT funds.

5. Party-in-Interest

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans would be recorded as notes receivable from participants in the statements of net assets available for benefits. There were no such loans at December 31, 2024 and 2023.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Company has adopted an approved volume submitter plan which received an IRS advisory opinion letter dated June 30, 2020 which indicated the form of the Plan satisfied the qualification requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and tax-exempt as of the financial statement date.

8. Non-exempt Party-in-Interest Transactions

During 2023, the Company failed to remit to the Plan certain participants' contributions totaling \$151 within the period prescribed by the Department of Labor's Rules and Regulations due to administrative errors. During 2024, the Company has made necessary corrections to satisfy both the Department of Labor and IRS guidance for this matter related to 2023.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
