Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

### **1. Description of Plan**

#### ***General***

Superior Integrity 401(k) Plan (Plan) was established on March 1, 2022, for eligible employees of Desert NDT, LLC dba Superior Integrity Services (Company). The Plan is a defined contribution plan designed to comply with the Employee Retirement Income Security Act of 1974 (ERISA). The following descriptions provide only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***Contributions***

Participants may contribute pretax annual compensation up to the maximum percentage allowable under the Internal Revenue Code. The Plan allows participants to contribute on an after-tax basis as Roth elective contributions. In addition, any participant, with the Plan administrator's written consent, may contribute to the Plan, other than as a voluntary contribution, if the contribution is from another qualified plan. The Company makes safe harbor matching contributions in an amount equal to 100% of elective participant contributions up to 1% of compensation, plus 50% of elective deferral contributions from 1% to 6% of compensation. Discretionary contributions may be made for each Plan year in an amount determined by the Company. The employer may determine different amounts for each allocation group. The Company shall notify the Plan administrator in writing of the amount of discretionary contributions, if any, determined for each allocation group. No discretionary contributions were made during the year ending December 31, 2024 and 2023.

#### ***Eligibility and Participant Accounts***

All employees of the Company who have completed a three month period of service are eligible to become participants in the Plan. Each participant's account balance is credited with the participant's contributions and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Auto Enrollment and Escalation***

New employees who have not otherwise elected to participate in the Plan are automatically enrolled in the Plan at their first eligible date (unless they have elected to not participate in the Plan), with a default deferral rate established by the Company of 3%, and deferrals are invested in the Plan's qualified default investment alternatives. The Company in its adoption agreement elected to automatically increase certain employees' default deferral rates on a uniform basis for only those employees who were automatically enrolled in the Plan and who have not made a deferral election change since that time, including an election not to defer, will have their default deferral rate automatically increased by one percentage point as of the first day of each subsequent Plan year by the Company.

### ***Vesting***

Participants contributions plus earnings thereon are fully vested. Contributions and rollovers into the Plan are 100% vested. Vesting in the Company's safe harbor matching contributions, plus actual earnings thereon is as follows:

### ***Benefits Paid to Participants***

A participant's account balance is paid to the participant or the participant's beneficiary in a lump sum payment, periodic payments or an annuity upon the participant's retirement, death or disability. The vested portion of a participant's account can be withdrawn by the participant upon termination of employment with the Company or upon withdrawal from the Plan. In-service withdrawals of after-tax accounts and hardship withdrawals of pre-tax accounts are also available.

### ***Notes Receivable from Participants***

Notes receivable from participants represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Under the Plan, participants may obtain loans not to exceed the participant's account balance in the Plan. Repayment periods may not exceed five years unless used for the purchase of a residence. Loan interest rates are based on financial institution prime lending rates for loans of a similar nature. Principal and interest are paid ratably through automatic payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be a distribution, notes receivable from participants is reduced and a benefit payment is recorded.

### ***Forfeitures***

Forfeited non-vested amounts are used to offset administrative expenses and future company contributions. For the year ended December 31, 2024 forfeitures used to pay Plan expenses and employer matching contributions totaled \$13,521. Forfeitures available for future use at December 31, 2024 and 2023 totaled \$25,913 and \$22,624, respectively.

### ***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to provisions of ERISA. In the event of Plan termination, employees become fully vested in their accounts.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Estimates and Assumptions***

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could vary from the estimates used in preparing the accompanying financial statements.

### ***Investments and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Benefits Paid to Participants***

Benefits to participants are recorded when paid.

### ***Risks and Uncertainties***

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### **3. Fair Value Measurements**

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

Level 1	Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable in active markets.
Level 3	Valuations derived from valuation techniques in which one more significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments are valued using Level 1 inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

### ***Mutual Funds***

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying asset owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the

Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status of the Plan

The Plan sponsor has adopted the FIS Relius Corbel IDP-Formatted Nonstandardized Pre-Approved Plan, which has an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (IRC) and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three year from the date of filing.

### **6. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are managed by the Trustee and, therefore, these transactions qualify as party-in-interest transactions. Some fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than by direct payment.

### **7. Subsequent Events**

Plan management has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued and concluded that no additional disclosures are required.
