(1) Description of the plan

The following brief description of the Jarrett Builders, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution plan covering all full-time employees of Jarrett Builders, Inc. (the “Plan Sponsor”) who are eighteen or older and have three months of service (“participants”). The Plan, which was adopted by action of the Plan Sponsor’s Board of Directors on January 1, 2022 (date of Plan’s inception), is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 15, 2024, the Plan elected to move its assets to Principal Life Insurance Company and the assets were held in a non-interest bearing holding account until early 2025, which is presented as cash on the statement of net assets available for benefits as of December 31, 2024.

Additionally during 2024, the Plan was amended and transitioned from a single-employer plan to a multiple-employer plan.

(b) Contributions

Each year, participants may defer a percentage of their pretax annual compensation as defined in the plan agreement, not to exceed the maximum annual amount as determined by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollovers”) and make after-tax Roth contributions. Eligible participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The rate increases 1% each year until a deferral rate of 8% is achieved.

The Plan Sponsor makes a safe-harbor matching contribution of 100% of a participant’s deferral up to 1% of compensation, plus 50% of deferrals that exceed 1% of compensation but do not exceed 6% a participant’s compensation. At its discretion, may contribute additional amounts to the Plan as determined by the Board of Directors. Any profit sharing contribution will be allocated according to the plan document to participants eligible to share in the contribution.

(1) Description of the plan, continued

(c) Participant accounts

Each participant's account is credited with the participant's contributions and the Plan Sponsor's contributions, as well as allocations of plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

The Plan is a safe-harbor plan and therefore, all participants are immediately vested in their voluntary contributions and all Plan Sponsor safe-harbor matching contributions plus actual earnings thereon. Vesting in the Plan Sponsor discretionary contribution portion of their account plus actual earnings (losses) thereon is based on years of continuous service. A participant becomes 20% vested after two years of service and vesting increases 20% each year until the participant is 100% vested after six years of credited service.

(e) Payment of benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum distribution equal to the value of his or her entire account. On termination of service due to other reasons, a participant will receive a lump-sum distribution equal to the value of his or her vested account.

(f) Forfeitures

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor discretionary contribution portion of their accounts and may be used to pay plan expenses or reduce future Plan Sponsor contributions. At December 31, 2024 and 2023, there were no forfeited nonvested accounts since the Plan Sponsor has not elected to make a discretionary contribution to the Plan.

(g) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½, unless certain exceptions apply.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

(2) Summary of significant accounting policies, continued

(b) Payment of benefits

Benefits are recorded when paid.

(c) Use of estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (“GAAP”) requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(d) Investment valuation and income recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan’s valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

(e) Contributions

Contributions from plan participants and any respective matching contributions from the Plan Sponsor, if applicable, are recorded in the year in which the employee contributions are withheld from compensation.

(f) Events occurring after the reporting date

The Plan has performed an analysis of the activities and transactions subsequent to December 31, 2024, to determine the need for any adjustments or disclosures for the year then ended. The Plan has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

(g) Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to distributions are charged directly to the participant’s account and are included in administrative expenses. The Plan holds assets in an expense balance account which receives deposits as a result of a revenue sharing agreement with a party-in-interest to the Plan. During 2024, deposits to the account were netted with administrative expenses and used to pay qualified plan expenses. See Note 5 for further disclosure.

(3) Summary of information certified by the custodians

Information related to investments and investment income or loss disclosed in the accompanying financial statements and supplemental schedule, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company, the custodian of the Plan as of December 31, 2024 and for the period from December 15, 2024 to December 31, 2024 and Transamerica Financial Life Insurance Company Inc. and Reliance Trust Company, the custodians of the plan, as of and for the year ended December 31, 2023 and for the period from January 1, 2024 to December 14, 2024.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability; and
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the assets or liability.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Fair value measurements, continued

Pooled separate accounts and common collective trusts held at December 31, 2024, while not reported on exchanges or other public means, are similar to mutual funds and considered as being published because the value is available via investor online reporting. Therefore, these accounts are determined to have a readily determinable fair value and net asset value is not used as a practical expedient.

The common collective trusts held at December 31, 2023 were valued differently as a Level 2 input.

The stable value account at December 31, 2023 is a depository liability similar to a bank CD and is not considered to be either a guaranteed interest account or a common collective trust. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the account, the issuer reserves the right to require notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 or 2023.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair values as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

(5) Related party and party-in-interest transactions

Certain plan investments are managed by Principal, the custodian of the Plan at December 31, 2024 and, therefore, these transactions qualify as party-in-interest transactions. The custodians provide certain administrative services to the Plan pursuant to an agreement whereby the service provider receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed for administrative services to the Plan.

If the revenue received by custodians from such mutual fund service providers exceeds the amount owed under the agreement, the custodian remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay the Plan's administrative expenses or allocated to the accounts of the participants. During the plan year, there were no excess amounts. The Plan or Plan Sponsor may make a payment to third-party service providers for administrative expenses not covered by revenue sharing. Certain administrative functions are performed by officers or employees of the Plan Sponsor and no such officer or employee receives compensation from the Plan.

Administrative expenses paid to parties-in-interest amounted to \$47,267 and \$36,788 for 2024 and 2023, respectively. The Plan Sponsor also pays for certain plan expenses for which it is not reimbursed by the Plan.

(6) Income tax status

The Plan Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(8) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

(9) Investment contract with insurance company

The Plan has entered into an investment contract with Principal Life Insurance Company, who maintains the Plan's contributions in guaranteed interest accounts, which have been determined to be fully benefit responsive. The accounts are credited with earnings of on the underlying investments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed interest accounts, which approximates fair value, was \$68 as of December 31, 2024. The average yield and crediting interest rates are reviewed on an annual basis for resetting.

(10) Reconciliation of financial statements to Form 5500
