Years Ended December 31, 2024 and 2023

1 DESCRIPTION OF PLAN

The following description of the Koerner Distributor, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

GENERAL -- The Plan is a defined contribution plan with a 401(k) feature sponsored by Koerner Distributor, Inc. (the Company) covering all non-union employees who have at least one year of service and are age 21 or older. Entry dates are the first of any month following the date eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is overseen by the Company's Board of Directors. Charles Schwab Trust Bank serves as the Plan trustee.

CONTRIBUTIONS -- Each year, participants may contribute up to the maximum limitation set by the Internal Revenue Service. The Plan has a 2% automatic deferral amount unless the participant makes a contrary election. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions among any or all of the investment options offered by the Plan.

The Company makes a 3% safe harbor nonelective contribution each year. The Company can also make a discretionary nonelective contribution to all eligible participants without regard to employee contributions. Such contributions, if any, are allocated to participants in the ratio that each participating employee's compensation bears to the total compensation of all participants. All contributions are invested as directed by each individual participant. Contributions are subject to certain limitations under the Internal Revenue Code. The Company's discretionary contribution was 2% for 2024 and 2023.

PARTICIPANT ACCOUNTS -- Each participant's account is credited with the participant's contributions, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING -- Participants are immediately vested in all contributions including any discretionary contributions, plus actual earnings thereon.

NOTES RECEIVABLE FROM PARTICIPANTS -- Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from two to five years but may be extended for the purchase of a primary residence. The loans are secured by the participant's vested account balance and bear a reasonable rate of interest as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

PAYMENT OF BENEFITS -- On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period of time, not exceeding a participant's life expectancy or joint life expectancy of a participant and participant's designated beneficiary. An eligible rollover distribution is also permitted. If the value of a participant's account is less than \$1,000, a lump sum distribution will be made without regard to the consent of the participant as soon as administratively feasible. The Plan also allows for in-service distributions once a participant has attained age 59 1/2.

1 DESCRIPTION OF PLAN (Continued)

FORFEITED ACCOUNTS -- At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Any forfeited accounts are used first to pay the Plan's administration expenses and then will reduce future employer contributions.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING -- The financial statements of the Plan are prepared using the accrual basis of accounting. Investments are recorded at fair value, except for the common collective trust. The common collective trust is reported at contract value, which is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

USE OF ESTIMATES -- The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION -- The Plan's investments are stated at fair value (except for the fully benefit-responsive common collect trust, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS -- Notes receivable from participants are measured at their unpaid balance plus any unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

PAYMENT OF BENEFITS -- Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES AND PARTICIPANT TRANSACTION FEES -- Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to Plan administration are charged directly to the participant's account. Distribution and loan fees are charged to the individual participant's account incurring the distribution or loan. Investment related expenses are included in net appreciation of fair value of investments.

3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the Plan has obtained a certification from Empower Trust Company, LLC (trustee through December 18, 2024) and Charles Schwab Trust Bank (the "Trustee") (trustee as of December 18, 2024), that certifies the completeness and accuracy of certain information which management used in preparing these financial statements. Accordingly, this information was not audited.

4 INVESTMENTS AT FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Fair Value Measurements - The fair value of registered investment company shares is based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements - Inputs to the valuation methodology include: (i) quoted prices for similar instruments in active markets, (ii) quoted prices for identical or similar instruments in markets that are not active, (iii) inputs other than quoted prices that are observable for the instruments, and (iv) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Fair Value Measurements - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4 INVESTMENTS AT FAIR VALUE (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported to the fund. Mutual funds held by the Plan are open-end registered mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Insurance contracts: Valued at cash surrender value based on premiums paid and accumulated dividends. The Plan invests in whole life contracts on behalf of six participants. Three of these policies are still active while the other three policies have been converted to reduced paid-up policies.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5 INVESTMENTS AT CONTRACT VALUE - COMMON COLLECTIVE TRUST

The Plan invests in a stable value fund held in a common collective trust. The common collective trust (CCT), Goldman Sachs Stable Value Fund, invests primarily in fully benefit-responsive investment contracts such as conventional and synthetic guaranteed investment contracts issued by insurance companies and other financial institutions.

The CCT is valued at net asset value of the units in the Goldman Sachs Stable Value Collective Trust Fund. The NAV, as provided by the Trustee, is used as a practical expedient based on the collective trust's underlying investments as determined by the fund's issuer. The funds seek to maximize total return through both current income and price appreciation, consistent with the preservation of capital and prudent risk taking. The funds have no restrictions on redemptions and have no unfunded commitments. Further information on the Goldman Sachs Stable Value Collective Trust Fund can be found in the investment's annual report.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value; however, certain events may limit the ability to transact at contract value. Specifically, any event outside the normal operation of the Plan that causes a withdrawal from the investment contract may result in a negative market value adjustment with respect to the withdrawal. Examples of such events include, but are not limited to, changes in the tax exempt status of the Plan, a significant change in the number of employees covered under the Plan, plan termination, or change in control of the Plan, including any mergers. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

6 PLAN TERMINATION

The Plan was established January 1, 1990. Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA.

7 TAX STATUS

The Internal Revenue Service has determined and informed the prototype sponsor, by a letter dated March 31, 2014, that the Plan, as then designed, is in accordance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving that letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

9 PARTY-IN-INTEREST TRANSACTIONS

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment. Fees paid by the Plan to the trustee for administration fees amounted to \$152,719 and \$105,395 for the years ended December 31, 2024 and 2023, respectively. The Plan also transacts with certain parties who may perform services to the Plan. Such parties qualify as parties-in-interest under ERISA.
