### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cumberland Valley Financial Corporation Savings & Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Cumberland Valley Financial Corporation Savings & Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective January 1, 1992 and was amended and restated effective July 1, 2021. Under Secure Act 2.0 voluntary provisions, the Plan elected to increase the force-out threshold from \$5,000 to \$7,000 effective January 1, 2024. The Plan covers all eligible employees of Cumberland Valley National Bank (the Plan Sponsor, Employer and Administrator).

#### Eligibility

Employees are eligible to participate in the Plan once they completed 90 days of service and reached age 21.

#### Contributions

Eligible employees may make pre-tax and Roth contributions from their eligible compensation, as defined by the Plan adoption agreement. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Rollover contributions are permitted only by employees who have satisfied the conditions for participation. The Plan Sponsor makes a safe harbor matching contribution equal to 100% of the participant's deferral contributions not exceeding 3% of the participant's compensation for the plan year plus 50% of the participant's deferral contributions in excess of 3% but not in excess of 5% of the participant's compensation for the plan year. The Plan Sponsor may also elect to contribute a discretionary contribution not to exceed 4% of compensation. No discretionary contribution was made during the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants are automatically enrolled in an elective deferral contribution of 3% of compensation, unless the participant affirmatively elects a different percentage or elects not to make an elective deferral contribution. This percentage is automatically increased on or after each January 1 by 1% up to a maximum of 10%.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Plan Sponsor's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. Administrative expenses are charged to each participant's account when a benefit distribution is processed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. Description of the Plan, continued

### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

### Vesting

Participants are vested immediately in their contributions and rollovers plus actual earnings thereon. Participants are vested immediately in the Plan Sponsor's safe harbor contributions. Vesting in the Plan's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. Participants are vested in the Plan Sponsor's discretionary contributions according to the following schedule:

2	20%
3	40%

6	100%

If a participant dies or becomes disabled, he or she is automatically 100% vested in all accounts.

### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance is greater than \$7,000 (excluding amounts attributable to rollover contributions) may elect to receive either a single lump sum amount equal to the value of the participant's vested interest in his or her account, or a single sum payment of a portion of the participant's vested interest in his or her account. On termination of service, a participant whose vested account balance is not greater than \$7,000 (excluding amounts attributable to rollovers) will receive his or her benefits as a single lump sum payment.

### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited accounts totaled \$9,925 and \$2,498, respectively. These accounts can be used towards future employer contributions or plan expenses.

All forfeitures are applied to Plan Sponsor contributions and pay Plan expenses.

### 1. Description of the Plan, continued

#### Revenue Credit Program

The Plan provides for a revenue credit program in connection with revenue sharing with certain investment managers. The amounts may be used to pay Plan expenses or allocated to eligible participant accounts.

#### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Trust Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

### 2. Summary of Significant Accounting Policies, continued

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan adoption agreement. Investment related expenses are included in net appreciation of investments. Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are excluded from these financial statements.

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through September 18, 2025, the date that the financial statements were available to be issued.

### 3. Information Certified and Provided by Custodian

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Empower Trust Company, LLC (Empower), the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that investment information provided to the Plan Administrator by the custodian is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedule.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Pooled separate accounts:* Valued at net asset value (NAV) per share based on quoted market prices of underlying investments.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with accounting standards, investments in 2024 and 2023 consist of pooled separate accounts that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified as Level 1, 2 or 3 in the fair value hierarchy.

### 5. Investment Contract with Insurance Company, continued

The Plan has a fully benefit-responsive investment contract with Talcott Resolution Life Insurance Company (Talcott or Issuer) that is reported at contract value. Talcott maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by Empower. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Plan Sponsor, and certain other Plan Sponsor-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate of the contract is based on an agreed-upon formula with the Issuer, as defined in the contract agreement, but cannot be less than 3%. Such interest rates are reviewed on a semi-annual basis for resetting. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers and withdrawals into/out of the contract; and the duration of the underlying investments backing the contract.

### 6. Exempt Party-in-Interest Transactions

Empower is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest. During the year ended December 31, 2024 the Plan paid \$1,513 to Empower for recordkeeping services. Alden Capital is the investment advisor and therefore these transactions qualify as party-in-interest. During the year ended December 31, 2024 the Plan paid \$10,991 to Alden Capital for investment advisory services. During the year ended December 31, 2024, the Plan received \$10,991 from the Revenue Credit Program, which was placed in an ERISA account. Qualified Plan expenses may be paid from the ERISA account. As of December 31, 2024, there is \$6,976 remaining in the ERISA account.

Additionally, indirect fees are paid to Empower based on investment account values. These fees range from 0.39% to 1.57% of the investment account value. The fees decrease net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

### **7. Tax Status**

The Plan uses a prototype Plan document sponsored by Empower Retirement, LLC which received an opinion letter from the IRS, dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **8. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination participants would become 100% vested in their accounts.

### **9. Subsequent Events**

Effective January 1, 2025, employees are eligible to participate in the Plan once they complete 90 days of service and reach age 18.

Effective January 1, 2025, the annual 1% increase in automatic elective deferral contributions changed from a maximum of 10% to 15%.
