For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1: Description of Plan

The following brief description of the Bankers Finance Capital Corp. Employee 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1983. The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Employers included in the Plan are Bankers Finance Capital Corp.; Presidential Bank, FSB; Realty Home Mortgage Co., LLC; Homebuilders Mortgage Co., LLC; Presidential Service Corporation; GIT Investments Services, Inc.; Presidential Holdings, Inc.; Cleveland Corporation; Clarendon Services, Inc.; Chesapeake Transport, Inc.; and Lucky Hill Farm, Inc. (all related employers, collectively the "Plan Sponsor"). The Plan covers essentially all employees of the above employers. New employees are eligible to become participants upon their date of hire with no age or service requirement.

The Plan's assets are held in the custody of Fidelity Management Trust Company ("Fidelity"), which also serves as the trustee of the Plan and record keeper.

Administrative Expenses

Certain plan administrative expenses are paid directly by the Plan Sponsor, as provided in the Plan agreement. The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

Contributions

Participant Contributions - Participants may make salary deferral contributions from their compensation each pay period, subject to the limitations of the IRC, up to 60% of compensation not to exceed the maximum contribution set by the Internal Revenue Service ("IRS") of \$23,000 for 2024. In addition, participants 50 years of age or older may elect to make "catch-up" deferral contributions, not to exceed \$7,500 in 2024. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. Participants are immediately fully vested in their salary deferral and rollover contributions.

Plan Sponsor Contributions - The Plan Sponsor makes matching contributions in an amount equal to 100% of a participant's contributions up to 4% of their eligible compensation, not to exceed \$4,000. The Plan Sponsor also makes matching contributions to employees who terminate during the Plan year. Plan Sponsor contributions vest fully at the earlier of retirement age (65), disability, or after two years of service.

Participant Accounts

Individual accounts are maintained for each participant and include the participant's salary deferral contribution, the appropriate Plan Sponsor matching contribution, and Plan earnings (losses) including realized and unrealized gains and losses on investments and

Participant Accounts (Continued)

an allocation of Plan expenses not paid by the Plan Sponsor. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Terminating participants forfeit non-vested Plan Sponsor contributions. Forfeitures of non-vested Plan Sponsor contributions may be used to reduce future Plan Sponsor contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,733 and \$35,258, respectively, which can be used by the Plan Sponsor to reduce future contributions. The Plan Sponsor used \$35,258 in forfeitures to reduce contributions in 2024.

Benefits Paid to Participants

The Plan allows for distributions upon termination of service, death, disability, or certain hardship situations. On termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in their account. A participant may elect to receive a lump sum payment or may roll over the value of their account into another qualified plan. Vested participants who separate from employment with the Plan Sponsor, and whose account is more than de minimis, may elect to leave their funds in the Plan. As of December 31, 2024 and 2023, the de minimis amount was \$5,000.

Hardship Withdrawals

The Plan allows, in certain hardship situations as defined in the Plan, participants to withdraw part or all of their deferral contributions while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Participants can have up to three loans outstanding at any given time and the loans are secured by the participants' vested accounts. Interest rates remain fixed for the life of the loan and shall bear a reasonable rate of interest as determined by the Plan Administrator based on a rate that is commensurate with interest charged for loans that would be made under similar circumstances. At December 31, 2024 interest rates on outstanding loans ranged from 4.25% to 9.50%. Loan terms may not exceed five years unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond ten years. Principal and interest are paid in equal installments by payroll deductions or in accordance with procedures provided by the Plan Administrator.

Investment Options

Under the Plan, a participant directs Fidelity as to the investment of the Plan Sponsor and the Participant's contributions. Participants may change their investment elections at any time. Transfers of account balances between elected investment options may also be made at any time.

Secure Act and Secure Act 2.0

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

Note 2: Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The presentation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events

Management has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued. Adjustment or additional disclosures, if any, have been included in these financial statements.

Note 3: Fair Value Measurements

The Plan follows the guidance for fair value measurements and disclosures in accordance with Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosures* ("ASC 820"). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

In determining fair value, management uses various valuation approaches, as appropriate in the circumstances. ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are market data from independent sources. Unobservable inputs are Management's assumptions, based on the best information available, of how the market would price the asset or liability. The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1

Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment.

Level 2

Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

Level 3

Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The inputs into the determination of fair value require significant judgment and estimation.

The Plan does not maintain Level 3 assets.

The Plan's policy is to recognize transfer of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies or level designation used at December 31, 2024 and 2023.

Money Market Fund

The objective of these investments is to earn interest for shareholders while maintaining a net asset value of \$1. These funds consist of short-term securities representing high-quality, liquid debt and monetary instruments.

Mutual Funds

Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust

Valued using the net asset value based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. The Plan can redeem these investments daily. There are no restrictions on redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Tax Status

The Company has adopted a Standardized Prototype Deferred Profit Sharing Plan as prepared by Fidelity Management Trust Company ("trustee"). The Plan has received favorable determination letters from the Internal Revenue Service, the most recent of which is dated June 30, 2020 stating that the Plan and related trust agreement are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving this determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with all appropriate requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5: Information Prepared and Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental Schedule of Assets Held for Investment Purposes at End of Year (attachment for Schedule H, Line 4i) as of December 31, 2024, and the related investment activity and interest on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 6: Administration of Plan Assets

Plan assets are held by Fidelity Management Trust Company, the trustee of the Plan.

The Plan is administered by the Benefits Administrator of the Company whereby certain administrative functions are performed by employees of the Company. No employees receive compensation from the Plan. Contributions are held and managed by the trustee, which invests the cash received, as well as interest and dividend income as designated by the participants and makes distributions to participants. The trustee also administers the payments of interest and principal on participant loans.

Note 7: Related Party Transactions

Certain Plan investments are proprietary funds and managed by the trustee, and therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Participant fees paid by the Plan amounted to \$56,277 for the year ended December 31, 2024.

Note 8: Plan Termination

The Plan is intended to be a permanent program of the Company. However, the Company can at any time declare the Plan terminated subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9: Concentrations of Credit Risk

The Plan provides for investment options in various mutual funds with Fidelity Management Trust Company. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near-term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across different mutual fund elections. Additionally, the investments within each participant-directed mutual fund election are further diversified into varied financial instruments.

Note 10: Reconciliation of Financial Statements to Schedule H of Form 5500
