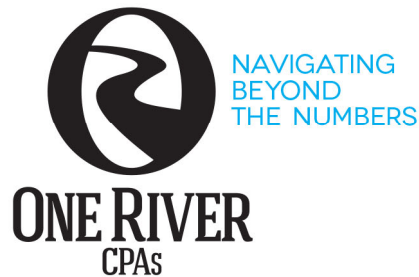

## Independent Auditors' Report

To the Administrative Committee of  
the Maine Family Planning 403(b) Plan,

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Maine Family Planning 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Maine Family Planning 403(b) Plan and to meet our other ethical responsibilities

in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Maine Family Planning 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the 2024 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters**

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Maine Family Planning 403(b) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a 403(b) defined contribution plan covering substantially all employees of Maine Family Planning (the “Organization”). Employees are immediately eligible to contribute a pre-tax deferral into the Plan. Participants are eligible to receive Organization nonelective contributions if they have completed one year of service. Participants are credited with one year of service if they have worked at least 1,000 hours during the eligibility computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

*Plan Contributions* – Each year, participants may contribute up to the IRS limit of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may be eligible to make special code section 403(b) catch-up contributions if they have worked at least 15 years for a qualified organization, as defined by the Plan. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). For eligible employees, the Organization makes a nonelective contribution equal to 3% of compensation. Participant contributions are funded on a payroll basis and Organization nonelective contributions are calculated and funded on a quarterly basis.

Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate account options and insurance company general account options, that are part of individual TIAA variable annuity contracts. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions and the Organization’s matching contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in all contributions plus actual earnings thereon.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at a fixed rate determined by the plan administrator based on prevailing market conditions. Principal and interest are paid ratably through payroll deductions. Note terms cannot exceed five years, unless the proceeds are used in the purchase of a primary residence of the participant, for which the plan administrator may permit a longer repayment term. The interest rate on participant loans outstanding as of December 31, 2024 is at 8.00%.

**NOTE 1 – DESCRIPTION OF THE PLAN, CONTINUED**

*Payment of Benefits* – Upon termination of service, death, disability, or retirement, participants may request a distribution in a lump-sum amount, installment payments, or an annuity contract. Participants may also choose to roll over distributions to other eligible retirement plans. The Plan makes a mandatory lump-sum distribution following severance from employment for accounts with balances equal to or less than \$1,000. In addition, hardship distributions out of the participant’s voluntary contributions account are permitted if certain conditions are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

*Plan Loans* – In additions to loans that plan participants borrow from their account balances (notes receivable), the Plan also permits plan loans. Plan loans are issued as separate contracts by Teachers Insurance and Annuity Association of America (TIAA), as contemplated under IRC Section 72(p)(5) and do not represent Plan assets. Loans are collateralized using a participant’s TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants may borrow a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 45% of his or her TIAA Traditional account balance subject to annuity contracts and Plan provisions. Loan terms range from one to five years in one-year increments or, for the purchase of the participants primary residence, a loan term up to 10 years. Principal and interest is paid ratably by the participant to TIAA, and each payment will reduce amounts collateralized by the borrowing participant’s TIAA Traditional account balance.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Use of Estimates* – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan’s investments are reported at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

*Payment of Benefits* – Benefits are recorded when paid. At December 31, 2024 and 2023, there were no benefits processed and approved for payment, but not paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income/loss.

*Subsequent Events* – The Plan has evaluated subsequent events through the report date, which is the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds must publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**NOTE 3 – FAIR VALUE MEASUREMENTS, CONTINUED**

*Pooled Separate Accounts:* Accumulation Unit Values of Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equity Fund (CREF) Access account investments are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing. Accumulation Unit Value of TIAA Access are based on the value of the underlying mutual fund investments. CREF Money Market Account holdings are generally valued at amortized cost. Each fund determines its unit value each day. The TIAA Real Estate Account invests in real estate properties and real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimated of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities, as well. These are prices using values obtained from independent pricing sources. Unit values are calculated daily.

*Guaranteed Investment Contracts - NFBR:* The TIAA Traditional Non-Benefit Responsive Annuity is a not fully benefit-responsive (NFBR) investment contract and is offered through a variety of contracts, including Retirement Annuities (RAs), Group Retirement Annuities (GRAs), and Retirement Choice Annuities (RC). Units are valued based upon accumulated cash contributions, plus interest credited to the Plan's contracts, and transfers in, less any withdrawals and transfers from the Plan's contracts. The valuation is a cost-based approach. As stated above, fair value in accordance with accounting literature is the price that would be received to sell an asset, or paid to transfer a liability in an orderly transaction between market participants at the measurement date, which is a market-based approach.

TIAA asserts that, based on two theories, contract value approximates a market-based approach. A fair value estimate of this investment has not been provided to the Plan, other than on a cost-based approach. However, TIAA has used a quantitative model, using 25 years of data for this investment as a whole, to demonstrate that discounted cash flows, based upon an 81% correlation between the 10-year treasury rate and the TIAA Traditional Annuity average return, supports one of its two theories of why the contract value approximates fair value using discounted cash flows. The other theory is that participants choosing to invest in this fund, by choice, represents willing market participation and orderly transactions. Management is unable to conclude whether there may be a material difference between contract value and using a discounted cash flows model for the Plan.

The following sets forth the restriction pertaining to certain investments in the Plan:

*CREF Accounts* – Accumulation units in CREF Accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business. In an effort to reduce market timing and excessive trading, shareholders will not be permitted to make electronic transfers back into that same account through a purchase or exchange for 90 calendar days, if a sale/exchange, repurchase, and resale/exchange within that account is made within a 60-day period, other than for the CREF Money Market Account.

*TIAA Real Estate Account (REA)* – Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter. Although the underlying assets of the REA cannot be quickly sold and converted into liquid assets, the TIAA General Account provides the REA with a liquidity guarantee - i.e., TIAA ensures that the REA has funds available to meet participant redemption, transfer, or cash withdrawal requests executed at quoted unit values.

The Plan invests in the TIAA Traditional Annuity option, including both fully benefit-responsive and non-benefit-responsive fixed annuity contract options that are fully and unconditionally guaranteed by TIAA, an insurance company. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest between 1% and 3%, and the potential for additional interest if declared by TIAA. When the contract value accumulation is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation.

**NOTE 4 – INVESTMENT IN GUARANTEED INVESTMENT CONTRACTS (TIAA TRADITIONAL ANNUITY), CONTINUED**

TIAA issues various type of contracts as funding vehicles for retirement plans. The non-benefit-responsive contract option contains liquidity restrictions, which could impact the value realized upon exiting the contract. The RA contract does not allow lump-sum cash withdrawals unless small sum conditions are met. With the GRA contract, small sum conditions apply, lump-sum withdrawals are available only within 120 days after termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from the RA or GRA contracts must be spread over a period of 10 annual installments (or five annual installments for withdrawals after termination of employment through election of a five-year fixed-period annuity under the GRA contract). There are no liquidity restrictions on the benefit-responsive contract option.

Because a portion of the fixed annuity contract options are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits. The contract value of TIAA Traditional Annuity equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with TIAA including plan termination and other events as specified in the contract. The plan administrator does not believe that any event which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. There are no known events or conditions that will allow TIAA to terminate the contract and settle at the amount different than contract value.

**NOTE 5 – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and account balances associated with plan loans held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied by the plan administrator and certified as complete and accurate by Teachers Insurance and Annuity Association of America and College Retirement Equity Fund, the Custodians of the Plan.

**NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments were managed by TIAA and CREF. TIAA and CREF are the Custodians, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for the investment management services during the Plan's year ended December 31, 2024 were offset against earnings.

The Organization provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

Notes receivable from participants also qualify as party-in-interest transactions. All of these related-party and party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 8 – INCOME TAX STATUS**

The Plan is designed after a volume submitted 403(b) Plan which received a favorable opinion letter, dated March 31, 2017, which states that the volume submitted Plan document is acceptable under Section 403(b) of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
