### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Carithers Wallace Courtenay 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following description of the Carithers Wallace Courtenay 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Carithers Wallace Courtenay, LLC (the Company) who are age 21 or older and who have completed three months of service. Employees are eligible to enter the Plan on the first day of the month following the date the eligibility requirement is met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On April 1, 2023, the Plan was amended and the Plan name changed from the Carithers Wallace Courtenay, LLC 401(k) Retirement Plan to the Carithers Wallace Courtenay 401(k) Retirement Plan.

#### Contributions

Participants may elect to make pre-tax and/or Roth contributions up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus catch-up contributions of \$7,500 for those qualifying participants who are at least 50 years of age by the end of the Plan year. All employees are automatically enrolled in the Plan at a rate of 4% upon satisfying the eligibility requirements unless they specifically opt out of the Plan or opt to change their contribution rate. The contributions will be invested in a default portfolio model, based on the participant's estimated years to retirement, unless the participant directs otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make discretionary matching contributions to eligible participants. For the year ended December 31, 2024, the Company made discretionary matching contributions to participants in an amount equal to 50% of the participant's contribution to the extent participant contributions did not exceed 6% of the participant's eligible compensation.

The Company may also make a discretionary profit-sharing contribution to eligible participants. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings on the investments in their account. Each participant's account is charged with withdrawals, losses on the investments in their account, and certain

administrative expenses. Participants direct the investment of their account into various options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings and losses thereon. Vesting in the Company's discretionary matching and profit-sharing contributions portion of their account is based on years of continuous service. A participant is 100% vested after five years of service beginning with 25% in year two and 25% each year thereafter.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$35,756, respectively. These accounts can be used to pay administrative expenses or to reduce Company contributions. During 2024, the Company experienced additions of \$48,699 to the forfeiture account and used forfeitures of \$24,319 to pay plan administrative expenses, \$0 to reduce the Company's contributions, and \$60,136 to reissue a stale distribution check that was previously applied to forfeitures.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and bear an interest rate equal to the prime rate plus 1% as of the first day of the calendar quarter in which the note is granted, as defined in the Plan document. During 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the notes, not to exceed 5 years, or 30 years if used for the purchase of a residence. Principal and interest are paid through payroll deductions. Notes receivable from participants qualify as party-in-interest transactions.

### **Payment of Benefits**

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution. In-service withdrawals are also permitted for participants who have attained age 59½. The participant's contributions may also be withdrawn for certain hardship situations.

### **Administrative Expenses**

The Plan document permits certain administrative expenses to be paid by the Plan. Administrative fees paid by participants include loan initiation fees and distribution fees. Additionally, standard asset-based fees are charged directly against participant accounts and are included in administrative expenses reported in the statement of changes in net assets available for benefits.

These standard asset-based fees are allocated to the participants' accounts based on the market value of the funds in which they are invested. All other expenses are paid by the Company. The Company does not expect reimbursement from the Plan for these expenses. These expenses are paid to a service provider of the Plan and, therefore, qualify as party-in-interest transactions.

The Plan has an ERISA account where a service provider of the Plan, Transamerica Life Insurance Company, deposits revenue sharing payments that can be used either to pay Plan administrative expenses or be allocated to participant accounts. During 2024, amounts of \$29,216 were deposited into the account, which were used to pay administrative expenses. Deposits to this account are included in net changes in fair value of investments in the accompanying statement of changes in net assets available for benefits. Payments from this account are included in administrative expenses in the year paid. The ERISA account had no available balance at December 31, 2024 and 2023.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of the employee's contributions from the participant's paycheck. The discretionary matching contributions, when approved by the administrative committee, are considered payable to the Plan when the related participant's contributions are payable to the Plan. Discretionary profit-sharing contributions are payable to the Plan after approval by the administrative committee.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification ASC 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer receivables. The Company determined that no allowance for credit losses was necessary as of December 31, 2023.

### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. See Note 4 for a discussion of fair value measurements.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

### Excess Contributions Payable

Accounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service were recorded as a liability with a corresponding reduction to participant contributions. The Plan distributed the 2023 excess contributions of \$38,961 to the applicable participants in June 2024.

### Payment of Benefits

Benefit payments are recorded when paid.

### Subsequent Events

Effective January 1, 2025, the Plan was amended to allow the employees of Mason, a CWC Company, a wholly-owned subsidiary of the Company, to participate in the Plan. Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 25, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan's qualified institution.

### 4. Investments

Investments are exposed to several risks, such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1) that the Plan has the ability to access.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company contributions.

### 6. Income Tax Status

The Plan uses a volume submitter 401(k) profit sharing plan created by Transamerica Retirement Solutions LLC (Transamerica). The Internal Revenue Service has determined and informed Transamerica by a letter dated June 30, 2020, that the prototype plan is designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has not received an individual determination letter and has been amended since the opinion letter was issued, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and could change upon examination.
