Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Robinson Export Import Corporation Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- The information in the 2024 financial statements, referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Notes to Financial Statements

1. Plan Description

The following description of the Robinson Export Import Corporation (the “Company”) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which qualifies under section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan generally allows employees who have attained 18 years of age and have attained 90 days of service to participate.

The custodian of the Plan is Principal Life Insurance Company, Inc. (Principal) who is responsible for holding Plan assets. Principal also serves as the Plan record keeper. Individuals of the Company serve as the Plan's trustees.

Participant Contributions

Each year, participants may make salary reduction contributions up to 100% of pretax annual compensation subject to the limitations of the IRC, as defined in the Plan.

The Plan allows participants to make Roth 401(k) contributions. The additional Roth contribution does not allow total employee's contributions to the Plan above the dollar limits of 401(k) contributions for the year.

Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as rollover contributions. Participants are immediately vested in their salary reduction and rollover contributions plus actual earnings thereon.

Participants are automatically enrolled in the Plan with a 2% salary deferral, unless a different salary deferral percentage is elected.

Company Contributions

- Annual Discretionary Matching Contributions – The Company has the option to make annual discretionary matching contributions to the Plan. The percentage of elective deferral contributions matched, if any, shall be a percentage determined by the Company and shall apply to all eligible persons for the entire Plan year. Contributions, when made, are allocated based upon a percentage of each participant's deferral. For the year ended December 31, 2024, the Company matched 100% of the first 2% of each participant's salary reduction contribution.
- Profit Sharing Contributions – The Company has the option to make annual non-elective contributions to the Plan. A participant must complete at least 1,000 hours of service by the beginning of the Plan year to be eligible for this discretionary employer contribution. Non-elective employer contributions made to the Plan are allocated to the participant's account based on an integrated allocation formula. For the year ended December 31, 2024, no such contributions were made.

Notes to Financial Statements

Vesting in the Company contributions (plus earnings thereon) is based on years of continuous service. Company contributions vest by 20% after completion of the first two years of service and vest an additional 20% per year thereafter until fully vested after six years. Participants also become fully vested on the date they reach normal retirement age, become totally disabled (as defined by the Plan), or death.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant can only have one loan outstanding at any time. All loans must be approved by the Plan administrator and will bear interest at a rate commensurate with local prevailing rates. Interest rates on participant loans ranged from 5.25% to 10.50%. Loans are secured by the balance in the participant's account and require periodic payments and are due through June 4, 2054.

Payment of Benefits

Participants are eligible for retirement benefits upon attaining the age of 65 or early retirement defined as age 59 1/2. On termination of service due to death, disability or retirement, a participant can receive an amount equal to the vested portion of the participant's account in a lump-sum amount, installment payments, or an annuity over the applicable life expectancy or term-certain period. For termination of service for other reasons, a participant may receive the value of the vested portion in the participant's account as a lump-sum distribution or elect a direct rollover distribution. However, if the total value of the vested balance is \$5,000 or less, the entire vested balance will be distributed in a lump-sum payment. Benefit payments to participants are recorded when paid.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution, rollovers (transfers in from other qualified plans), the Company discretionary matching contribution (if any), and allocations of (a) the Company discretionary profit-sharing contributions (if any), (b) Plan earnings, (c) realized and unrealized gains and losses on investments, and (d) an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants are afforded several investment options covering a wide range of investment objectives and risks. Participants may allocate their contributions across these options in any proportion they wish and can change this allocation at any time. Transfers of account balances between elected investment options may also be made at any time.

Forfeited Accounts

Terminating participants forfeit the non-vested portion of the participant's Company contributions. Forfeitures can be allocated to participant accounts based on participant earnings, as defined, used to reduce the Company's administrative expenses to the Plan, or used to reduce the Company's Plan contributions. For the year ended December 31, 2024, \$10,437 of forfeitures were applied to reduce the Company's Plan contributions and \$2,953 of forfeitures were applied to reduce administrative expenses. On December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4 and \$-0-, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Administrative Expenses

The Company may elect to pay the administrative expenses of the Plan. If not paid by the Company, administrative expenses are required to be paid by the Plan. All such costs and expenses will, unless allocable to the accounts of particular participants, be charged against the accounts of all participants on a pro-rata basis or in such other reasonable manner as may be directed by the Plan. In addition, certain accounting and administrative functions of the Plan are performed by employees of the Company at no cost to the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the Plan year or at the time of

purchase during the Plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company, both qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, net and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The hierarchy comprises 3 levels of inputs that may be used to measure fair value.

Valuation techniques used to measure fair value are defined as follows:

- Level 1: Fair values are based on quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date.

- Level 2: Fair values are based on inputs other than quoted price included within level 1 that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.
- Level 3: Fair values are based on unobservable inputs used for valuing the asset or liability. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. An example could be real estate valuations, which require significant judgment.

The following is a description of the valuation methodology used for assets measured at fair value:

- Mutual funds ("RIC"): Shares held by the Plan are valued at unadjusted quoted market prices in an active market.
- Pooled separate accounts ("PSA"): The net asset value ("NAV") of a separate account is not publicly quoted but is available to current investors via the Company's website or when Plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, these investments have a "Readily Determinable Fair Value". The NAV is calculated in a manner consistent with GAAP for investment companies. Because it is valued similarly to mutual funds the PSA are valued as a level 1 asset.
- Common collective trusts ("CIT"): Investments held by a CIT are required to be reported at fair value. The fair values of these investments are used in determining the NAV of the CIT, which are not publicly quoted but are available to current investors via the Company's website or when Plan participants access their account values. The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date. Therefore, these investments have a "Readily Determinable Fair Value". The NAV is calculated in a manner consistent with GAAP for investment companies. Because it is valued similarly to mutual funds, the CIT are valued as a level 1 asset.

With the exception of the U.S. Bond Separate Account and U.S. Property Separate Account, PSA transfers and payments are generally processed within seven business days; however, Principal has the right to take up to 270 days to process transfers and payments and to restrict the rights for redemptions at any time. Transfers and payments for the U.S. Bond Separate Account can take up to 90 days to process, and the U.S. Property Separate Account can take up to 3 years.

5. Excess Contributions Payable

On December 31, 2024 and 2023, payables of \$7,096 and \$26,059, respectively, were recorded for amounts refundable by the Plan and paid to participants in 2025 and 2024, respectively, for contributions made in excess of amounts allowed by the Internal Revenue Service.

6. Party-in-Interest Transactions

The Plan has not considered participant contributions or benefits accrued or paid by the Plan for participants as party-in-interest transactions. Certain Plan investments are mutual funds, common collective trusts, and pooled separate accounts managed by Principal. Such transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. Fees paid during the year for professional services rendered by parties-in-interest were based on customary and reasonable rates for such services. Participant loan origination fees are paid out of the relevant participant's account.

7. Income Tax Status

The Company adopted a prototype standardized profit-sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the IRC, and therefore, is not subject to tax under present federal income tax laws.

Management evaluated the Plan's tax positions under guidance from the Financial Accounting Standards Board and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.
