Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hirschler Fleischer, A Professional Corporation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Notes to Financial Statements

1. Description of Plan:

The following description of the Hirschler Fleischer, A Professional Corporation Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Hirschler Fleischer, A Professional Corporation (the "Company"). Employees become eligible to participate and receive Company profit sharing and safe harbor contributions following the later of (1) the employee's completion of six months of service or (2) attaining age twenty-one. Employees are eligible for entry into the Plan immediately upon satisfying the eligibility requirements. In addition, eligible employees are automatically enrolled in the Plan with employee deferrals of four percent of eligible compensation. The deferral percentage will automatically increase annually by two percent, on the anniversary of the participant's date of hire, until a maximum of ten percent is reached. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan document, subject to Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan provides for Company Safe Harbor matching contributions equal to 100% of the participant's first 3% of eligible compensation. The Company may also provide a discretionary profit sharing contribution, to be allocated based on each participant's compensation. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Company's safe harbor contribution, (b) the Company's profit sharing contribution and (c) plan earnings (losses), and charged with an allocation of administrative expenses and transaction fees (distribution fees and recordkeeping fees), where applicable. Allocations are based on participant's earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting: Vesting in the Company's discretionary profit sharing contribution is based on years of service, as defined in the Plan's provisions. A participant is 100 percent vested after six years of credited service.

Investment Options: Participants may direct the investment of their account balances in accordance with guidelines established by the Plan. The Plan currently offers mutual funds and a common/collective trust fund as investment options for participants.

1. Description of Plan, Continued:

Payment of Benefits: Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, death, disability, or retirement, as defined in the Plan. Participants are entitled to receive either a lump-sum payment amount or installments, as provided by the Plan, in amounts equal to the vested value of their account.

In-service distributions of employee contributions are available after the participant reaches age 59.5 years. A participant may request a distribution of matching, safe harbor and profit sharing contributions even if still employed, as long as they have reached the age of 65 and have participated in the Plan for at least 5 years.

Forfeitures: Forfeited balances of participants' non-vested accounts are used to reduce future Company contributions or pay plan administrative expenses. Forfeitures were \$38,426 in 2024. Forfeitures used to reduce Company contributions and fees were \$35,780 for 2024. Forfeited balances available were \$10,575 at December 31, 2024 and \$7,929 at December 31, 2023.

Plan Administration: Participants' accounts invested with Vanguard Fiduciary Trust Company are administered by the Retirement Committee of the Board of Directors of the Company. Vanguard Fiduciary Trust Company serves as trustee of the Plan.

Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (distribution fees and recordkeeping fees) are charged directly to the participant's account.

2. Summary of Significant Accounting Policies:

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies, Continued:

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent Events: Management has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

3. Fair Value Measurements:

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. Fair Value Measurements, Continued:

Collective Trust Fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the Common/Collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no Level 2 or 3 assets or liabilities in the Plan as of December 31, 2024 and 2023.

4. Administrative Expenses:

The Plan paid administration expenses in the amount of \$101,338 during 2024. Although not required by the Plan, some of the costs of the Plan administration are absorbed by the Company.

5. Related Party Transactions:

The Plan invests in shares of mutual funds and a common/collective trust fund managed by affiliates of the trustee. These are related party transactions and are identified as parties-in-interest in the accompanying schedule of assets (held at end of year). The Plan paid administrative fees to the trustee totaling \$23,238 during 2024. The Plan paid administrative expenses to other parties-in-interest totaling \$78,100 during 2024.

6. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Risks and Uncertainties:

The Plan provides for investments in various securities. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

8. Tax Status:

The Internal Revenue Service has informed the prototype sponsor by a letter dated June 30, 2020 that the adopted prototype plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "Code"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and operated in accordance with ERISA.

Management has evaluated the effect of FASB guidance surrounding uncertain income tax positions and concluded that the Plan has no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.
