### Statement of Reasonable Cause for Omission of Independent Auditor's Opinion

The purpose of this document is to explain why no Auditor's Opinion (as described in Part III of Schedule H) is attached to this Form 5500 Return. The experience of my ERISA counsel has been that the Office of the Chief Accountant does not take enforcement action for the absence of an attached Auditor's Opinion under certain limited circumstances which he believes are present here. Immediately below are our facts.

1. On May 14, 2023, Cox Operating, L.L.C. – the Plan Sponsor - and various affiliated entities, each filed a voluntary petition under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court, for the Southern District of Texas, Houston Divisions (the "Bankruptcy Court"), and administratively consolidated under Case Number 23-90324 (the "Bankruptcy Cases"). On February 29, 2024, the Bankruptcy Cases were converted to Cases Under Chapter 7 of the Bankruptcy Code. On May 6, 2024, the Bankruptcy Court entered an Order confirming the election of Michael D. Warner as permanent Chapter 7 Trustee (the "Trustee"), subject to qualification under Bankruptcy Code Section 322. Docket No. 1919. On May 8, 2024, Michael D. Warner filed a Notice of Bond and Acceptance of Election, thus qualifying as trustee under the Bankruptcy Court's May 6, 2024, Order, and is now the duly elected and qualified Chapter 7 Trustee of the Bankruptcy Cases. Docket No. 1996. On August 23, 2024, the Trustee filed his *Motion for Authority to (i) Employ Special ERISA Counsel and (ii) Terminate 401(k) Plan* (the "Termination Motion"). Docket No. 2182. On September 17, 2024, the Bankruptcy Court entered its Order Granting the Termination Motion (the "Termination Order"). Docket No. 2113. The Termination Order provides, in pertinent part: "The Trustee is hereby authorized to (a) wind down/terminate the 401(k) Plan, (b) allow and direct any custodian of funds to execute and file documents related to the 401(k) Plan, to establish missing participant IRA accounts with appropriate entities, as well as distribute funds to the owner thereof; and (c) execute and file any and all documents necessary to effectuate the foregoing. Termination Order ¶ 3.
2. The plan assets are held at Empower. My ERISA counsel has reviewed the transaction histories and other financial information and represents to me they appear to be in good order. That said, neither of us have personal knowledge of any plan related transactions.
3. The cost and expense of an independent auditor's work would be borne solely by the Plan, as the Bankruptcy Cases do not have sufficient funds to address such costs, and such costs would likely not be considered a benefit to the Bankruptcy Cases.
4. The process of terminating this plan and distributing plan assets to participants has commenced.

For these reasons, I respectfully submit that reasonable cause exists for a determination that no independent auditor's opinion need be attached to the Form 5500 filed in connection with this plan.
