We have performed audits of the financial statements of the BestCo LLC Profit-Sharing Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of the Plan**

The following brief description of the BestCo LLC Profit-Sharing Retirement Plan and Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of BestCo LLC (the “Company”), except for leased employees, independent contractors, student interns and employees of affiliated companies. All full-time employees of the Company are eligible to participate in the Plan after one hour of service and attainment of 18 years of age. In addition, part time employees who attain 1,000 hours of service are eligible to participate in the Plan. The Investment Committee controls and manages the operation and administration of the Plan. Empower Trust Company, LLC and Empower Annuity Insurance Company of America (“Empower”), together, serve as the custodian of the Plan (the “custodian”). The Plan is subject to the provisions of ERISA.

***Contributions***

The Plan allows participants to contribute up to 60 percent of their pre-tax compensation and provides for auto-enrollment of 3 percent of participant compensation upon attaining eligibility requirements. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company’s matching contributions are a combination of Safe Harbor matching and discretionary. For the period ended May 23, 2024 and the year ended December 31, 2023, the Company contributed a Safe Harbor matching contribution equal to 100 percent of the first 3 percent, plus 50 percent of the next 2 percent of the participant’s compensation, as defined by the Plan. In addition, the Company may make additional contributions at the discretion of the Board of Directors. No discretionary contributions were made for the period ended May 23, 2024 and the year ended December 31, 2023. Contributions are subject to certain limitations.

***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a guaranteed investment contract as an investment option for participants.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s matching and discretionary contributions, and an allocation of plan earnings, and charged with benefit payments, transactions fees related to participant loans, plan losses and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Payment of Benefits***

For termination of service due to death, disability, retirement or separation, each participant has the option of receiving a lump-sum payment, installment payments, or various annuity options at the participant’s discretion. Hardship distributions are allowed up to 100 percent of the participant’s contribution balance. The Plan restricts hardship distributions to a \$500 minimum.

A participant may elect to leave their balance in the Plan after termination, if their vested balance exceeds \$1,000. Participants with vested account balances less than \$1,000 may receive an involuntary lump-sum distribution upon termination of employment at the Company’s discretion.

***Vesting***

Participants are immediately vested in their contributions, including rollovers, if any, plus actual earnings thereon. Participants completing one hour of service are fully vested in the Company's Safe Harbor contributions.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account, shall bear interest at a reasonable rate, and be repaid over a period not to exceed five years, unless the loan is taken for the purchase of a primary residence. A participant may have only one loan outstanding at a given time.

***Forfeitures***

Upon termination of the participant's employment for any reason other than retirement, death, or disability, the unvested portion of the participant's account will be forfeited. Forfeited discretionary matching contributions are used to reduce employer contributions. Forfeited discretionary profit-sharing contributions are reallocated to eligible participants' accounts.

During the period ended May 23, 2024 and the year ended December 31, 2023, forfeited nonvested accounts totaled \$0. During the period ended May 23, 2024 and the year ended December 31, 2023, no amount of forfeitures were used to reduce Company contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the liquidation basis of accounting, consistent with terminated plans, as of and for the period ended May 23, 2024, in conformity with accounting principles generally accepted in the United States of America ("GAAP"). There were no material differences between the liquidation basis of accounting and the ongoing basis of accounting.

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at contract value. Plan management determines the Plan's valuation policies utilizing information provided by the trustee and custodians. See Note 3 for discussion of the Plan's investments reported at contract value.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest (expense) income from notes receivable from participants is recorded when received. Other interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest (expense) income is recorded on an accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid directly by the Company. These administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (participant loans) are charged directly to the participant's account.

**Note 3. Fully Benefit-Responsive Investment Contracts**

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 1.04%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

**Note 5. Exempt Party-In-Interest Transactions**

Certain Plan investments are managed by Empower, the trustee. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the trustees by the Plan for administrative services were \$0 for the period ended May 23, 2024 and \$17,890 for the year ended December 31, 2023, respectively. Fees paid to an unrelated investment advisor were \$1,150 for the period ended May 23, 2024 and \$51,187 for the year ended December 31, 2023.

**Note 6. Plan Termination and Plan Merger**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts

On May 23, 2024, the Plan was merged into the SCN BestCo 401(k) Plan. Participants' accounts in the Plan were rolled into to the SCN BestCo 401(k) Plan as of that date.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated May 20, 2015 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.
