Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

(1) Description of the Plan

The following description of the Enstall US Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

- A. General** – The Plan was adopted and became effective for participation on January 1, 2018. Effective September 1, 2023, the Plan was amended to change the name of the Plan to Enstall US Inc. 401(k) Profit Sharing Plan. Previously, the name of the Plan was ESDEC, Inc. 401(k) Profit Sharing Plan and Trust. The Plan is a defined contribution 401(k) and profit sharing plan covering all eligible employees of Enstall US Inc., PanelClaw, Inc., Ironridge, Inc., and EcoFasten Solar, LLC (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company serves as the Plan Administrator. The recordkeeper and custodian of the Plan is Voya Retirement Insurance and Annuity Company ("Voya").
- B. Eligibility** – Under the provisions of the Plan, each employee shall be eligible to become a participant in and enter the Plan on their date of hire. The employee need not meet a minimum age requirement or perform a minimum amount of service to become eligible to make elective deferrals or receive allocations of employer matching contributions. To be eligible for employer profit sharing contributions, participants must be age 21 or older and perform at least one year of service, as defined by the Plan document.
- C. Contributions** – Participants may contribute a portion of their eligible compensation on a before-tax basis and an after-tax basis, using the Roth 401(k) option, up to the maximum percentage allowable by the Internal Revenue Code. Under the Plan's automatic enrollment feature, newly eligible participants are automatically enrolled in the Plan, and 5% of the participant's compensation is contributed on a pre-tax basis unless another election is made by the participant. Participant contributions under the automatic enrollment feature are invested in the default fund unless the participant chooses another investment option. The default fund is the Target Date Retirement Fund based on the participant's age.

The Plan provides a safe harbor employer matching contribution equal to a percentage of the participant's compensation. The safe harbor match is equal to 100% of the amount of the participant's contribution, up to 3% of the participant's eligible compensation and 50% of the participant's contributions above 3% up to a maximum of 5% of eligible compensation. Additional matching employer contributions up to 4% of eligible participant compensation may be contributed at the discretion of the Company. There were no discretionary matching employer contributions made by the Company for the year ended December 31, 2024. Additionally, the Company may elect to make discretionary profit sharing contributions. There were no discretionary profit sharing contributions made by the Company for the year ended December 31, 2024.

Participants may also roll over contributions from prior employer qualified tax deferred retirement accounts.

- D. Vesting** – Participants are 100% vested in their contributions and safe harbor employer matching contributions plus the actual earnings thereon. Vesting in additional matching employer contribution portion of their accounts and discretionary profit sharing contributions plus earnings thereon is subject to a graded vesting schedule. A participant is vested after six years of credited service.

(1) Description of the Plan (continued)

- E. Participant accounts** – All investment options are participant-directed. A separate account is maintained for each investment option of a participant by type of contribution. Each participant's account is credited with the participant's contributions, safe harbor employer matching contributions, discretionary matching contributions, allocations of Plan earnings and discretionary profit-sharing contributions, and charged with an allocation of administrative expenses. Plan earnings are allocated and credited to the account daily based on the adjusted balance of each participant's account. The benefit to which a participant is entitled is the benefit from the participant's vested account.
- F. Investment options** – Participants may direct their contributions and the Company's contributions into various investment choices provided by the Plan. These options include mutual funds and a common collective trust. Additionally, participants may transfer funds between investments.
- G. Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000. Loan terms can be no longer than five years, or up to twenty years subject to the Plan Administrator's discretion, for the purchase of a primary residence. The loans are collateralized by a maximum of 50% of the vested balance in the participant's account and bear interest at a rate of prime + 2%. Principal and interest are paid ratably through payroll deductions. The interest rate for participant loans outstanding at December 31, 2024 ranged from 5.25% to 10.50%.
- H. Payment of benefits** – In the case of a normal retirement, permanent disability or termination of employment, participants may elect to receive the value of their account balance in a lump sum, in accordance with the provisions of the Plan. In the event that a participant dies before retirement, his or her beneficiary will receive the value of the participant's account balance in a lump-sum distribution, less the value of outstanding loans made to the participant. Participants qualifying for a hardship withdrawal may receive all or a portion of their contributions, plus investment return earned thereon, but not more than the amount necessary to meet the financial hardship.
- I. Forfeitures** – At December 31, 2024 and 2023, forfeited nonvested accounts were not material. These accounts may be used to pay administrative expenses or reduce future employer contributions. During 2024, there were no material forfeited nonvested accounts used for either purpose.
- J. Administrative expenses** – Plan participants pay substantially all costs associated with the Plan including certain investment expenses such as fund withdrawal fees, which are deducted from the respective participant's account, including fees which are paid by the account of the participant taking a loan. Investment management related expenses, account maintenance costs, and fees related to the administration of notes receivable from participants are included in administrative expenses (Note 6).
- K. Plan termination** – Although it has not expressed an intention to do so, the Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested.

(2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. Accordingly, income is recognized when earned and expenses are recorded when incurred.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The following is a description of the valuation methodologies used for the investments held by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds: The Plan's mutual fund investments are stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Investment in common collective trust: The Plan's investment in the common collective trust is stated at unit value, or the equivalent of net asset value, which is a practical expedient for estimating the fair value of the investment. The common collective trust has no unfunded commitments as of December 31, 2024 and 2023, and can be redeemed daily with no redemption notice period or other redemption restrictions.

Risks and uncertainties – The Plan provides for various investment fund options which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of benefits – Benefit payments to participants are recorded when paid.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which approximates fair value.

Subsequent events – Plan management has evaluated subsequent events through September 5, 2025, which is the date the financial statements of the Plan were available to be issued.

(3) Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

(4) Information certified by the custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the custodian of the Plan's assets, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments
- Notes receivable from participants
- Interest and dividend income
- Net appreciation in fair value of investments
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform any audit procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(5) Income tax status

The Plan adopted a non-standardized prototype plan document (the "Prototype Plan"). The Prototype Plan received an opinion letter from the IRS dated June 30, 2020, stating that the Prototype Plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Management has not obtained an individual determination letter for the Plan. Management and the Plan Administrator believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust remains tax-exempt at December 31, 2024 and 2023. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

(6) Party-in-interest transactions

Certain Plan investments are managed by Voya. Administrative fees paid to Voya, the record keeper and custodian of the Plan, amounted to \$113,022 for the year ended December 31, 2024. Amounts paid to other service providers totaled \$5,282 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
