Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Moyle Petroleum Company Profit Sharing and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

(1) Significant Accounting Policies

Nature of Business of Plan Sponsor

Moyle Petroleum Company and its subsidiaries (the Company and the Plan Administrator) own and operate 27 Common Cents Convenience Stores, eight Super Tunnel car washes, a Kwik Lube Automotive Service Center, two Common Cents travel plazas, Inferno restaurants, and is a wholesale and retail distributor of gasoline and diesel fuel.

Basis of Accounting

The financial statements of the Moyle Petroleum Company Profit Sharing and 401(k) Plan (the Plan) are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value on a recurring basis as determined by Alerus, N.A. (the Trustee). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when received. Dividend income is recorded on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from Plan participants and the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Net Change in Fair Value

The net change in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year, and the unrealized gains and losses in securities held at the end of the year.

(1) Significant Accounting Policies

Excess Contributions Payable

Amounts payable to participants in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Significant subsequent events have been evaluated through September 22, 2025, the date which the financial statements were available for issue.

(2) Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Moyle Petroleum Company and its wholly-owned subsidiaries, (collectively the Company). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company who have completed one year of service (as defined by 1,000 hours) and have attained the age of twenty-one are eligible to participate in the Plan. Those eligible employees who are employed by the Employer on the last day of the Plan year are eligible to receive employer matching contributions. Upon meeting the Plan's eligibility requirements, employees may enter the Plan on January 1 or July 1.

Contributions

Participants may contribute up to 50 percent of their pretax annual compensation, as defined in the Plan, up to certain limits as established by the Internal Revenue Service. The Plan provides for discretionary matching contributions by the Company equal to a certain percentage of each participant's elective deferral contributions not exceeding 10 percent of their pretax annual compensation. The Plan also allows for additional discretionary profit-sharing contributions by the Company. The Company made no discretionary profit-sharing contribution for the year ended December 31, 2024. Discretionary matching contributions totaled \$196,299 during the year ended December 31, 2024. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and contributions to a Roth 401(k) account are included in the participant's gross income. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participant's Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

(2) Plan Description

Payment of Benefits

Benefit payments are made as soon as administratively feasible following the date on which a distribution request is made or is otherwise payable. Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account by either a lump-sum distribution or through installments. In the event a participant has an outstanding note balance at the time of their termination, the unpaid balance is treated as a benefit payment to that participant. On termination of service, a participant with an account balance of \$1,000 or less will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Hardship Withdrawals

Should a plan participant experience a hardship, he or she may elect to withdraw a maximum of their vested account balance less a) any outstanding loan balance and b) earnings on participant deferral contributions and employer match contributions. All cases of hardship must be presented in writing to, and approved by, the Company. The Company may request additional supporting documentation from plan participants to substantiate any case of hardship. The Company may, at its discretion, approve all or part of the withdrawal request. Hardship withdrawals are recorded as distributions in the period in which they are paid.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the employer's matching contribution, (b) the employer's profit sharing contribution, and (c) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

Participant Investment Options

Participants may direct contributions to any of the funds offered by the Plan. Participants may change their investment options as often as they wish. Participants may elect to discontinue contributions at any time.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earnings (losses) thereon is based on years of credited service. A participant becomes 20 percent vested after two years of credited service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after six years of credited service, or if less than six years, upon reaching normal retirement age, total disability, death, or upon termination of the plan.

Participant Notes Receivable

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1-5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent established at the time the loan is made. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as participant notes receivable in the financial statements of a defined contribution plan, measured at the outstanding principal amount plus accrued but unpaid interest.

(2) Plan Description

Forfeitures

Forfeited, non-vested account balances totaled \$3,595 and \$1,327 at December 31, 2024 and 2023, respectively. Non-vested account balances are forfeited, unless participants return to employment and contribute the distribution received at termination within a specified time. The Plan allocates forfeitures to reduce future employer contributions. Forfeitures of \$1,200 were used to reduce the 2024 employer contributions.

Administrative Expenses

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. The Company has, at its discretion, absorbed certain other administrative expenses pertaining to the Plan. If not paid by the Company, these administrative expenses become the responsibility of the Plan.

(3) Information Certified by Trustee

The Trustee holds the Plan's investments, executes investment transactions, and performs all related accounting functions. The Trustee determined the fair value of investments at December 31, 2024 and 2023.

The Plan is administered by the Company. Alerus Financial N.A. is the Trustee for the years ended December 31, 2024 and 2023. The Plan investments are held and managed by the Trustee.

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended December 31, 2024 and 2023. Information contained in the following has been certified by the Trustee:

- Statements of Net Assets Available for Benefits (except for employer contribution receivable, participant notes receivable, and liabilities)
- Statement of Changes in Net Assets Available for Benefits (except for Contributions, Benefits Paid to Participants, and Administrative Expenses)
- Supplemental Schedule of Assets Held at End of Year (except for participant notes receivable)

The Plan primarily invests in mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed since December 31, 2024.

(4) Income Tax Status

The Plan has adopted a non-standardized form of prototype plan sponsored by Alerus Financial, N.A. The prototype plan has received a determination letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan determination letter has been relied upon by this Plan. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

(4) Income Tax Status

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their entire account.

(6) Participant Withdrawals

Vested, undistributed, account balances of separated Plan participants total approximately \$3,118,000 and \$2,898,000 at December 31, 2024 and 2023, respectively.

(7) Recurring Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: inputs include:
 1. quoted prices for similar assets or liabilities in active markets;
 2. quoted prices for identical or similar assets or liabilities in inactive markets;
 3. inputs other than quoted prices that are observable for the asset or liability;
 4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 inputs must be observable for substantially the full term of the asset or liability
- Level Three: inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following tables present the assets carried at fair value as of December 31, 2024 and 2023, respectively, in the accompanying statements of net assets available for benefits by fair value hierarchy, as described above.

The following methods and assumptions were used to determine fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at net asset value which is equivalent of \$1 per share.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(8) Related Party Transactions

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. The Plan allows participants to take out loans against their account balances.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
