Opinion

We have audited the financial statements of the Duquesne Family Office LLC Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Notes to the Financial Statements

1. Description of the Plan

The following description of the Duquesne Family Office LLC Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering substantially all employees of Duquesne Family Office LLC, Duquesne Fund Services LLC, and employees of Lost Tree Corporation if they are employed at Lost Tree Corporation's Florida location and their employment first commenced before February 1, 2016 (collectively, the Company). The Plan was effective as of January 1, 2011.

Employees of the Company become eligible to participate in the Plan upon attainment of age twenty-one. Participation in the Plan for purposes of the discretionary profit sharing contribution requires completion of 1,000 hours of service during the plan year and employment on the last day of the plan year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employer contributions are at the discretion of the Company's management. Effective November 1, 2023, participants may rollover into the Plan contributions received from another qualified plan or individual retirement plan.

Participant Accounts

Each participant's account is credited with an allocation of plan earnings and the Company's discretionary contribution, if any. Allocations of the Company's contributions are based on employee compensation. Allocations of plan earnings are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the Company's discretionary contributions and actual earnings thereon.

Payment of Benefits

Upon termination of service due to retirement at or after attaining normal retirement age, 65, or disability, a participant with a vested account balance greater than \$1,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or a series of installment payments over a period not to exceed the life expectancy of the participant or the life expectancy of the participant and their designated beneficiary. Retired or disabled participants with vested account balances of less than \$1,000 will receive a lump-sum payment.

Notes to the Financial Statements (Continued)

1. Description of the Plan (Continued)

Payment of Benefits (Continued)

If a participant dies with a vested account balance greater than \$5,000 before payment of benefits, the participant's beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or a series of installment payments over a period not to exceed the life expectancy of the participant's designated beneficiary. Vested account balances of less than \$5,000 will be distributed to the beneficiary in a lump-sum payment.

A participant who terminates service for a reason other than retirement at or after attaining normal retirement age, disability or death with a vested account balance greater than \$1,000 may elect, prior to attaining normal retirement age, to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Terminated employees with vested account balances of less than \$1,000 will automatically receive a lump-sum distribution.

In December 2024, participants requested distributions from the Plan but had not been paid as of December 31, 2024. The full withdrawal amount of \$552,838 was funded with cash, including cash received from the Receivable from No Margin, in January 2025.

In December 2023, participants requested distributions from the Plan but had not been paid as of December 31, 2023. The full withdrawal amount of \$9,934,859 was funded with cash, including cash received from the Receivable from No Margin, in January 2024.

Notes Receivable From Participants

Participants may borrow from their plan accounts a minimum of \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000, reduced by the highest outstanding loan balance in the previous 12 months. Repayment terms generally may not exceed five years, however, a loan may be repaid over a term which is greater than five years but less than 10 years if the loan is used to acquire the participant's primary residence. Plan participants are limited to one outstanding borrowing at a time.

In the event of default, as described by the Plan, participants are considered to have received a distribution and are subject to income taxes on the distributed amount.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants would remain 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Risks

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements of assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - Observable inputs such as quoted prices in active markets for identical investments that the Plan has the ability to access.

Level 2 - Inputs include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs, other than quoted prices in active markets, that are observable either directly or indirectly;
- d. Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

Level 3 - Unobservable inputs in which there is little or no market activity for the asset or liability, which require the reporting entity to develop its own estimates and assumptions relating to the pricing of the asset or liability including assumptions regarding risk.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the fair value hierarchy.

Investment Valuation and Risks (Continued)

The carrying value of the Plan's investment in the limited partnership is determined by the Plan's pro rata interest in the net assets of the limited partnership. The limited partnership's underlying investments in securities traded on a national securities exchange (or reported on the NASDAQ national market) are stated at the last reported sales price on the day of valuation; other securities traded in the over-the-counter market and listed securities for which no sale was reported on that date are stated at the last quoted bid price, except for short positions, for which the last quoted ask price is used. The estimated fair values of investments not traded on a public market are determined by management as determined by the investment manager of the limited partnership after giving consideration to operating results, financial conditions, recent sales prices of issuers' securities and other pertinent information. The limited partnership's objective is to seek capital appreciation. The limited partnership intends to invest in a diverse portfolio of foreign and domestic instruments including, but not limited to, commodities, commodity futures, swaps, currencies and currency forward contracts, fixed income futures contracts, fixed income securities, equities, equity-related securities, warrants and listed and over-the-counter options on the above. It is the policy of the limited partnership to accept withdrawals as of the end of each fiscal quarter of the limited partnership provided a redemption request is received by the general partner at least 30 days prior to withdrawal date or as permitted by the general partner. The investment in the limited partnership is reported at fair value and is valued using the NAV provided by the limited partnership on the last day of the Plan's year end. There are currently no unfunded commitments on the investment in the limited partnership.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain or loss includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near term could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses

Generally, administrative expenses of the Plan are paid by the Company. Administrative expenses that are not paid by the Company are paid by the Plan.

Subsequent Events

The Plan's management evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 24, 2025, the day the financial statements were approved and authorized for issue.

4. Tax Status

The Internal Revenue Service (IRS) has determined and informed the plan sponsor by a letter dated February 20, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Related Party and Parties-in-Interest

Certain plan assets are invested in a limited partnership managed by the Company. The Company does not receive any form of compensation from the Plan for these management services. These transactions qualify as party-in-interest transactions. The transactions are not, however, considered prohibited transactions under Section 408(b) of ERISA regulations.

5. Related Party and Parties-in-Interest (Continued)

Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

The Plan has notes receivable from participants subject to specific guidelines as defined in the plan document (Note 1).

These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.
