We have performed audits of the accompanying financial statements of Edison Energy Group 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Edison Energy Group 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Description of the Plan

The following description of Edison Energy Group 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the “Summary Plan Description” and the Plan document for a more complete description of the Plan’s provisions. Copies are available from the Plan Administrator.

General

The Plan is a defined contribution plan covering all eligible employees of Edison Energy Group, Inc. (the “Plan Sponsor” or the “Company”) and its subsidiaries, including Edison Energy, LLC and Altenex, LLC (the “Participating Employers”). The amended Plan was established to provide a systematic savings plan for eligible employees (the “Participants”). The Plan was established on January 1, 2017, and was amended and restated effective November 12, 2024, to comply with IRS regulations. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Sponsor has appointed an investment trustee, Fidelity Management Trust Company, to execute investment transactions, hold the Plan’s assets and administer the Participants accounts.

Eligibility

All full-time U.S. employees who have reached the age of 21 and are not part of any collective bargaining agreement become immediately eligible to participate in the Plan. Part-time, temporary, seasonal and intern employees become eligible to participate in the Plan upon both reaching the age of 21 and completing 500 hours of service at least three consecutive years.

Contributions

The Plan provides for employee pre-tax and Roth contributions. Participants may contribute up to 80% of their pre-tax eligible adjusted W-2 compensation, which includes pre-tax elective deferral contributions and does not include overtime, bonuses, commissions, severance pay, stock-based compensation and other wage adjustments.

Pre-tax contributions are subject to limitations of the lesser of 80% of eligible compensation or \$23,000 and \$22,500 under Federal law for plan years ending December 31, 2024 and 2023, respectively. The Plan also accepts certain eligible rollover contributions from other qualified retirement plans.

The Plan also provides that Participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make a catch-up contribution of the lesser of 80% of eligible compensation or \$7,500 for both Plan years ending December 31, 2024 and 2023.

Contributions (continued)

The Company provides a non-discretionary employer matching contribution. The non-discretionary employer matching contribution equals 100% of each Participant's elective deferrals up to 4% of the Participant's eligible compensation. All non-discretionary matching contributions apply to both regular and catch-up contributions and is based on annual eligible compensation. A true-up is performed annually for any missed non-discretionary matching contributions.

Vesting

Participants are immediately fully vested in their employee and employer matching contributions, rollovers and other discretionary contributions plus actual earnings thereon.

Participant Accounts

Participant's accounts are credited with their contributions and allocations of the Plan Sponsor's contributions and Plan earnings, net of any administrative expenses. Allocations are based on Participants' compensation or account balances, as defined. The benefit to which each Participant is entitled is the benefit that can be provided from the Participant's vested account.

Notes Receivable from Participants

Eligible Participants may borrow from their Plan accounts amounts attributable to the Participant's vested balance, for a maximum term of five years. If the note is for the purchase of a principal residence, the term of the note may be extended to ten years. A Participant may borrow a maximum of 50% of their eligible balance up to \$50,000, reduced by the excess of the highest outstanding note amount during the immediate preceding twelve month period over the total outstanding note balance on the date of the new note. The minimum note is \$1,000 and only two notes can be outstanding at any time. The notes receivable are secured by the balance in the Participants' accounts and the interest rates are fixed at the inception of the notes in an amount equal to the prevailing interest rates charged by persons in the business of lending money for notes under similar circumstances. The interest rate charged on notes outstanding as of December 31, 2024 ranged between 4.25% and 9.50%. Principal and interest are paid ratably through payroll deductions.

Plan Investments

The Plan's investments are held by Fidelity Management Trust Company (Fidelity), the trustee, in various mutual funds and a stable value fund. Participants have the option to allocate their individual accounts among various investment alternatives and to make transfers as specified in the Plan document.

Benefits and Withdrawals

On termination of services due to death, retirement at age 59½, or disability, the Participants or their beneficiaries may elect a distribution in an amount equal to the value of his or her vested account, either in a lump-sum distribution or in equal installments. If the Participant's account balance is less than \$1,000 the distribution will automatically be paid in a lump sum. In-service withdrawals are only allowed when the Participant reaches the age of 59½. Hardship withdrawals are allowed, with a minimum of \$500, under the provisions of the Plan, and cannot exceed the amount required to meet the immediate financial need created by the hardship.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Fair Value Measurements

FASB ASC 820-10, "*Fair Value Measurements*," applies to reported balances that are required or permitted to be measured at fair value under an existing accounting pronouncement. ASC 820-10 emphasizes that fair value is a market based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability and establishes a fair value hierarchy. The fair value hierarchy consists of three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs that utilize quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – Inputs that include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Fair values for these instruments are estimated using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows.

Level 3 – Inputs that are unobservable for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any, related market activity.

In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual Funds are valued at their quoted market price, which represents the net asset value of shares held by the Plan at year end.
- Common Collective Trust Funds are valued at NAV of units, as provided by the trustee and used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The portfolio attempts to obtain prices from one or more third party pricing vendors or brokers to value its investments and when current market prices or quotations are not readily available or reliable, securities will be valued in good faith. Factors used in determining value vary by security type and may include market or security specific events, changes in interest rates and credit quality.
- The Stable Value Fund is a fully benefit-responsive asset fund that is backed by a diversified portfolio of fixed-income assets and is held in the general account of the issuer. The fund is stated at contract value, which also approximates fair value, and is based on the current interest rates credited to the contract, less any contingent deferred sales charges.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from Participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is reported on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make repayments and the Plan Administrator deems the Participant loan to be in default, the Participant's notes receivable balance is reduced and a benefit payment is recorded.

Contributions

Contributions from the Plan Sponsor accrued, if applicable, is based upon the contribution formula. Participants' contributions are recorded in the period in which their payroll deductions are withheld.

Benefits Paid Directly to Participants

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from Participants and benefits paid to Participants are charged directly to the Participant's account and are included in administrative expenses when they are incurred. Investment-related expenses are included in net appreciation of fair value of investments.

Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Note 3 – Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 – Fair Value of Investments (continued)

*In accordance with Subtopic 820-10 (see Note 2), certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

For the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold during the year) appreciated in value by \$3,025,423.

Note 5 – Stable Value Fund Contract with Insurance Company

The Plan entered into a fully benefit-responsive stable value fund contract with Lincoln National Life Insurance Company ("Lincoln"). Lincoln maintains all investment contributions in a general account. The account is credited with earnings on the underlying investments and charged for Participant withdrawals and administrative expenses. The stable value fund contract issuer is contractually obligated to repay the principal and a specified rate that is guaranteed to the Plan.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported by Lincoln, represents contributions made under the contract, plus earnings, less Participant withdrawals, administrative expenses and contingent deferred sales charges. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$168,022 and \$161,058, respectively.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan, (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under common control with the employer, (3) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business, (4) removal from the Plan of one or more groups or classifications of participants, (5) partial or complete Plan and contract termination of the contract; or (6) Plan disqualification. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

Note 6 – Exempt Party-in-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Certain Plan investments include shares of funds managed by Fidelity. Fidelity was also the investment trustee during the Plan year, as defined by the Plan, therefore, transactions executed by the trustee qualifies as party-in-interest transactions. Fees are also paid by the Plan and its Sponsor for investment management fees and services.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 – Tax Status

The Plan has obtained an opinion letter, issued to FMR, LLC (Parent of Fidelity Management Trust Company, the Plan's trustee) from the IRS dated June 30, 2020, stating that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA is acceptable under section 401 of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8 – Tax Status (continued)

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law which includes the package of retirement provisions referred to as SECURE 2.0. These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine which optional provisions to elect.

On November 12, 2024, the Plan elected to add new optional withdrawal elections available through the 2019 SECURE Act and SECURE 2.0. The Plan now offers penalty-free distributions to participants experiencing domestic abuse, major disasters, incurred personal emergency expenses and to cover qualified birth or adoption expenses. The distribution types are each subject to certain dollar limitations, timing and repayment options.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, all accrued benefits shall be paid to the Participants in accordance with the provisions of the Plan.

Note 10 – Subsequent Events

FASB ASC 855-10, "*Subsequent Events*," defines further disclosure requirements for events that occur after the balance sheet date but before financial statements are issued. In accordance with ASC 855-10, the Plan's Sponsor has evaluated events subsequent to December 31, 2024 through August 28, 2025, which is the issuance date of this report. There has been no material event noted during this period that would either impact the results reflected in this report or the Plan's results going forward.
