Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. Description of the Plan

The following description of the Rady Children's Physician Management Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1996 to enable eligible employees to make pre-tax contributions to the Plan, thereby providing employees with an opportunity to accumulate funds for retirement. The Plan is a defined contribution plan established and sponsored by Rady Children's Physician Management Services, Inc. ("RCPMS"). The Plan covers substantially all employees of RCPMS and is administered by RCPMS. The Audit and Corporate Responsibility Committee is the Plan's named fiduciary for purposes of Section 402(a) of the Employee Retirement Income Security Act of 1974 ("ERISA"). See Note 9.

Eligibility

Any employee, excluding a resident of Puerto Rico, nonresident aliens who have no United States income, and leased employees, who has completed 6 months of service and is 21 years of age is eligible to participate in the Plan. Eligible new employees are automatically enrolled in the Plan with a 5% pre-tax deduction unless they elect to opt out.

Contributions

Participants may elect to have RCPMS contribute up to 100% of their eligible compensation to the Plan in the form of pre-tax or Roth deferrals, up to the amount allowable under the Plan document and current income tax regulations. Participants who elect to have RCPMS contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with each participant's direction. Participants are also allowed to make rollover contributions into the Plan of amounts received from other tax-qualified employer-sponsored retirement plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Plan provides that RCPMS may elect to make discretionary matching contributions. For 2024 and 2023, RCPMS elected to contribute 100% of the first 3% of eligible compensation that a participant contributed to the Plan, plus 50% of the next 2% of eligible compensation contributed to the Plan by the participant. Contributions are subject to certain limitations.

Vesting

Participants immediately vest 100% in participant contributions plus actual earnings. Effective January 1, 2012, participants immediately vest 100% in employer contributions.

Allocations

Each participant's account is credited with investment earnings and an allocation of certain Plan administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms provide for note payments to be made through payroll deductions and for notes to be amortized over a reasonable period of time not to exceed five years. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Benefit payments

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of participant's vested interest in his or her account or may elect to receive a non-transferable deferred annuity contract. Participants may also request in-service withdrawals upon attainment of age 59 ½ or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met.

Plan termination

Although it has not expressed any intent to do so, RCPMS has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of income and expenses during the reporting period. Actual results could differ from estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Audit and Corporate Responsibility Committee determines the Plan's valuation policies utilizing information provided by the Plan's custodian and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by RCPMS and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the respective participants' account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described below:

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Tax Status

The Internal Revenue Service has determined that the non-standardized pre-approved profit sharing plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code and informed Fidelity Management Trust Company, the Plan custodian and trustee, of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, RCPMS believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. RCPMS has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Certain Plan assets are invested in mutual funds and a money market fund managed by Fidelity Management Trust Company, the Plan's custodian and trustee. Certain officers of RCPMS are current participants in the Plan. The Plan has notes receivable from certain of its participants. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

8. Reconciliation of Financial Statements to Schedule H of Form 5500

Net assets available for benefits and the net increase in net assets available for benefits, as reported in the financial statements, are consistent with the amounts reported in Schedule H of the Form 5500.

9. Subsequent Events

In connection with the merger of RCPMS's parent entity, Rady Children's Hospital and Health Center, with Children's HealthCare of California, effective January 1, 2025, the Audit and Corporate Responsibility Committee was recomposed to the Audit and Compliance Committee.

RCPMS has evaluated subsequent events through September 4, 2025, which is the date the financial statements were available to be issued. No other significant matters were identified for disclosure during this evaluation.
