## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Cregger Company, Inc. 401(k) Plan  
Columbia, South Carolina

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cregger Company, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### Note 1. Description of the Plan

The following description of the Cregger Company, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan established on December 31, 1982 and is offered to employees of Cregger Company, Inc. (the “Company”), the Plan Sponsor. The Company is a distributor of plumbing, lighting, electrical, HVAC, and appliance products operating 59 stores in the states of Colorado, North Carolina, South Carolina, and Georgia. During the fiscal year, Cregger purchased a supply company that had locations in Indiana, Kentucky, Ohio, and West Virginia. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Trustee and Administration of the Plan** – The trustee of the Plan is Principal Trust Company (the “Trustee”). The recordkeeper of the Plan is Principal Life Insurance Company (“Recordkeeper”). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Board of Directors of the Company is responsible for oversight of the Plan.

**Eligibility** – All employees who are at least 21 years of age and have completed 60 days of service are eligible to participate in the Plan.

**Contributions** – For the year ended December 31, 2024, participants may contribute a portion of his or her pretax annual compensation up to a maximum of \$23,000 in a calendar year. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions up to an annual amount of \$7,500 during the Plan year. Participants direct the investment of their contributions into various investment options offered by the Plan. For each Plan year, the Company has made matching contributions of 50% of the participant’s percentage contribution up to a maximum of 3% of participant compensation, and 50% of salary deferrals between 3% and 5% that a participant contributes to the Plan. The Company’s contributions are discretionary.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions, rollover contributions, and allocations of the Company’s contributions, as applicable, and Plan earnings and then charged with Plan losses and an allocation of Plan expenses. Allocations are based on participant earnings and account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participant contributions are fully vested and nonforfeitable at all times. Vesting in the Company’s matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

**Notes Receivable from Participants** – Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The loans are secured by the balance in the participants’ accounts and bear interest at a rate comparable to similar loans from commercial lending institutions. Current interest rates on outstanding loans are fixed and range from 3.25% to 9.50%. Principal and interest are collected through payroll deductions. The notes are repaid ratably through payroll deductions over a period of five years or less. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Internal Revenue Code (“IRC”).

**Payment of Benefits** – Benefits are recorded when paid. Subject to certain conditions, a participant may make withdrawals from his or her vested account balance in the Plan while employed. Upon termination of employment for any reason other than retirement (including disability or death), the total vested value of the account is distributed to the participant or the participant’s beneficiary. In the case of retirement, the participant may choose from one of the Plan’s several distribution alternatives.

**Forfeited Accounts** – Forfeiture balances were \$151 and \$6,057 at December 31, 2024 and 2023, respectively. Non-vested participant account balances of terminated participants are forfeited in the subsequent Plan year and allocated to the remaining participants as an employer contribution. Forfeitures may also be used to reduce future employer contributions to the Plan. During 2024, employer contributions were reduced by approximately \$33,000, from forfeited non-vested accounts.

**Funding** – The Company’s policy is to fund the Company match of participant deferrals within the Department of Labor’s required timeframes.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates** – The preparation of the financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates. The most significant estimate affecting the Plan is the fair value of the investments.

**Concentrations of Credit Risk** - All Plan assets are invested with the Trustee. Such investments are subject to credit and market risk associated with (1) the credit worthiness of the Trustee, (2) the credit worthiness of underlying issuers, and (3) fluctuations in market value inherent with changes in economic conditions.

**Investment Valuation and Income Recognition** – Purchases and sales of funds are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Earnings on investments are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances.

**Notes Receivable from Participants** – The notes receivable are measured at carrying value, which is the remaining unpaid balance plus accrued but unpaid interest, and are considered delinquent and written off as a deemed distribution when 90 days past due. No allowance for loss on receivables from participants is provided based on loans being secured by the participants' balances.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** – Certain expenses incurred in connection with the administration of the Plan, including accounting fees, are paid by the Company and, as such, are not an expense of the Plan. See Note 6 for further discussion regarding Plan expenses.

**Note 3. Certified Investment Information**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Total investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the schedule H, Part IV, line 4i-schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

**Note 4. Fair Value Measurements**

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated by approximately \$5,451,000. Gains and losses (realized and unrealized) included in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments, and changes in fair value as reported in the accompanying statement of changes in net assets available for benefits primarily relate to mutual fund activity.

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Collective Trusts* - The Plan invests in several collective trusts. The trusts are measured at net asset value ("NAV") as a practical expedient and are not classified in the fair value hierarchy. These collective trusts simulate the performance of guaranteed investment contracts through an issuer's guarantee of a specific interest rate and a portfolio of financial instruments that are owned by the issuer. This provides a stable value fund option for Plan participants. The contracts provide that participants execute Plan transactions at net asset value. Net asset value represents contributions made to the fund, plus earnings, less participant withdrawals. The fair value of the Plan's interest in the collective trusts is based on the net asset value of units held. There are no unfunded commitments related to these investments. Participants withdrawing from their accounts for allowable events will receive the principal and accrued earnings. These events include transfers to other plan investment options and payments because of retirement, termination of employment, disability, death, and in-service withdrawals as permitted by the Plan. Certain events, such as plan termination or a plan merger initiated by the Plan Sponsor, may limit the ability of the Plan to transact at net asset value. The Plan Sponsor does not believe any events are probable that may limit the ability of the Plan to transact at net asset value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Guaranteed Investment Option with Insurance Company**

The Plan has a guaranteed investment option (“PGO”), a general account backed group annuity contract issued by Principal Life Insurance Company (“Principal Life”) to Principal Trust Company as custodian. The Plan Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The PGO guarantees principal and a rate of interest for a period of time. These guarantees are backed by the full faith and creditworthiness of Principal Life. While guarantees are supported by the general account of Principal Life, participants do not participate in the investment experience or performance of the general account. The rate credited to accounts is a composite weighted average of underlying guarantees provided in the contract. Each underlying guarantee is in effect for its full maturity, which may vary. The targeted average maturity of the underlying guarantees of the PGO is 4.0-6.0 years.

A composite crediting rate contractually guaranteed by Principal Life is credited to account balances. Currently, the composite net crediting rate is a 6.05% effective annual rate, until November 30, 2024. The rate will be reset December 1, 2024, and semiannually thereafter. The guaranteed minimum interest rate is 2.70%. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The PGO was a new option for participants in 2023. The contract value of the PGO at December 31, 2024 and 2023 was \$1,689,298 and \$4,862,524, respectively.

Benefit payments to participants for plan benefit events, including retirement, termination of employment, disability, plan termination, death, loans, and withdrawals, as allowed by the plan, are made without any surrender charge or early termination charge.

The contract defines the circumstances and amounts for which the plan may terminate its interest in the contract. The issuer, Principal Life Insurance Company, has the right to no longer receive deposits under the contract. However, the circumstances for termination of the contract are still subject to provisions of the contract.

**Note 6. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are in funds and accounts that are managed by the Trustee or their subsidiaries and affiliates. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$55,409 for the year ended December 31, 2024.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investments in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts based on participant earnings and distributed in such a manner as defined by the Plan.

**Note 9. Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Company by letter dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Subsequent Events**

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through July 15, 2025, the date these financial statements were available to be issued, and, there were no subsequent events that required disclosure in these financial statements.
